



# Colorado Parks and Wildlife Centennial Annual Pass APPLICATION - \$14.00

The Centennial Pass is offered at a discounted cost to qualified Colorado residents who meet certain income guidelines. To qualify, a resident must be 18 years of age, must show a Colorado photo identification card, and provide income verification as listed below. The federal *total income* must be at or below the threshold amount based on number of dependents shown in the chart below:

To qualify, please provide a photocopy of one of the following documents filed for the previous tax year:

If you do not have a tax form from last year, or your income is at a level such that you were not required to file a federal income tax return within the last calendar year, you must sign an affidavit and show proof to that effect under penalty of perjury.

The Centennial Pass is valid from January 1 through December 31 each year. With this pass, the Centennial pass holder and vehicle occupants will be allowed entrance to Colorado's State Parks in any vehicle they choose. **The pass holder must be present in the vehicle for the pass to be valid.** NOTE: When visiting Cherry Creek State Park, an additional \$1.00 daily fee or \$3.00 yearly fee is required.

- A copy of the first page of current tax return to verify income meets threshold, **OR** if your income is such that you are not required by law to file a tax return, complete and sign the Centennial Pass Affidavit, shown below, attesting to this fact.
- A copy of your current Colorado's Driver's License or Identification Card\*
- A check or money order in the amount of \$14.00 payable to: Colorado Parks and Wildlife.\*\*

\*Providing your identification helps us limit fraud and allows us to qualify you as a senior (64 and older) who is eligible to receive camping discounts.

\*\*If you prefer, payment can be made using a credit card by calling our Sherman Street office after you mail in your application. Also note that there is an additional \$3 yearly water basin authority fee for users of Cherry Creek State Park. If you wish to purchase this pass, please make your payment for \$17.
