

2018 Louisiana Purchase Ranch Public Access Hunt Application - Instructions

If you have a 2018 elk (bull or cow) or deer (buck or doe) license valid for Game Management Unit 11/211 and would like to participate in an unguided hunt on Louisiana Purchase Ranch, please follow these directions:

- 1) Fill out the first page – General Information
- 2) Fill out the corresponding section for the species your license is valid for
- 3) Mail the completed application to:

Applications are due at the office by Friday, August 10, 2018. Please call the Colorado Parks and Wildlife office in Meeker with any questions, at (970) 878-6090.

Only hunters who have qualified and whom have been selected will receive notification, including specific dates and details. Unsuccessful applicants will not be notified by CPW, so if you do not receive notification, you were not selected to participate in any of these special hunting opportunities. All selected hunters will be required to follow travel restrictions and access rules designated by CPW and Louisiana Purchase Ranch.

Note: Selected hunters' hunting licenses associated with these hunts are still valid Game Management Unit wide (GMU 11/211) as well as valid within other specified GMUs (Valid GMUs are printed on the license). Selected hunters are still able to hunt any valid GMUs printed on their license throughout the selected season.
