#### **Project Description:**

The Pike National Forest South Park District USFS Officer is requesting funding to purchase one dirt bike for patrol and maintenance on the trails and roads throughout the forest open to OHVs. The Pike National Forest is responsible for managing 1,106,604 acres of public land that is in close proximity to two major metropolitan cities, Colorado Springs and Denver. This makes Pike National Forest one of the most highly used and populated National Forests in the state of Colorado.

The South Park Ranger District program alone is responsible for over 700 miles of motorized trails and roads open to OHV's. The heavy use areas on the South Park Ranger District are Badger Flats, Cedar Mountain, Packer Gulch, Rock Springs and Sheep Mountain riding areas. Other heavy OHV use areas on the Pike National Forest the LEO is responsible for include Indian Creek, Rainbow Falls, and Rampart Range to name a few. These areas are extremely popular due to their urban interface with two populated cities, trail accessibility, riding opportunities for different skill levels and the many other recreational opportunities that these areas have to offer. The LEO also patrols other district's trails and roads on the PSICC on a weekly opportunity as well as patrol trails and roads on National Forests throughout the State of Colorado.

The South Park LEO is requesting funding to purchase a new dirt bike that I will make street legal giving me the opportunity to take it to any forest road or trail. The old motorcycle the South Park LEO inherited and refurbished is finally unserviceable and frankly not appropriate for the trail riding he would like to accomplish. The South Park LEO is looking to purchase a bike that light and reliable so he can ride technical trails and roads around the forest. He also has personal experience with different dirt bikes which gives me the experience and passion to put the machine to the best use for OHV access and enforcement.

The South Park LEO will recognize the importance of our partners including CPW's OHV program by placing "Colorado OHV Registration Dollars at Work" stickers/signs on the newly purchased dirt bike as well as OHV checkpoint signs setup throughout the forest on saturated patrols. As always public contacts include discussion about the importance for OHV's to be registered and how the OHV registration funds are being used to support the Districts OHV program. Often, the South Park LEO will tell individuals out of OHV compliance to purchase registration at the time of contact or receive citations. He also works closely with USFS recreation programs to keep trails open.

The South Park LEO understands the budgetary challenges that exist to maintain a quality OHV program. He appreciates that funding approved from CPW to keep recreational programs throughout the USFS functioning. The South Park LEO truly appreciates this funding opportunity and looks forward to working together to provide a positive and safe environment for the public to enjoy.

#### PROJECT SELECTION CRITERIA

#### 1. Need for & Benefit of the Project (25 points):

The Pike National Forest is one of the most widely known and visited forests in the state of Colorado due to not only the two neighboring large cities in close proximity (Denver and Colorado Springs) but also because it is home to America's Mountain; Pikes Peak. That and many other attractions brings millions of visitors to the front range area each year and a multitude of these visitors are motorized enthusiasts who want to get out somewhere close to ride trails and experience what this great state has to offer. We also have a great community of OHV enthusiasts living in the area who utilize the trails regularly. This has its benefits for the local economy, but it also has a major impact on our natural resources and forests in the surrounding areas. We have seen a major spike in recreational and OHV use in the last three years and it's not slowing down any time soon. Stated earlier this forest has a variety of riding opportunities for all skill levels for UTV's, ATV's, Dirt Bikes and 4x4's, on South Park RD alone we have over 700 miles of OHV trails.

The Pike National Forest South Park LEO typically patrols USFS trails and roads alone to enforce OHV compliance. An reliable and appropriate dirt bike is a necessary tool for the USFS LEO to patrol every trail and road open to the public. The public seeing their dollars a work on the motorcycle and the education and enforcement the LEO will give help the public understand the importance of OHV registrations the work it takes to open and maintain trails and roads throughout the forest.

#### 2. Partnerships, Support and Leverage (25 points):

The South Park LEO works closely with cooperator organizations such as: Focus on the Forest, Mile High Jeep Club, Colorado Parks and Wildlife Officers, and Colorado Parks Trail Coordinators to name a few. The South Park LEO also assists the recreation crews around the Pike National Forest for focused patrols and opening and clearing trails for the public.

The South Park LEO hopes to continue to keep his bonds with outside organizations and volunteer groups strong. The \$11,263 OHV grant will provide funding for one new replacement dirt bike to help the LEO lead and support bigger projects and trail maintenance. With the LEO riding along with the volunteers more production and comradery will be accomplished. This funding will also allow the LEO to continue his previous efforts in coordinating with outside organizations and other CPW officers for OHV compliance checkpoints and patrols.

Many of the LEO's partners have provided letters of support for the grant and are included in the application package. These partners work closely with the South Park LEO and SPK recreation crew and the work would not be possible without a collaborative effort.

# 3. Resource Protection, Enhancement and Restoration relative to eligible OHV grant activities

(25 points):

The purchasing of a new dirt bike will promote more protection of sensitive environmental resources by providing the South Park LEO with safe and reliable access into some of the more technical and secluded areas on the district. The LEO will be able to cover more ground in less time, finding, observing and monitoring OHV use in sensitive areas. With the information gathered from frequent motorcycle patrols he will be able to stop illegal use before it begins to negatively affect wildlife habitats and the surrounding natural resources.

While out riding the LEO will also be able to determine trail maintenance areas; where to improve drainage structures, repair damage from excessive runoff, minor re-routes of sections of trail due to unsustainability, hardened crossings and possible bridge construction sites. Being able to patrol on motorcycle more often will exponentially enhance the LEO's ability to protect, restore and improve the environment by addressing existing problems and minimizing impacts made by OHV users.

#### Large Equipment Purchases, Maintenance and Disposition:

The South Park LEO will oversee the basic maintenance and upkeep of the dirt bike. The LEO has personal knowledge on how to maintain a motorcycle for reliable use. The PSICC Law Enforcement and Investigation division will handle charges for maintenance parts, oil, fuel, and labor throughout the years of its use. The LEO will keep the motorcycle locked up, protected, and secured in enclosed government trailer used for transporting equipment. The dirt bike will be winterized at the end of ever season so it will be available to ride the following season.

The dirt bike will be transported for use in the back of his patrol truck and secured safely. The bike being in the back of the truck makes it readily available to use whenever the need arises. If there ever is a time, he will no longer need the services of this bike he would award them over to the CPW OHV State Trails Crew or whoever they deemed it necessary to go to. Below are specifications of the dirt bike the LEO is attempting to acquire through these grant funds.

- a. Requested equipment specifications:
  - a. Engine size 250cc or 300cc
  - b. Two stroke engine
  - c. Electric start with kick start as backup
  - d. Liquid cooled
  - e. Electronic fuel injection
  - f. Wide-ratio 6 speed transmission
  - a. Vehicle must meet ANSI/OPEI B71.9-2016 standards
  - h. 12 inches of minimum ground clearance

#### 4. Travel Management Plan Implementation, Education and Enforcement (25 points):

#### Travel Management.

With the purchasing of this new machine for the LEO the opportunity for engineering, education, and enforcement of the travel management plan will increase exponentially. These travel management measures will include maintaining trails and roads, increasing visitor contacts, and covering more ground in a single day to increase contacts and seeing trails. Trails that aren't maintained properly lead to illegal routes and damage to natural resources.

#### Education, Enforcement and Compliance Activities:

Engineering, Education, and Enforcement are the forefront for a USFS LEO's job. Throughout the riding season the South Park LEO must cover some of the busiest OHV areas in the state by himself. The LEO's effort in OHV law enforcement in the last two years has led to

many diverse contacts with OHV owners. His consistent presence in these OHV areas has led to higher compliance and purchase of OHV registrations. The LEO on a current dirt bike model will connect him with OHV enthusiasts which in turn will lead to more compliance and respect of the rules and regulations.

The dirt bike will give the LEO the ability to access ever single trail and road on the National Forests quickly and efficiently. The LEO can also ride 50inch/single track trails and provide feedback on where new single trail could be added or improved. Attached below are stats from the Pike and San Isabel National Forests that have involved OHV's in the last year. The LEO also has the ability to patrol every single road and trail throughout the State of Colorado that are on National Forests. He has attended specific OHV events such as the Taylor Park RZR Rally to provide saturated enforcement on OHV. He has also accomplished a successful OHV compliance checkpoint in Badger Flats on Labor Day weekend in 2023. One day of the checkpoint led to over 90 separate OHV contacts for registration compliance. This includes violations of Federal Law and assimilating violations of Colorado Title 33 law.


