## **Project Description:**

#### WHO?

The Stay The Trail Education and Stewardship Alliance (the Alliance) is a 501(c)(3) non-profit entity. The Alliance works with individual off-highway vehicle (OHV) enthusiasts, clubs, groups, land management agencies, local governments, and the non-motorized recreation community to promote responsible OHV recreation. The Alliance utilizes educational programs, stewardship projects, volunteer work, direct user contacts, our website, social media, trail maps, advertising, video, and associated trail sustainability and resource protection efforts.

#### WHERE?

The Stay The Trail Education and Stewardship Campaign is a statewide outreach program that works with Colorado Parks and Wildlife, the Bureau of Land Management, and the US Forest Service at the state and field office levels. OHV enthusiasts, clubs, groups, hunters, rental companies, visitor bureaus, chambers of commerce, cities, towns, counties, and motorsports dealers frequently request information from our organization. Additionally, many visitors request information from us when visiting Colorado. The Campaign may also work in bordering and regional states when large Colorado visitor groups visit Colorado. This awareness allows the Campaign to strategically target and educate out-of-state trail users before they arrive. The Campaign also networks with other motorized education and ethics groups from the Rocky Mountain region to generate ideas and learn from successful outcomes.

#### WHAT?

This grant would allow the continuation and enhancement of the Stay The Trail Campaign. The primary elements and deliverables include:

- Expenses for delivering the Stay The Trail educational message through direct outreach tools, including traveling Statewide with the (2) Stay The Trail educational trailers to 35-45 events annually, including stewardship/volunteer projects. These expenses include travel, project materials & supplies, advertising, equipment, and other miscellaneous expenses. The events include trailhead outreach, trade shows/expos, club and agency meetings, workshops, stewardship projects, and other recreation outreach.
- A full-time project coordinator and a full-time stewardship and outreach specialist with associated personnel costs, including salary/wages, benefits, taxes, cellphones, required computers/printers/software, lodging & per-diem, office supplies, volunteer expenses, and miscellaneous operating expenses, maintenance and enhancement of the Stay The Trail web site and social media sites, including up-to-date maps, rules/laws, OHV guidelines, etc. coordinated with Colorado Parks and Wildlife and the federal agencies, smartphone apps, events calendar, news feed, brochures, videos, agency contacts, OHV related links, Tips, FAQs, requests for educational materials, presentations, and events.

#### Additional Program Costs Include:

- Printing Maps, brochures, youth activity books, decals, stickers, posters, videos, promotional materials, costs for development, graphic design, printing, mailing, and other delivery methods.
- Vehicle/ OHV insurance, equipment, maintenance, parts, supplies, and storage.
- Costs for grant administration.

#### WHEN?

Stay The Trail is an ongoing and continuous education program that began in 2003. The proposed grant would allow the program to continue through the 2024-2025 operating season.

## **Program Funding Acknowledgement**

Awarded funding is acknowledged and advertised to the public in various ways. Printed acknowledgment is branded on all STT educational materials representing 'Major Program Funding Provided By *Colorado Registration Dollars at Work.*' This is also displayed on STT vehicles and trailers and is continually posted during updates to STT social media sites, signage projects, kiosks, apparel, and the STT website. It is also mentioned during news conferences, interviews, and press releases. STT also highlights the Registration Dollars at Work during all conversations with the OHV community.

#### **PROJECT SELECTION CRITERIA**

## 1. Need for & Benefit of the Project (25 points):

Statewide, the Campaign will:

 Continue the on-ground education campaign at trailhead events and direct on-trail user interactions, which promote responsible ethics among OHV enthusiasts. This effort will continue to minimize the potential for adverse impacts and resource damage from irresponsible 4x4/OHV use.

2. Continue the STT statewide mapping campaign. This Campaign focuses on complex trail networks in high-use areas. We develop unique maps in collaboration with the BLM, FS, and partners to highlight motorized routes and address on-ground issues by emphasizing them on the maps. These maps are placed on kiosks at trail system entrance points and staging areas. In some cases, the maps are printed for distribution and are all available digitally on the STT website.

3. Continue to organize and complete stewardship projects with local clubs, groups, and land managers. Enable user involvement in the construction, designation, and maintenance of sustainable trail systems. This is accomplished through targeted volunteer and stewardship projects cooperating with

local agencies and clubs.

4. Continue working with towns and counties to help them implement solutions to identified OHV issues. STT will continue contact with several towns and counties in Colorado that allow OHV use on streets and roads. These areas are struggling with increased usage, parking and staging, speed, dust, and noise. To build on our recent success, STT will work with these municipalities to discuss issues and identify solutions.

5. Reinforce and highlight responsible OHV use and discourage inappropriate or illegal use.

6. Improve public perception and increase stewardship in Colorado Towns and Counties overwhelmed by the increase in OHV recreation.

The Campaign will continue to fund items such as two full-time employees, educational materials and equipment, targeted stewardship, trailhead outreach, maps, website information, brochures, printed publications, and advertising and promotional items.

The stewardship message and programming will encourage OHV enthusiasts to adopt a sense of "ownership" over designated roads and trails. This practice provides a valuable supplemental resource to the land management agencies' limited budgets and staff. The program will supplement the educational resources agencies need to discourage irresponsible use by encouraging strong ethics centered on responsible use to allow continued access to designated roads and trails. The website will provide up-to-date information on where to ride legally and highlight the ethics of responsible use of trails and roads, along with news items and a calendar of events. The website will host new and updated official agency travel maps as they are created or updated for specific OHV areas. Social media sites will continue to promote the Stay The Trail message and responsible OHV recreation. We plan to develop educational videos featuring our messages with direct examples of correct trail use and ethics, with the first video directed towards OHV rental companies designed for them to show to the riders before hitting the trails.

The two main components of this Campaign have proven to be the most effective in addressing these needs: direct contacts with enthusiasts and volunteer stewardship projects. Since its inception, the direct connections have been a staple of the Stay The Trail program, utilizing the educational trailers, tents, and booth tables staffed by employees and volunteers to convey the ethics of responsible use to enthusiasts. The stewardship projects enable enthusiasts to maintain a sense of "ownership" of their public lands. In addition, tens of thousands of recreationists are also exposed to the program at major outdoor recreation events throughout the year. Furthermore, printed advertisements and mixed-media messaging, such as static and mobile billboards along critical access routes, bilingual signage, and work with a Spanish liaison to promote the Stay The Trail message

## 2. Partnerships, Support, and Leverage (25 points):

The Stay The Trail Campaign strives to enlist and engage as many interested outdoor enthusiasts as possible, believing that collectively, we can address the issues and concerns through dialogue and a spirit of compromise and collaboration.

- 1. Educate OHV users about travel management regulations, plans, and where to recreate legally.
- 2. Encourage and enable outdoor stewardship, from individual actions to mixed-use volunteer projects.
- 3. Assist in successfully implementing and educating travel management plans to help reduce potential resource damage.
- 4. Fulfill the education goals of agency land use plans.
- 5. Help public land managing agencies meet resource protection and mitigation standards and goals.
- 6. Improve the long-term sustainability of Colorado's public roads and trail systems open to OHVs.
- 7. Contact the non-motorized recreation community to establish dialogue and work toward mutually beneficial solutions.

The Stay The Trail Steering Committee was formed at the program's onset to provide an ongoing, unique, positive dialogue between land managers and the OHV community. The steering committee understands the common ground and differing viewpoints regarding OHV issues and collaborates to encourage open discussion regarding land use and competing-use matters whenever possible. Each steering committee member is committed to conservation, environmental sustainability, and protecting our State's natural resources for future generations of outdoor recreationists. The Committee meets bi-monthly year-round and continues to provide valuable guidance and direction for the Stay The Trail Campaign.

#### 1. OHV Clubs, Groups, and Associations

Stay The Trail often facilitates partnerships between local OHV clubs or organizations and the appropriate land management authorities. These partnerships increase maintenance, trail adoption, and other trail improvement actions that will add to the long-term sustainability of OHV trails throughout the State. The Stay The Trail campaign also partners with various OHV clubs to attend club/group-sponsored events around the State, including new trail openings and dedications. Staff members can present at meetings and participate in organized rides, clean-ups or trail projects, land use meetings, or educational events.

#### 2. Volunteers

The Campaign relies heavily on volunteers, beginning with a volunteer Board of Directors and Steering Committee. The Board of Directors attends regularly scheduled evening meetings on their own time and volunteers to help with individual projects. Many individual volunteers are utilized during outreach events and stewardship projects statewide.

## 3. Agency Partnership and Assistance

Many U.S. Forest Service Ranger Districts, Colorado Parks and Wildlife, and BLM Field Offices throughout Colorado rely on the Stay The Trail campaign to help them with on-the-ground trailhead and event education. Outreach events and stewardship projects around the State are scheduled at the request of and in cooperation with local land management offices.

#### 4. Non-Motorized Interest Groups

Many of the Stay The Trail Campaign's tools and resources directly apply to non-motorized forms of outdoor recreation on public lands. Non-motorized recreation organizations and environmental groups from within the State and nationally are actively solicited for their input and knowledge. Stewardship projects are often completed in cooperation with non-motorized interest groups. The Stay the Trail campaign highly encourages the concept of respected multiple-use recreation.

#### 5. Additional Funding and Support

Additional program funding comes from individual, group, and club donations. In many cases, these donations are often directly tied to event interactions. Other grant awards and Stewardship Sponsorships have been secured from OHV and 4x4 industry members. The U.S. Forest Service and Bureau of Land Management also contribute semi-regularly. The board of directors continually looks for additional funding sources outside the State OHV grant process, including building partnerships with outdoor product businesses and OHV/4x4 industries.

# 3. Resource Protection, Enhancement, and Restoration relative to eligible OHV grant activities

(25 points):

The core efforts of the Stay The Trail program include on-ground education and event attendance, promotion of stewardship on our public lands, and the mitigation of the negative impacts. This effort aids in protecting natural resources by fostering an educated and responsible community of OHV enthusiasts. Resources are protected when users consistently follow the guidelines and recommendations in the program's educational messaging. The following are some of the critical messages consistently reinforced and delivered through various means:

- Stay (on) The Trail
- Keep your wheels where they belong
- Don't Leave a Mark in Taylor Park
- Love the Loop Keep of Alpine Tundra
- In Colorado, We Stay The Trail
- Get Dirty, Rock N Roll, Get Over It, Whoop It Up, No Short Cuts, Stay In Line, Stay On Course, Be Sensitive
- Stick It or Ticket, Colorado Off-Highway-Vehicle Sticker Required by Law
- · Mind the signs
- Mind the width/Know your width
- Know before you go
- When in town, Throttle Down
- Don't Pummel the Tundra
- Tires are for the Trail, Keep of Alpine Tundra
- Pack it out
- · Share the trail
- Hunting with your OHV Know the rules
- The start of the hunt is the end of the ride
- No short cuts
- Know where to ride your OHV legally
- Register your ride
- Take it slow
- Play Nice
- Mind your sound -keep it down
- Teach your kids to ride responsibly

The Campaign's stewardship projects, land use days, clean-up runs, and partner projects produce results on the ground, which enhance and often restore specific OHV areas. The volunteer stewardship programs facilitated by the Stay the Trail program include those that work to protect resources through fencing, signage, new mapping kiosks and trail maintenance. Enhancement is achieved through working with clubs, groups, and local agencies to provide sustainable trail systems which provide an opportunity and challenge for riders and drivers of all backgrounds. Restoration efforts to fix and mitigate resource damage from irresponsible use will help to define sustainable routes through regeneration of native vegetation and by protecting the natural beauty that draws outdoor recreation enthusiasts from around the world to our State's trail systems.

4. Travel Management Plan Implementation, Education and Enforcement (25 points):

The Stay The Trail Campaign employs many tools to reduce interpersonal user conflicts and improve adherence to OHV Travel Management regulations and designations. Following are some of the tools:

**Educational Trailers**— The Campaign utilizes two educational trailers to staff events and trailheads around the State. Both are wrapped with eye-catching graphics and outfitted inside with various educational materials and maps. Staff and volunteers have direct contact with OHV enthusiasts and other recreationists in the field. Various OHVs participate in club events, allowing the staff to get out and make on-trail contacts.

**Tents and Banners** – The Campaign also has "easy-up" tents and banners that can be utilized with or separate from the trailers, increasing exposure and total outreach opportunities at any given time.

**Web Site\_-** staythetrail.org has become a preferred one-stop-shopping source for OHV information by enthusiasts all over the country. STT is continually updating the website to meet the newest ever-changing needs of the OHV community.

**Social Media**—We use social media such as Facebook and Instagram to interact with the public and highlight, communicate, and echo the stewardship messages and opportunities of Stay The Trail. STT has increased our reach by sharing our partners' accomplishments and agency updates.

**Sound Testing** -Sound testing continues to be conducted at field events throughout the State as a free service for users and enthusiasts. There has been a decrease in the need for sound testing of machines, but Stay The Trail still offers this service when requested. Recently, a new sound issue has come up: vehicle sound systems. Usually, on SxSs, these sound systems are used in marine applications and are very loud, causing complaints. We are working on a solution to mitigate this issue.

Brochures/Printed Materials\_-Several unique brochures have been developed to promote responsible recreation in a user-friendly format. Titles include off-highway guidelines for Motorized Vehicles, 4-Wheel Drive Vehicles, All-Terrain Vehicles and Side-By-Sides, Motorcycles, OHV Opportunities on public roads in CO, Trails Open to Full-Size Vehicles in CO, and Courteous Use of Motorized Trails. A new brochure, Rocky Mountain Terrain, focuses on sensitive ecosystems in CO, such as Alpine Tundra and Wetlands. Various inserts also communicate changes in state and federal laws. The map, brochures, and youth activity book are now available in Spanish to help communicate with the Spanish-speaking community.

Youth Outreach – The youth activity and coloring book was developed in 2013 and is an excellent educational tool for reaching youth. The book has received updates regularly and was designed for parents and children to read. Additionally, a full-size mascot costume was added in 2014. Named ROHVER, the mascot mirrors the cartoon figure in the kid's activity and coloring book. New in 2017 and redesigned and rebuilt by the Boy Scouts in early 2023 is the "RC Challenge Course." The course was designed and built as an interactive attraction to engage kids and teach them the importance of "Staying On The Trail." Kids get the opportunity to drive a 1/25 scale Remote Control (RC) 4x4 vehicle to negotiate obstacles on a simulated OHV trail. The trail features a log crossing, bridge, whoops, rocks, water/stream crossing, switchbacks, animals, and a sensitive area. These were modeled after STT Guidelines illustrated in our "Motorized Vehicles" brochure. Teaching youth the fundamentals of good land and OHV ethics will positively impact the next generation of recreation enthusiasts.

**Posters** – Posters help visually convey the messages of stewardship and ethics. These are provided to the land management agencies for placement near popular OHV areas and in OHV businesses.

Maps — The Colorado OHV Opportunities Map was initially developed and printed in 2009; the most recent revisions were completed in late 2020. Agency field offices, State welcome centers, OHV dealers, cities, towns, and others are provided copies of the map for public distribution. The information on the printed maps is mirrored and "live" on the website. The up-to-date Motor Vehicle Use Maps (MVUMs) published by the Forest Service and new BLM Travel Management maps are hosted on the website. Information on the Colorado Trail Explorer (COTREX) mapping app has also been added to our mapping information on the Stay The Trail website and social media sites to inform people of Colorado's interactive free mapping option.

Smartphone Applications – The Stay The Trail program has made USFS and BLM official travel maps available on the free mobile mapping application Avenza. We also promote CPW's COTREX app in multiple ways. Stay The Trail provides links and directions for users to download and use these apps easily.

**Static and Mobile Billboards** - During the past six seasons, numerous static billboards promoted the Stay The Trail message along popular Colorado highways. Two mobile billboards were implemented in 2010 with Colorado Parks and Wildlife. In 2019, STT purchased two additional mobile billboards, which are now in Taylor Park and around the State. This has effectively doubled our mobile advertising efforts.

This project is very consistent with the long-range plans of the land management agencies. Agency field personnel have come to rely heavily on the hands-on field presence of the Stay The Trail program to assist them in their directed educational efforts. They often schedule the educational trailers a year in advance. OHV Clubs have also utilized the program to educate their members at club meetings and events.


#### **Education**

Stay The Trail's primary focus is education and direct delivery of our core message. The STT program and our on-ground, direct-user education method have been established as a nationally recognized effort. The program undergoes an annual strategic review by the Board of Directors alongside all critical stakeholders, including agency representatives, to determine the efficiency and reach of the message. Changes or improvements deemed appropriate by the Board of Directors and Steering Committee are implemented yearly.

## **Enforcement and Compliance Activities:**

We believe education and stewardship are the keys to improving compliance with OHV regulations and designations. Education is one of the 4E'sof recreation management. Most users contacted in the field have expressed a willingness to do the right thing and operate their OHVs responsibly on public lands. They need accurate and complete information to help and guide them. The Stay The Trail Campaign puts information directly in the hands of the enthusiasts through various educational tools described previously in this application. Responsible riding/driving techniques and official travel maps provide essential tools for compliance. Continued visitor contacts and social media and marketing efforts continue to reinforce the message.

Focus on the Forest (FoF) is a nonprofit of 100% volunteers that is dedicated to cleaning up our National Forests using alternative solutions to motivate & enable communities to keep our public lands clean and safe. We have a 3 phase program to address problem areas that has been working for FoF for over 7 years. The ongoing support from Stay The Trail has been an integral part in our success.

Phase I is to do a mass cleanup of a problem area. Primarily, these areas are dispersed camping and OHV riding areas. We can have up to 200 volunteers from the community show up and Stay The Trail has been there to share information with everyone while pitching in during the cleanup.
