# **CPW Aquatic Biologist Introduction**

Alex Townsend introduced himself to the group as the new CPW Aquatic Biologist.

## **Envision Chaffee County**

Cindy Williams gave an update on the Chaffee Rec Plan. Based on collected data, it can be expected that visitation will continue to increase exponentially in coming years. The report card indicates heaviest impacts on dispersed camping sites, with 14% degradation per year. Because of the increased visitation, there are approximately 40% fewer dollars per visitor available to manage the lands that they enjoy.

# **AHRA Updates**

## Park Manager Updates

# Staffing Updates (Old Biz, 11/2020)

Corrine Servis was selected as AHRA's Operations Manager and is in the process of moving to Salida. A Park Resource Technician was selected and will start in March or April. Alex Townsend was selected as the Area 13 Aquatic Biologist, and was introduced at the beginning of the meeting.

#### Tree Removal

The strainers (trees) in Cañon City are being removed tomorrow.

#### **Cliff Jumping**

There is some movement within CPW that may prohibit cliff jumping within State Parks. AHRA requests feedback from CTF on this issue.

## Parking at Salida East, Rincon, and Salida Boat Ramp

AHRA is seeking volunteers to serve as Ramp Hosts to assist in parking and traffic flow issues during busy times. Where necessary, LE staff may also assist in this process.

## **Numbers Campground**

The AHRA is working on the potential of a campground at the Numbers. More information to follow as it becomes available.

#### Tennessee Pass Revival

The comment period for the revival of line traffic in Tennessee Pass has been extended.

#### Silver Bullet Easement

CPW is working with the Skarat family to enter into an easement agreement which would allow the AHRA to get heavy equipment into the Silver Bullet area when necessary.

## Salida Low Head Dam

A meeting will take place tomorrow regarding the potential for removal of the Salida Lowhead Dam. More information to follow as it becomes available.

# **Rationing and Permit Updates**

#### **Private Boater Capacity Education Efforts**

John presented the draft version of the <u>private boater page</u> updates which will contain wording and problem dates as part of the user education and redistribution effort for Browns Canyon. AHRA will look into the possibility of fulfilling CTF's request to post follow-up numbers after each posted date.

## Commercial Boating 75% of Capacity Report

John presented the Commercial Boating 75% of Capacity Report. This report may be found on the AHRA River Outfitters website.

# **Labor Day Section 5 Capacities**

The AHRA will monitor Section 5 traffic on Labor Day weekend to gather more information regarding the amount and type(s) of traffic on the water. This data will be used to potentially propose changes to commercial vs private allocations within this section on these dates.

## Grandfathered Use, "Boat is a Boat" (Old Biz, 01/2020)

The AHRA proposes to switch to "a boat is a boat" rationing methodology, allowing any commercially allocated boat to be used as a kayak, or vice versa. This change, along with the potential removal of grandfathered use, will reduce the amount of exceptions and conversions required to complete year-end reporting for both outfitters and AHRA staff.
