Full Hook-Up (water, sewer, electric)



Site 1 – Raptor Glen

Pull-through. Nice, flat. Driveway 100'. Maximum camping unit length is 40'. Room for one additional passenger vehicle. Has 4 steps from parking pad to table and fire ring. Scrub oak around sight, but no real shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 2 – Raptor Glen

Pull-through. Nice, flat. Driveway 100'. Maximum camping unit length is 48'. Room for one additional passenger vehicle. Has 5 steps from parking pad to table and fire ring. Scrub oak around sight, but no real shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 3 – Raptor Glen

Pull-through. Slight grade. Driveway 110'. Maximum camping unit length is 45'. Room for one additional passenger vehicle. Has 5 steps from parking pad to table and fire ring. Scrub oak around sight, but no real shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 4 – Raptor Glen

Back-In. Slight grade. Driveway 50'. Maximum camping unit length is 45'. Room for one additional passenger vehicle only if camping unit plus additional vehicle does not exceed 50'. Has 5 steps from parking pad to table and fire ring. No real shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.

Site 5 – Raptor Glen

Back-In. *This site has a moderate grade at site entry. Total site length is 46'. The back end of site is the camping unit parking pad. It is 27' and is flat. 19' is at a moderate grade at the front end of site. Maximum camping unit length is 30'. Will work if pull-trailer no more than 30'. Not for motor homes more than 30'. Room for one additional passenger vehicle only if camping unit plus additional vehicle does not exceed 45'. No real shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 6 – Raptor Glen

Back-In. Slight grade. Driveway 50'. Maximum camping unit length is 45'. Room for one additional passenger vehicle only if camping unit plus additional vehicle does not exceed 50'. No real shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 7 – Raptor Glen

Back-In. *There is a moderate to steep grade for about 10 feet on the approach into this site. Total site length is 33' and it is flat. Maximum camping unit length is 30'. Room for one additional passenger vehicle only if camping unit plus additional vehicle does not exceed 30'. Has 4 steps from parking pad to tent and fire ring. There is a moderate drop-off at site, may be a hazard for young children. No shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 8 – Raptor Glen

Back-In. *This site has a moderate grade at site entry. Total site length is 48'. The back end of site is the camping unit parking pad. It is 28' and is flat. 20' is at a moderate grade at the front end of site. Maximum camping unit length is 30'. Will work if pull-trailer no more than 30'. Not for motor homes more than 30'. Room for one additional passenger vehicle only if camping unit plus additional vehicle does not exceed 48'. Has 4 steps from parking pad to tent and fire ring. There is a moderate drop-off at site, may be a hazard for young children. No shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.

Site 9 – Raptor Glen

Pull-through. Nice, flat. Driveway 120'. Maximum camping unit length is 50'. Room for one additional passenger vehicle. Has 4 steps from parking pad to table and fire ring. There is a moderate drop-off at site, may be a hazard for young children. No shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.



Site 10 – Raptor Glen

Pull-through. Nice, flat. Driveway 120'. Maximum camping unit length is 45'. Room for one additional passenger vehicle. There is a moderate drop-off at site, may be a hazard for young children. No shade. 12'x12' tent pad. No tents off developed site. Awnings and pop-outs OK.
