ISSUE:	Should spring turkey hunting on Centennial Valley State Wildlife Area be by reservation only?
DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):	
<p>Centennial Valley State Wildlife Area is a 1200 acre fee title property situated on the South Platte River in Weld county, east of Kersey, CO. As the population along the front range of Colorado has grown, so too has the number of hunters on Centennial Valley. The number of hunters has increased to the point where hunter safety has become a huge concern. During certain times of the hunting season, over 50 vehicles are parked at Centennial Valley. During the spring turkey season, the property will often have 120-150 people hunting during the early part of the season. The two small parking lots cannot handle the number of vehicles and hunters park along the county roads creating traffic problems on adjacent county roads. Hunters seldom hunt alone- typically each vehicle has 2-4 hunters. Commonly, CPW personnel get reports of hunters having shot hit them inadvertently by other hunters on the property.</p> <p>Currently there are no restrictions on hunting access to Centennial Valley SWA with the exception of small game and waterfowl hunters during the regular duck season. Big game and turkey hunters have full access to Centennial Valley until the regular duck season. Once the regular duck season begins, all hunters are restricted to hunting on Saturdays, Sundays, Wednesdays and legal holidays. Small game and waterfowl hunters are only allowed to hunt in seven uniquely identified areas that may be reserved through CPW's Hunter Reservation System (HRS). These hunters are allowed to make up to three reservations annually. Big game and turkey hunters are allowed to hunt the entire property.</p> <p>Area 4 staff believe that spring turkey hunting would be best suited on a reservation system to address current conflicts with overcrowding and safety issues, and to improve the overall hunter success on the property. CPW staff propose the following changes to regulations on Centennial Valley SWA:</p> <ul style="list-style-type: none"> - Centennial Valley SWA is closed to all public access from the day after the spring turkey season to August 31. During the regular duck seasons, the property is only open to hunters holding a valid hunting license, or members of a designated hunter party, on Saturdays, Sundays, Wednesdays and legal holidays on a reservation only basis (In accordance with PWC Regulation 901 (A)). - During the spring turkey season, ten (10) total turkey reservation slots will be available each day the property is open. Each reservation slot is valid for the entire property and up to 4 hunters are allowed per reservation, with no cap on the number of reservations per hunter. The number of reservation slots can be adjusted in HRS without a need to address regulations. - All other small game and waterfowl reservation regulations would remain the same. <p>The Hunting Reservation System (HRS) is easily adaptable to the proposed changes.</p>

<p>1. *Preferred Alternative*: (<u>Changes are underlined</u>) 901(B)(36)</p> <p>a. Public access is prohibited from <u>after the spring turkey season through August 31.</u></p>	

- b. During the regular duck seasons, public access is limited to Saturdays, Sundays, Wednesdays, and legal holidays. Reservations are required to hunt waterfowl and small game, and are limited to three (3) per hunter annually. Waterfowl and small game hunters may only hunt the areas specified on their reservation. Reservations must be made in accordance with #901.A of these regulations.
- c. During the spring turkey season, public access is prohibited except for licensed turkey hunters or members of a hunting party that have a turkey hunting reservation. A total of ten (10) reservation slots per day will be available for spring turkey hunters during the spring turkey season. Turkey hunters may hunt the entire property with a reservation, with no limit on annual reservations. Reservations must be made according to #901(A) of these regulations. A maximum of four (4) hunters are allowed per hunting reservation slot.
- d. Public access is prohibited from 1 hour after sunset to 4:00 am.
- e. Camping is prohibited.
- f. Dogs are prohibited, except as an aid to hunting.
- g. Horses are prohibited.
- h. Fires are prohibited.
- i. Target practice is prohibited.
- j. Hunting with centerfire rifles is prohibited.
- k. The launching or takeout of vessels is prohibited.
- l. All reservation hunters must check out at one of the check stations located in each parking lot of the property.
- m. Small Game and Waterfowl hunting is prohibited on the opening weekend of the regular plains rifle deer season and the opening day and first weekend of the late plains rifle deer season.

ISSUE:	Should property use regulations be changed on the Webster SWA during the regular small game and waterfowl seasons now that property management activities have changed?
DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):	
<p>The Webster SWA is a 158-acre leased property north of LaSalle and south of the South Platte River in Weld County. The property currently does not have a reservation system and is heavily used by waterfowl and small game hunters. In addition, the property is also used by hikers and wildlife viewers. Ducks Unlimited and CPW have put forth considerable efforts to establish shallow-water augmentation structures on the property to increase brood rearing for waterfowl and migratory shorebirds. The property was temporarily closed while these augmentation structures were being built.</p> <p>Starting in April of 2017 the Webster SWA began receiving water to fill the new augmentation structures. This has led to a significant increase in the hunting quality and activity on the property. Many of the state wildlife areas in Weld County along the South Platte River are available through the Hunter Reservation System and on limited days. However, the Webster SWA is a no-reservation property, open year-round. However, as a result of the new augmentation structures, local staff anticipates a significant increase in hunting opportunity and demand on the property. There is only one parking lot on the property which currently accommodates 8 vehicles. The access road to the parking lot is narrow and bisects two private parcels. On heavy use days, overflow parking along the roadway will increase conflicts with adjacent landowners. Access to the augmentation structures and the north end of the property is by pedestrian traffic only.</p> <p>Continuing to allow the property to be open to all users, at all hours, may adversely affect CPW's relationship with neighboring landowners, increase conflicts between consumptive and non-consumptive users, decrease hunting quality and limit the effectiveness of the property as a resting area, brooding area and potentially the nesting success of migratory waterfowl. Placing the property under a single use restriction of hunting only, and restricting the days and hours of access will decrease congestion, improve hunting and wildlife use of the property, and allow for greater enforcement authority. Prohibiting access from the end of the spring turkey season through August 31st will also greatly decrease disturbance for brood rearing waterfowl and migratory shorebirds.</p> <p>Furthermore, restricting the property to a first-come, first-serve basis with limited parking will reduce the number of hunter conflicts, improve safety between hunters and limit on-going conflict with neighboring landowners.</p> <p>Additionally, the property is primarily open and used for waterfowl, small game and turkey hunting. Because of the layout of the shallow water impoundments or ponds, and proximity of adjacent landowners, Area 4 staff do not believe the use of center-fire rifles and muzzleloaders are conducive to a safe experience on the property. Staff recommends that center-fire rifles and muzzleloaders are prohibited.</p>

ISSUE:	Should property use regulations be changed on the Brower SWA during the regular small game, waterfowl and turkey seasons?
DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):	
<p>The Brower SWA is a 65-acre fee title property on the South Platte River east of Evans. The property is heavily used throughout the year by those who do not actively participate in hunting or wildlife viewing activities. Currently the property is open from September 1st through the end of February for hunting rabbit, squirrel, dove and waterfowl, and March 1st through the end of April for hunting turkey. Wildlife viewing is also permitted during this time.</p> <p>There is one parking lot on the property which will accommodate approximately 6 vehicles. Those who are not actively using the property for hunting loiter in the parking lot and along the river corridor of the property during peak hunting hours and into the night. This activity is creating safety hazards between the hunting and non-hunting public, as well as conflicts for adjacent landowners.</p> <p>Multi-agency law enforcement patrols and surveillance has shown a high level of littering, vandalism, substance abuse, prostitution and other criminal activity on the property. Law enforcement efforts to patrol the property and evict violators have not solved the issues, as the majority of the non-hunting user's claim to be "watching wildlife" when approached by law enforcement. Surveillance of the property shows that less than one percent of users are actively viewing wildlife.</p> <p>Due to the increase in human demographics in the area, the 65-acre property can no longer safely support a multi-use provision for hunting, fishing and wildlife viewing. Placing the property under a single use restriction of hunting only, and restricting the hours of access will allow for greater enforceability.</p>

ISSUE:	Should the Mitani-Tokuyasu State Wildlife Area change closure regulations and parking regulations to be more closely aligned with other proposed regulations on Weld County SWAs?
DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):	
<p>The Mitani-Tokuyasu State Wildlife Area is a reservation only property in Weld County, that incorporates the confluence of the Cache la Poudre and South Platte rivers. It is a small property that is partially under fee title and partially under a perpetual recreation/hunting easement.</p> <p>Area 4 staff recommends a regulation clean-up for the property to be consistent with other nearby Weld County properties. These proposed changes are considered minor and should provide clarification on the property closures and parking regulations.</p> <p>The current regulations for the Mitani-Tokuyasu SWA are as follows:</p> <p>901(B)149. Mitani-Tokuyasu State Wildlife Area - Weld County</p> <ol style="list-style-type: none"> a. Public access is prohibited from 9:00 pm – 4:00 am, except with an authorized night hunting permit. b. Public access prohibited from March 1 – August 31, except for hunters with a valid spring turkey license. c. Camping is prohibited. d. Fires are prohibited. e. Target practice is prohibited. f. The launching or takeout of vessels is prohibited. g. Horses are prohibited. h. During the regular duck season, hunting access is limited to occupants of vehicles legally parked in 1 of 4 spaces in the designated parking area. A reservation is required to occupy a parking space from 4:00 am until noon. Reservations may be made in accordance with #901.A of these regulations. After noon each day, parking spaces are available on a first-come, first-serve basis.

ISSUE:	Should the wording for regulation #901(B)(118)(g) be changed to account for early Aquatic Nuisance Species inspection station closures, and to clarify time frames for legal vessel access on Jumbo Reservoir after ANS inspection station closures?		
DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):			
<p>The current regulation 901(B)(118)(g) reads "From October 1 to until the reservoir is frozen, craft used for fishing or to set and pick up decoys and retrieve downed waterfowl may be launched." In the past, there have been years in which the boat ramp at Jumbo Reservoir has closed prior to October 1. The closure date of the boat ramp varies due to either low water levels or the closure of the ANS inspection station. The ANS inspection station closure also varies every year dependent upon available ANS funding. The recreational rights for Jumbo are leased to CPW from the Julesburg Irrigation District (JID). JID requires the boat ramp to be closed whenever the ANS inspection station is not operating to prevent the launching of motorized vessels without inspection. All motorized vessels are required to be inspected prior to launching at Jumbo Reservoir; therefore, all motorized vessels are prohibited on Jumbo Reservoir once the ANS inspection station closes. Removing the date from the regulation would account for years in which the boat ramp closes prior to October 1. Changing the wording from "craft" to "vessel" would make wording consistent with other regulations since there is a definition for "vessel" but there is no definition for "craft".</p>

ISSUE:	Should the opening date for the Bosque del Oso State Wildlife Area be changed from April 1 to May 1?
DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):	
<p>Collection of shed antlers west of Interstate 25 opens on May 1. However, the Bosque del Oso SWA (GMU 851) opens to public access on April 1. Due to the potential for trophy bull elk in GMU 851, the Bosque del Oso SWA is a major destination for shed antler hunters. The opening date of the Bosque del Oso SWA should therefore be changed to reflect the statewide (west of I-25) regulation and avoid confusion and/or citations for constituents. In 2018, shed hunters entered the Bosque del Oso SWA on April 1 and 'stockpiled' shed antlers or marked locations of antlers with GPS delineation to return May 1 to take possession of the antlers. This put the 'legal' shed hunter at an automatic disadvantage. Commercial operations on a SWA is illegal without a commercial use permit, but some of these antler collectors are obviously selling their sheds. There is also extremely limited public land available for shed antler collection in GMU 851, further increasing the pressure on the Bosque del Oso SWA.</p> <p>In most parts of western Colorado, winter conditions affecting big game typically last into late April or early May, and big game are still losing weight and body condition. The Bosque del Oso SWA is primarily bull elk winter range, so a May 1st opening date would also help minimize additional stress during this critical time frame.</p>
