

West Slope Mountain Lion Plan

- Larger Scale
- 'Stable' population objective
- Two independent management thresholds: evaluated annually and applied to entire West Slope at DAU scale

• Lion Density Monitoring





West Slope Plan management threshol

- The Adult Female proportion in harvest will not exceed <u>22% of the total DAU</u> <u>harvest composition (in any single year)</u>
- Total human-caused mortality will not exceed <u>17% of</u> projected lion population in the DAU (using a running 3-year average)
- Both selected to achieve a stable population level
- Both thresholds received broad support from lion advocacy groups






East Slope DAUs


- Most plans around 20 years old
- L-19 updated in 2019
- Two DAUs under Research Objectives
- Harvest and Mortality thresholds
- In "stable" objective DAUs
 - 45% or lower female (adult and subadult) proportion in harvest
 - 50% or lower female (adult and subadult) proportion in total mortality

Currently different than West Slope Plan BUT...East Slope Planning Process underway















Recent study areas with density estimates












Modeled lion density versus measured


Current statewide estimated mortality rates

- Annual harvest rate = 11.5% 13.3 %
- Annual total human-caused mortality rate= 14.2% 16.4%


West Slope Management Plan threshold= not exceed 17% total human-caused mortality
