

Colorado Bobcat Mortality and Harvest Report

Bobcats are a small-game furbearer species in Colorado with a harvest season from Dec 1- end of Feb of each year. Either a furbearer license or a small game license AND furbearer harvest permit is required to pursue bobcats. The season closes two months in advance of female bobcats giving birth. Bobcat kittens are usually born in late April/May and disperse independently in fall and winter. Possession of a harvested bobcat comes with the requirement for a mandatory check and sealing process in Colorado, which allows CPW to collect specific data on bobcat mortalities, including gender, age class, and location of mortality. All reported bobcat mortalities are shown in the table below, including harvest, roadkill, game damage, and other sources (miscellaneous).

Each year, CPW summarizes and evaluates data on bobcat population performance against five management guidelines. The goal of evaluating bobcat data against these benchmarks is to maintain long-term, self-sustaining bobcat populations in suitable habitat in Colorado while also providing opportunities for bobcat harvest. A diverse suite of management guidelines are used to develop an annual conclusion on bobcat population trend. If the majority of these metrics exceed the management guidelines in certain scenarios, CPW could recommend adjusting regulations governing bobcat seasons, harvest methods, or bag limits to safeguard Colorado's bobcat populations. Recent evaluations of these guidelines suggest Colorado's bobcat populations are stable and may be increasing in some areas. Colorado's bobcat season timing and length, limitations on trapping methods of take, and the annual data collected from mandatory check on all harvested bobcat supports the management of a viable bobcat population.
