



Public COW Hunter Management/Ranch Rules

-) All Cow Elk hunters must check in for orientation at 6:00 pm the night before your season starts. Orientation will be held at the ranch office located off of Hwy 69 at the Ranch Headquarters.
-) Upon Arrival each hunter and guest must signed a “Release” on file with the office.
-) All hunters will be provided with maps designating hunting and non-hunting areas, access points and suggested areas to hunt.
-) All hunters will be required to bring the harvested animal to ranch Headquarters for inspection. Whole or quartered
-) In order to protect habitat, reduce erosion and repair cost, vehicles are not allowed off any ranch road except for parking immediately next to the road.
-) Practice before you arrive on the ranch, “we” want to promote a one shot clean kill on all animals harvested.
-) ATV, motorcycle, snowmobile, horse or pack animal will not be allowed
-) Consumption of alcoholic beverages will not be allowed on the ranch property while conducting hunting activities
-) No smoking and no drug use of any kind on ranch property
-) No fires will be allowed on ranch property.
-) All gates will be left as found
-) All hunters are permitted to be accompanied by one guest only. And must notify ranch ahead of time about their guest. Guest may not be a licensed outfitter nor professional hunter
-) All hunters are required to abide by all Colorado and federal laws.
-) All hunters shall not drive more than 15mph on ranch property

-) No shooting from a vehicle
-) No rifle shall be loaded while in vehicle
-) Camping or overnight stay is not allowed on ranch property.
-) No hunting of any other species other than what you have a license for will be allowed
-) No prehunt scouting will be allowed on the ranch
-) All hunters must abide by all ranch rules. Violation of these rules can and will result in expulsion from the ranch, loss of hunting privileges and possible criminal prosecution. We uphold the highest standards for fair-chase and ethical hunting.
-) Hunters are not allowed to use or put up any personal trail cameras
-) No fishing on the ranch for any reason.
-) No shed or artifact hunting on ranch. If found all items stay on ranch.
-) Processing of harvest animals is the hunters responsibility.
-) Any medical issues must be pointed out prior to arrival on ranch.
-) Please respect all Ranch Personnel. They will help you in anyway they can, so long as it doesn't interfere with their ranch duties.

Public **BULL ELK** Hunter Management/Ranch Rules

-) All Bull Elk hunters must check in at 5:00 pm the night before your season starts. Check in will be held at the ranch office located off Hwy 69 at the Ranch Headquarters. Hunter's vehicle will remain at headquarters during the hunt
-) All Bull Elk hunters will be guided by ranch personnel. Room and board will be provided by ranch.
-) All Bull hunters must abide by the ranch management rules and harvest mature bull elk only. Our guides are the best in the business. The older and the bigger they are, is our goal for your trophy.
-) Upon arrival, each hunter and guest must sign a "Release" on file with the office.
-) All hunters will be required to bring the harvested animal to ranch Headquarters for inspection and removal of the front bottom two teeth for ranch aging.
-) In order to protect habitat, reduce erosion and repair cost, the hunter's vehicle will be kept at ranch headquarters. And the hunter will be with their guides for the remaining of the hunt.

-) The hunter must leave the ranch no later than 24 hrs. after harvesting said animal
-) Practice before you arrive on the ranch, “we” want to promote a one shot clean kill on all animals harvested.
-) ATV, motorcycle, snowmobile, horse or pack animal will not be allowed
-) Consumption of alcoholic beverages will not be allowed on the ranch property while conducting hunting activities
-) No smoking and no drug use of any kind on ranch property
-) No fires will be allowed on ranch property.
-) All gates will be left as found
-) All hunters are permitted to be accompanied by one guest only. And must notify ranch ahead of time about their guest.
-) All hunters are required to abide by all Colorado and federal laws.
-) All hunters shall not drive more than 15mph on ranch property
-) No shooting from a vehicle
-) No rifle shall be loaded while in vehicle
-) Camping or overnight stay is not prohibited on ranch property.
-) No hunting of any other species other than what you have a license for will be allowed
-) No pre-hunt scouting will be allowed on the ranch
-) All hunters must abide by all ranch rules. Violation of these rules can and will result in expulsion from the ranch, loss of hunting privileges and possible criminal prosecution. We uphold the highest standards for fair-chase and ethical hunting.
-) No fishing on the ranch for any reason.
-) No shed or artifact hunting on ranch. If found all items stay on ranch.
-) Processing of harvested animals is the hunters responsibility.
-) Any medical issues must be pointed out prior to arrival on ranch.
-) Food diet request must be made in advance of arrival.
-) Please respect all Ranch Personnel. They will help you in any way they can, so long as it doesn't interfere with their ranch duties.
