IT'S TIME FOR THE SECONDARY DRAW — ACT NOW!

BIG-GAME HUNTERS:

Most elk, deer, pronghorn and bear licenses not issued through the primary draw are available in the secondary draw that is open to anyone, whether you applied for the primary draw or not. It's your chance to get licenses remaining from the primary draw without having to wait until leftover day!

Some things to remember about the secondary draw:

- You must have a qualifying license to apply for the secondary draw.
 Fall turkey licenses are now valid qualifying licenses!
- The \$8.00 resident and \$10.00 nonresident application fees apply.
- The secondary draw does not use preference points, and you cannot apply for preference points.
- Applications are for individuals only, not groups.
- Youth receive preference for all hunt codes in the secondary draw.

Other license options:

The secondary draw is a great way to get licenses remaining from the primary draw without having to wait to get your license over the counter. If you'd rather not participate in the secondary draw, you still have other options to get a license:

- Wait for leftover day: Limited licenses that were not issued in the primary or secondary draws will be made available on leftover day, Aug. 6, starting at 9 a.m.
 MT. Or you can buy an over-the-counter (OTC) license; these licenses also go on sale Aug. 6, starting at 9 a.m. MT.
- Keep checking the Leftover List, available in late July. A new **REISSUE PREVIEW LIST** will be posted online every Tues. at 11 a.m., and those hunt codes will be moved to the Leftover List and available for purchase every Wed. starting at 11 a.m. All hunt codes will be released 11 a.m.–1 p.m. on Wed. of every week, starting the week after leftover licenses go on sale. *No new hunt codes will be added to the list after 1 p.m. each Wed*.

APPLY FOR THE SECONDARY DRAW ONLINE THROUGH YOUR ACCOUNT

You may also submit your application by phone.

- **A.** Sign into your CPW account at **cpwshop.com**. *Do not create a new account if you already have one*.
- **B.** Confirm your account details (personal information, unique identifier, contact details, etc.), or make any necessary updates.
- **C.** Hover over "Go Hunting & Fishing" in the blue banner at the top of the page and click on "Buy Big Game Licenses," listed under "Hunting Licenses" in the dropdown menu. (On your mobile phone, click on the three-bar icon in the upper lefthand corner and then select "Go Hunting & Fishing" from the dropdown menu.)
- **D.** Select residency and click "Proceed."
- **E.** Be sure you have your qualifying license before you begin your application.
- **F.** Select the species you want to apply for (deer, elk, pronghorn and bear), then click the "Apply Now" button in the dropdown menu.
- **G.** Fill out the application with your hunt code selections (enter up to four choices per species) and hit "Submit."
 - Application fees will be charged at this time.
 - Successful applicants will have the credit card they have on file in their account charged after the draw. The payment deadline is **July 22, 2024, 11:59 p.m. MT**.
 - **NOTE:** Do **NOT** buy another license or redeem a voucher for the same species until after you receive the results of your secondary draw application.
