<b>LICENSE SURRENDER PERIOD UPDATE</b>		
<p>1, 6</p>	<p>The new license surrender period information has been clarified since the time of publication.</p> <p><b>The updated information is:</b></p> <p><b>Even if a customer decides to surrender their license by the license surrender period deadline, CPW will automatically charge the credit card on file when an awarded license is posted to the customer's account.</b></p> <p>Customers will then receive preference point restoration to the pre-draw level, <b>a refund of the license fee</b> and removal of the surrendered license from the customer's account.</p> <p><i>The online version of the brochure has been updated with this correction.</i></p>	<div data-bbox="643 573 1459 911" style="border: 1px solid black; padding: 10px;"> <p>► <b>A BRIEF PERIOD TO SURRENDER YOUR LICENSE AFTER THE PRIMARY DRAW IS NOW AVAILABLE:</b> Once the draw is complete, CPW will send emails to customers who are successful in the draw and provide them with a short period when they can decide to surrender their license if they no longer want it, receiving preference point restoration to the pre-draw level and removal of the license from the customer's account. The deadline for this surrender period is <b>Fri., April 22, at 11:59 p.m. MT</b>. If you do not follow the instructions in the email and surrender the license by the deadline, CPW will charge the credit card on file in your account as we normally would.
