

Project title Blodgett Open Space Development



A. Give a detailed description of the project, including information such as miles of new or resurfaced trails, any other trail components/structures, and the restoration/decommission of old reroutes.

The Blodgett Open Space Development Project will include the following elements:

- 1. Trailhead improvements including a new parking lot to accommodate approx. 50 stalls
- 2. Professional and purpose built sustainable trail system -

17000 LF of Chamberlain Trail (providing regional connectivity)

8626 LF open space, singletrack trails

14850 LF Mountain bike only trails

1600 LF social trail closure

- 3. Wayfinding posts for new trails, new maps, signage with rules/regulations, and "Leave No trace" education signs
- 4. Stormwater permits for City of Colorado Springs construction activities. (These are required at time of disturbance to ensure compliance with stormwater management best practices).
  - B. Describe the project's urgency and why it is being pursued at this time.

The Blodgett Open Space Master Plan process was driven by the city's need to update its existing 21-year-old master plan to include new acquisitions that expanded the open space and address the city's growth which has resulted in a significant increase in visitation, legal trail use, and illegal trail building.

Because of the popularity of this area, land managers and the community alike have expressed concerns about increased degradation to the natural resources, including the known Bighorn sheep habitat. City staff affirmed the need to reduce user conflicts and improve public health and safety for trail users through decreasing social trail access and creating designated trails that are managed and maintained.

C. Describe all existing trails/trail systems in the area and the need for additional trail reroutes to be constructed.

Designated Blodgett Open Space trails currently make up about 9 miles. This includes several trails on utility and maintenance access roads. Some of the "roads" will be rerouted to singletrack trails. Many of the existing trails leave the open space and travel uphill and thus do not provide good connectivity, loop options, or variations for skills levels. The Blodgett Open Space Master Plan will recommend a trail system of 21.5 miles.

The project will expand access by incorporating a new trailhead on the south side of the open space and through substantial construction of the recommended master plan trail system.

#### 2. COMMUNITY BENEFIT

15 points

A. Describe the community that will benefit from this project. Include relevant demographic and economic data.

With 500,000 residents, Colorado Springs is the state's second largest city. Located on the Front Range, it boasts a vibrant and diverse community with proximity to an abundance of outdoor amenities and a temperate climate conducive to four seasons of outdoor recreation. Colorado Springs is unique in its geographic expansiveness, with a municipal footprint that spans 195 square miles.

From its inception as a city, Colorado Springs has long enjoyed a robust park system that has helped shape the community's identity. The City of Colorado Springs PRCS department maintains over 18,000 acres of parkland and open space, 15 regional parks, 143 neighborhood and community parks, an extensive urban trail network, community centers, museums, golf courses, Garden of the Gods Park and Pikes Peak America's Mountain. Voters in 2020 affirmed the importance of outdoor amenities with an overwhelming majority supporting an extension of the TOPS (Trails, Open Space, and Parks) sales tax revenue program until 2045.

B. Outline any deficiencies or barriers to access that this project would address or improve for the abovementioned community.

The lure of outdoor amenities and a proliferation of new jobs in recent years has made Colorado Springs one of the fastest growing cities in the state. With the city's increased population arises a demand for more recreation areas, and with this demand, land management challenges to balance recreational and preservation needs. Both Blodgett Peak and the Blodgett Open Space are reflective of these challenges. As Colorado Springs and the neighborhoods surrounding the project area have grown exponentially in the last two decades, an increased amount of trail users have has created the urgent need for comprehensive assessment, planning, and implementation of designated trails for recreational use, and closure of the many social trails that resulted from absent or outdated management plans.

C. Estimate the number of people and/or types of user groups that will have access to recreational opportunities as a result of this project. Include methods for determining this estimate.

Blodgett Open Space is located in Northwest Colorado Springs, which encompasses the neighborhoods of Rockrimmon, Peregrine, and Woodmen Valley, within zip code 80919. The area is adjacent to the US Air Force Academy and just north of Garden of the Gods. Approximately 70,000 people live within a five mile radius of the area including adjacent zip codes of 80918, 80920 and 80904. The open space is nearby three elementary schools and a middle school. This increasingly popular open space and nearby USFS lands are attractive for their forested terrain and scenic views of the city. The 2014 PRCS Master Plan revealed that 90 percent of respondents utilize parks and open spaces at least once per week. Considering this figure, Blodgett Open Space provides potential access for nearly 70,000 proximal residents.

#### 3. PROJECT MANAGEMENT

10 points

A. Give a detailed description of who will oversee the design process and trail construction. Include who will build the trail (staff, volunteers, conservation corps, contractors, etc.)

The City of Colorado Springs Parks Department's David Deitemeyer, Senior Landscape Architect, will design and manage the construction of the project. David has 11 years of trail design, construction, and management experience. He has successfully led many projects of this size and scope.

Construction activities described in the scope of work for this grant request will be contracted out to professional trail builders. The PRCS Department anticipates utilizing volunteer groups, maintenance staff, and youth conservation corps in subsequent phases of master plan implementation.

B. Outline any CPW State Trails funding received in the last five years and if the project(s) were completed on time, on budget and within scope. For applicants without prior State Trails funding, provide examples of similar grant funded projects. Include project title, year of award, grant amount, and grantor for each.

Within the last five years, the City has received State Trails Grant funding for the Daniels Pass Trail system (\$250,000 award). The project was completed on time and within budget in 2020.

4. PLANNING 10 points

A. Discuss the process that identified this construction project as a priority.

The City is nearing the last phase of the Blodgett Open Space Master and Management Plan process, a nearly 12-month-long process to study the open space, engage community and establish recommendations for the development and management of the open space over the next 10-15 years.

The proposed improvements include creation of a new trailhead to access the newly acquired open space parcels, identified because there is currently no public access at that location.

The proposed trails seek to expand recreational access to the entire open space to provide improved, expanded and additional trail access for the community while balancing preservation and conservation of the area's resources. Goals identified through the planning process are:

- 1) Expand key habitat areas, wildlife corridors and reduce habitat fragmentation
- 2) Reduce the impact and degradation to the natural resources
- 3) Manage the public access on newly acquired open space parcels

Additionally, the expansion and development of bike-only trails seek to:

- 1) Reduce user conflict between mountain bikers and other trail users. The new bike trails will promote safer multi-use trail conditions by offering select trails to optimize bike-only experiences
- 2) Reduce the number of illegally built trails that have occurred within the open space and adjacent forest service land
- 3) Strengthen the relationship between the PRCS Department and the region's mountain bike user groups, industry partners, and retail businesses

This work will be critical to protect the natural and cultural resources from high use/demand.

B. List all approved internal master or outdoor recreation plans and/or any external area, regional, or statewide plans this project supports.

The City of Colorado Springs has an active PRCS Master and Management Plan adopted in 2014 which calls for the following:

- 1. Enhance and promote the landscape, built-environment, culture and history of Colorado Springs and propose parks and open space strategies customized to the area's unique sense of place and people.
- 2. Create balanced system of conveniently located parks, interconnected trails, open space networks and multipurpose recreational facilities
- 3. Protect the natural environment and promote environmental conservation (water quality, wildlife habitat, scenic views, air quality)

The City of Colorado Springs Comprehensive Plan - Plan COS - Chapter 7 highlights the importance of preserving natural resources stating, "Our citizens and City government place a high priority on the natural environment–protecting natural features, minimizing impacts of environmental hazards, and conserving natural resources." Pikes Peak Outdoor Recreation Alliance (PPORA) is leading the OPPI (Outdoor Pikes Peak Initiative), an aligning initiative which aims to "Identify and advance priorities and innovative strategies for recreation and conservation planning." Further, the SCORP encourages projects which "Foster awareness and experiences that build an ethic of stewardship and responsibility to care for natural and cultural resources and outdoor recreation infrastructure."

A. Explain how the site will be maintained and monitored (maintenance plans, estimated cost, and future budgeting commitments, etc.) after construction.

Once completed, the Blodgett Open Space and its new trail system will be maintained and monitored by the City of Colorado Springs PRCS staff. The City of Colorado Springs has a dedicated tax revenue for development, maintenance and stewardship of our parks, trails and open space known as the Trails, Open Space and Parks (TOPS) program. The program allows for an annual stewardship fund of \$1.5 million for the open space program.

The stewardship of Blodgett Open Space is managed by a PRCS Park Ranger assigned to the property and supplemented by a volunteer citizen group, Friends of Peregrine Parks and Open Space. (Blodgett Open Space is adjacent to the Peregrine Neighborhood).

Lastly, we anticipate additional community involvement from volunteer and nonprofit user groups for maintenance and future trail development needs as identified in the Blodgett Open Space Master Plan.

B. Describe the best management practices that will be used to construct the trail to ensure that the trail and its amenities will be sustainable.

The proposed project will be professionally designed by a landscape architect utilizing professional trail building standards and recommendations from the US Forest Service, International Mountain Biking Association (IMBA), and Volunteers for Outdoor Colorado and incorporating local knowledge of trail building best practices for the Pikes Peak Region.

- Trails will be designed and constructed with frequent grade reversals and will be rolling contour trails.
- -Vegetation and boulders will be used for anchor points, speed control and screening.
- -Trail gradients will be guided by the trail difficulty, soils, cross slope and potential user experience levels.
- Technical bike-optimized trails will incorporate rocks and boulders to armor steep trail grade sections and provide advanced trail features.

Trail designs will be completed to optimize the user experience, best utilize open space and terrain interaction and encourage compliance in staying on designated trails. Land management personnel will utilize maintenance staff and volunteer groups to provide ongoing maintenance as needed.

#### 6. WILDLIFE AND NATURAL RESOURCES

15 points

A. Describe how potential impacts to wildlife and natural resources were evaluated during the project scoping phase (using 'Planning Trails with Wildlife in Mind', mapping tools, etc.). Include any positive impacts this work will showcase.

The Blodgett Open Space Master Plan process evaluated natural resources and wildlife habitats and discussed those findings with CPW, USFS, and US Fish and Wildlife.

Wildlife and natural resource project components include:

- 1. Expanding and enhancing critical wildlife habitats and corridors currently disrupted by habitat fragmentation resulting from prolific social trails in the project area.
- 2. Reducing the number of miles of trails by creating designated and managed trail access.
- 3. Recommendations vetted through CPW, USFS, and the community with guidance from the CPW's publication "Planning Trails with Wildlife in Mind."
- 4. Recommendations to include possible regulated, controlled access (seasonally) in sensitive habitats.
  - B. Describe any wildlife and natural resources issues raised by CPW staff during the application consultation.

None have been submitted.

Based on previous dialogue with CPW staff regarding Blodgett Open Space, we are aware of the importance and sensitivity related to the Queens Canyon Big Horn Sheep herd.

- C. Explain how potential wildlife and natural resource impacts will be avoided, minimized, and/or mitigated (trail realignment, seasonal closures (include dates), signage, gates, game cameras, etc.)
- Designated trail alignments, with a reduction of trail density in the project area, and design of alignment outside of key habitat area
- Non-designated trail closures (currently estimated at 6 miles)
- Expanding and enhancing key habitat areas and wildlife corridors in the project area and east to the City of Colorado Springs
- Exploring management concepts and recommendations including restricting dogs off leash, seasonal trail closures, signage and education, and other applicable regulations
- Expanding the planning area, analysis and future trail improvements onto the adjacent US Forest Service lands (Blodgett Peak Trail planning area 2024 CPW Planning Grant request)

A. Outline public engagement activities for this project (public meetings, comment periods, surveys, etc.)

The City of Colorado Springs PRCS Department is currently leading a strategic community engagement process into the Blodgett Open Space Master Plan that started in May 2023. An active stakeholder action committee has met six times to review and provide input into the engagement process. At the time of this writing, the public process has included five in-person engagement opportunities, three community surveys, one community workshop, and one review survey. Planned are seven more public meetings, including an additional community workshop and two more online surveys. The final Blodgett Open Space Master and Management Plan will be completed by March 2024.

If awarded our CPW Planning grant request, the Blodgett Peak Trail planning project will continue through 2024, expanding the scope of the open space master planning team and allowing for additional public comment and engagement.

- B. Describe any partnerships that will ensure the project's success (public agencies, conservation or recreation groups, local businesses, etc.)
- 1. The project is supported by the PRCS Department's advising bodies the TOPS Working Committee and Parks Advisory Board. Both groups will endorse and approve the final Blodgett Open Space Master and Management Plan.
- 2. Collaborating government agencies include the US Forest Service, Colorado Parks and Wildlife (local office), US Fish and Wildlife Service (appointed biologist), and Colorado Springs Utilities.
- 3. The stakeholder committee includes user and advocacy groups such Trails and Open Space Coalition, Colorado Springs Mountain Bike Association, and Medicine Wheel Trail Advocates, as well as hiking, equestrian, and paragliding groups.
- 4. Nearby neighborhoods, including several HOA's representing adjacent subdivisions, and the Council of Neighborhood Organizations (CONO) are also part of the stakeholder committee.
- 5. Blodgett Open Space continues its existing "Friends Group" partnership with the Friends of Peregrine Parks and Open Space.
  - C. Describe how potential opposition to this project or its implementation will be identified, addressed and managed.

Possible opposition would include providing designated recreational access in/near Bighorn Sheep habitat.

- The master planning process provides for a better understanding of the key habitats, their extents, and their health. Land managers will develop recommendations to reduce the existing amount of social trails which contribute to habitat fragmentation and create designated trails that can be strategically managed and regulated.

Additional opposition may occur related to single use trails in the planning area.

- -This is being addressed in the comprehensive analysis of recreational opportunities in Blodgett Open Space. Single use trails will be specified to reduce conflict among user groups.
- -Under consideration is local management of recreational use in the adjacent planning area (City management on Forest Service lands) which may provide more managed trail access.

#### 8. BUDGET AND FUNDING

A. Describe the source of match for the project and when it will be secured. Include in-kind donations and partner contributions.

10 points

The matching funds are provided by the City of Colorado Springs PRCS Department, totaling \$200,000 (or 44% of the project budget). The funding source is the Trails, Open Space and Parks (TOPS) fund program.

The matching funds have been allocated in the City's 2024 budget which is scheduled to be adopted by the Colorado Springs City Council on December 12, 2023. Once approved, the funds will be available January 1, 2024.

B. Describe any consequences if this funding application is unsuccessful (loss of partner funds, staff capacity, expiration of surveys, etc.).

If the funding application is not successful, the following consequences will result:

- It will prolong the necessary management and implementation of much needed regulated public access in a highly sensitive area with increasing demand for use.
- -Degradation of natural resources and wildlife habitat will continue at a fast pace without action.
- -Decreases or eliminates the PRCS department's ability to leverage City funds that are already available.
- -Missed opportunity to strengthen the partnerships with the US Forest Service, CPW, neighborhoods, partner nonprofits, and user groups
- -Decreased recreational opportunities for an increased number of local residents and visitors to Colorado Springs.




