A RESOLUTION SUPPORTING THE GRANT APPLICATION FOR A COLORADO PARKS AND WILDLIFE NON-MOTORIZED TRAILS PROGRAM FOR THE SOUTH VALLEY ROAD TRAIL REPLACEMENT

WHEREAS, the Ken-Caryl Ranch Metropolitan District ("*District*") is a political subdivision of the State of Colorado, organized pursuant to C.R.S. § 32-1-101, *et seq.*, to provide park and recreation services to residents within, and to individuals passing through, its jurisdiction;

WHEREAS, pursuant to C.R.S. § 32-1-1001(1)(h), the District's Board of Directors ("*Board*") has the power to manage, control, and supervise all of the business and affairs of the District, including its financial affairs;

WHEREAS, the District's senior staff have presented to the Board a proposed project scope; and,

WHEREAS, the Board supports the Colorado Parks and Wildlife grant application for the South Valley Road Trail replacement project ("*Project*"), and, if the grant is awarded, the Board supports the completion of the project.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE KEN-CARYL RANCH METROPOLITAN DISTRICT THAT:

- 1. The Board strongly supports the application and has appropriated matching funds for a grant with Colorado Parks and Wildlife for the Project.
- 2. If the grant is awarded, the Board strongly supports the completion of the Project.
- 3. The Board recognizes its legal and financial obligations under the grant if it is awarded.
- 4. The project site is either owned or within a trail easement by the Ken-Caryl Ranch Metropolitan District and will be owned or maintained by Ken-Caryl Ranch Metropolitan District for the next 25 years.
- 5. The Board will continue to maintain the South Valley Road Trail in a high-quality condition and will include funds for maintenance in the annual budget submitted to the Board of Directors for adoption.
- 6. If the grant is awarded, the Board hereby authorizes the District Manager to sign the grant agreement with Colorado Parks and Wildlife.

Project title South Valley Road Trail Improvement Project

1. PROJECT NEED

15 points

A. Give a detailed description of the project, including information such as mileage or width of trail maintenance, re-route or restoration plans, and any other trail components/structures.

The South Valley Road Trail is located along the east side of South Valley Road in Ken-Caryl Valley, just west of C-470. It is located within the South Hogback Open Space. The asphalt trail connects with an existing concrete trail on the south side of Ken Caryl Avenue, extending south along South Valley Road. The Ken-Caryl Ranch Metropolitan District will only be replacing the asphalt portion of the trail, which is all along South Valley Road. The Metropolitan District is planning to replace the 3,750-foot-long asphalt trail with concrete in 2024. The asphalt trail is currently disintegrating at the southern end with significant cracking throughout, creating a safety issue and diminished user experience. The trail is planned to be widened from 8 feet to 10 feet to better allow for a variety of user types, including bikers, hikers, runners, and families with strollers. The concrete depth is planned for 6 inches.

B. Describe the project's urgency and why it is being pursued at this time.

The trail is currently in a state of disrepair, including extensive cracking throughout and disintegration of the asphalt in multiple sections. These issues create safety hazards for all categories of users. Bikers are often seen taking to the road adjacent to the trail and avoiding the trail altogether. The high speed limit on the adjacent road is another safety concern of having bikers on the road versus on the trail.

C. Describe the current condition of the existing trail. Include how it arrived at its current condition.

Several sections of the asphalt trail are disintegrating, and there are cracks throughout. Staff has filled cracks and patched holes on an on-needed basis, but the scope of the issues have expanded exponentially over the last few years. The trail condition has passed the threshold to just perform basic repairs and the trail now needs to be replaced given the safety concerns.



2. COMMUNITY BENEFIT

The trail is easily accessible to residents of both the Plains Areas and the Mountain Areas of Jefferson County, many of which can reach this trail within 10 minutes from their homes. Improved conditions on the trail will make it easier and safer for all ages and abilities to enjoy the trail experience.

Improved connectivity is of utmost importance with this trail. The trail connects to public trails in Jefferson County's South Valley Park Open Space as well as Ken-Caryl Ranch Metropolitan District's South Hogback Open Space. Users can also connect to Coyote Song Trail, which then leads south to Deer Creek Canyon Road. Deer Creek Canyon Road connects to Hildebrand Ranch Park, further expanding access to more trails.

The South Valley Road Trail also offers easy access to the C-470 Bikeway Trail, especially given the recent intersection improvements at C-470 and Ken Caryl Avenue.

B. Outline any deficiencies or barriers to access this project would address or improve for the abovementioned community.

The current trail creates a safety concerns for users on bikes or on foot. Many users instead walk or bike on the adjacent road, which is very concerning from a safety perspective. The high speed limit on the adjacent road is a concern when adding bikers to the road. The community would be able to utilize the trail for commuting and exercise and be off the road.

C. Estimate the number of people and/or types of user groups that will have access to recreational opportunities as a result of this project. Include methods for determining this estimate.

There is a wide array of user types, including bikers, hikers, runners, and families with strollers. The concrete depth is planned for 6 inches. Per trail camera data, the trail averages approximately 60 users per day. Staff feel this number will grow when the trail is replaced with concrete because both safety and user experience will be improved.

3. PROJECT MANAGEMENT

The trail project will be overseen by the Parks Director and Parks Staff of the Ken-Caryl Ranch Metropolitan District. The staff will have oversight of a concrete construction contractor, who will tear out the existing asphalt trail and install the new concrete trail. Ken-Caryl Ranch staff will be responsible for any re-vegetation and future maintenance of the concrete trail.

We are also working closely with multiple Jefferson County departments: Road and Bridge, Traffic and Engineering, and Open Space, to ensure proper connections to the crosswalk at the intersection of Valley Parkway and South Valley Road and the connections to Open Space soft surface trails. We are also working closely with these entities to ensure proper maintenance by the County of South Valley Road to prevent future and mitigate existing runoff issues.

B. Outline any CPW State Trails funding received in the last five years and if the project(s) were completed on time, on budget and within scope. The Ken-Caryl Ranch Metropolitan District has not received any funding from CPW in the last 5 years.

4. PLANNING

A. Discuss the process that identified this maintenance project as a priority.

The South Valley Road Trail has been deteriorating for several years. Staff has filled cracks and patched holes on an on-needed basis, but the scope of the issues have expanded exponentially over the last few years. The trail condition has passed the threshold to just perform basic repairs and the trail now needs to be replaced given the safety concerns. The Metropolitan District Board has been discussing the need for the trail replacement for the past five years, but the full funding was not available until now. The trail has been identified in the District's 10-year Capital Plan as a project for 2024.

B. List all approved internal master our outdoor recreation plans and/or any external area, regional, or statewide plans this project supports.

The South Valley Road Trail is part of the Ken-Caryl Ranch Trails Master Plan. The trail serves as an important connection for both Ken-Caryl residents and non-residents to other public trails in the area. It creates a trail loop from Ken-Caryl Avenue to Valley Parkway to South Valley Road, and it connects to public trails in Jefferson County's South Valley Park Open Space as well as Ken-Caryl Ranch Metropolitan District's South Hogback Open Space.

While this specific trail is not currently part of the Jeffco Trails Plan, the trail does connect to other important trails that are part of the plan, thus further expanding important regional connections. Jeffco is considering us a regional trail for purposes of their Trails Partnership Program, thus once completed it would become part of the Jeffco Trails Master Plan as an existing regional trail. With the recent intersection improvements at C-470 and Ken Caryl Avenue, the South Valley Road Trail provides easy access to the C-470 Bikeway Trail.

5. MAINTENANCE AND SUSTAINABILITY

- 10 points
- A. Explain how the site will be maintained and monitored after the grant funded work is complete (operation and maintenance plans, future budgeting commitments, etc.)

Management and maintenance of the South Valley Road Trail was transferred to the Ken-Caryl Ranch Metropolitan District in December of 1991 via an easement from Jefferson County. Approximately two-thirds of the open space area where the trail resides is owned by the Ken-Caryl Ranch Metropolitan District. The remaining third is owned by Jeffco Open Space. There are portions within Jefferson County right-of-way, so the Metropolitan District is working very closely with Jefferson County on applicable permitting. The Ken-Caryl Ranch Metropolitan District will continue to be responsible for all maintenance of the trail after improvement. The Metropolitan District budgets for maintenance on an annual basis.

B. Describe the best management practices that will be used to construct the trail to ensure that the trail and its amenities will be sustainable.

The contractor will follow the trail design standards as set by Jefferson County Open Space. These include a 10-foot trail width, 6-inch depth, 4500psi fiber mesh, 2' shoulder, saw-cut joints, minimum of 1% cross slope with a broom finish perpendicular to direction of travel. Contractor will shape and compact existing subgrade to ensure a proper base.

6. WILDLIFE AND NATURAL RESOURCES

A. Describe how potential impacts to wildlife and natural resources were evaluated during the project scoping phase (using 'Planning Trails with Wildlife in Mind', mapping tools, etc.). Include any positive impacts this work will showcase.

The current asphalt trail has been in existence for more than 35 years, and the new trail will occupy the same basic footprint but be slightly wider. Given that we are replacing an existing trail, there will be negligible impact to natural and cultural resources. Regarding wildlife, staff engaged Colorado Parks and Wildlife, and they do not have any wildlife concerns. Staff does plan to re-vegetate the impacted area adjacent to the trail with a native seed mixture, and weed management will be addressed in-house as needed.

B. Describe any wildlife and natural resources issues raised by CPW staff during the application consultation.

No issues were raised.

C. Explain how potential wildlife and natural resource impacts will be avoided, minimized, and/or mitigated (trail realignment, seasonal closures (include dates), signage, gates, game cameras, etc.)

If construction occurs anytime between January 1 and August 31 a bird nest survey would be completed and if nests are found, appropriate nest buffers will be established. Nest buffer distances will take into consideration that birds nesting in the area have already adapted to a high level of human caused disturbances because of the proximity of a major roadway adjacent to the work site.

7. PUBLIC ENGAGEMENT & PARTNERSHIPS

A. Outline public engagement activities for this project (public meetings, comment periods, surveys, etc.)

The project was identified in the District's first-ever 10-year Capital Plan in 2020; however, the impacts of COVID prevented the District from moving forward with the project. Since then, the South Valley Road Trail project was discussed in public meetings of the Ken-Caryl Ranch Metropolitan District Board on July 25, August 22, and September 5, 2023. The community was provided notice of these public meetings through email notifications, the Ken-Caryl Ranch e-News email newsletter, and in the Life at Ken-Caryl newspaper. Agendas and board packets, which included details about the trail project, were posted in advance of the meetings on the Ken-Caryl Ranch website at www.ken-carylranch.org. The public is encouraged to provide feedback to the Board either during the public comment portion of meetings or via email. Overall, the community has provided positive feedback and supports the trail improvement. Proposal review and contractor selection will take place at a public Board meeting, providing yet another opportunity for input. Prior to the start of construction, staff will make announcements via our various communications mediums sent to the community and on the website.

B. Describe any partnerships that will ensure the project's success (public agencies, conservation or recreation groups, local businesses, etc.)

The Ken-Caryl Ranch Master Association and the Ken-Caryl Ranch Trail Club support the project. Both entities will assist with communicating the trail project to the community.

C. Describe how potential opposition to this project or its implementation will be identified, addressed and managed.

Community feedback will be encouraged through public meetings and via email. Staff will address any concerns directly with those who have identified any potential issues.

8. BUDGET AND FUNDING

The funding match is coming from the Ken-Caryl Ranch Metropolitan District capital fund and will be available in 2024. Staff is also pursuing potential funding through the Jefferson County Trails Partnership Program, but decisions are not made about that program until December of 2023. The Ken-Caryl Ranch Master Association is offering to contribute \$5,000 toward the project.

B. Describe any consequences if this funding application is unsuccessful (loss of partner funds, staff capacity, expiration of surveys, etc.).

If this funding is not available, the project scope may be reduced or other planned capital projects may be delayed in order to divert funds to this project.

Reviewer assumes that the existing trail alignment will not change when new concrete paving is installed. However, since the width of the new paving is expanding from 8' to 10', and/or the alignment is changed, then surface disturbance will be unavoidable and opportunities for invasive species to establish will be likely. In this case, the Grantee will commit to invasive plant control for several growing seasons or until the issue has been resolved.

The overall surface disturbance is expected to be less than ½ acre and therefore a Jefferson County Grading Permit and other procedural actions intended to protect national waterways will not be required for this project.

The impervious surface area will increase (add 0.18 acre) with expansion to 10' width. But because of runoff being directed into vegetated areas before merging with major drainageways adjacent to the site the additional quantity of water is expected to have a negligible impact in regard to flooding or overall water quality of receiving waters of the South Platte River basin.

Additionally, the project work site is within 30'-100' of a riparian area. A small tributary of Massey Draw parallels the site for approx. 850' of the total 3900LF of the trail corridor. If construction occurs anytime between January 1 and August 31 a bird nest survey should be completed and if nests are found, appropriate nest buffers should be established. Nest buffer distances will take into consideration that birds nesting in the area have already adapted to a high level of human caused disturbances because of the proximity of a major roadway adjacent to the work site.






Local Vicinity Map: South Valley Road Trail



Dear Colorado Parks and Wildlife,

I am the President of the Ken Caryl Trail Club - an organization of over 800 members living in the Ken Caryl neighborhood. My organization would like to lend our support to the trail maintenance grant proposal the Ken Caryl Metropolitan District is submitting to replace the current asphalt trail adjacent to South Valley Road.

This trail provides critical access for our residents to visit South Valley Park, Hildebrand Ranch Park, and Deer Creek Canyon Park for recreation and exposure to the outdoors. This trail is also a vital commuting corridor for our residents that use bicycles to get to work as the trail connects our neighborhood to the C470 trail system providing access to the Denver metropolitan area. Many regional users frequent this trail system as well given the stunning views afforded to those that complete the loop through South Valley Park.

Our current trail is in urgent need of replacement due to large cracks that have formed inhibiting our residents' use of bikes and strollers. The current state of the trail impacts runners and commuters as well that are generally on the trail before and after daylight and the cracks cause safety concerns specifically for this group of users given the reduced visibility.

Replacing this trail with a 10ft wide concrete trail would enhance access for the varied user groups mentioned above by eliminating safety issues and widening the trail to promote concurrent use for those using different types of transportation.

Dear Parks and Wildlife State Trails Committee Members,

I am writing this in support of the Ken Caryl Ranch Metropolitan District's Trail Maintenance Grant to replace the South Valley Road asphalt trail with concrete. I moved to Ken Caryl Ranch Valley in 1991 when the South Valley trail was one of the few all-weather trails available to residents. At the time I was a runner and would utilize that trail 5 days a week year-round. Nowadays I walk it at least once a week. I have been an active member of the community, including chairing the Open Space Committee, involvement in the South Hogback purchase, and serving on the Open Space Management Plan Task Force. During these three decades I have seen multiple asphalt repaving and resurfacing efforts, but the reality is the trail continues to disintegrate, particularly along the upper, southern end.

This trail is arguably one of the most popular trails behind the Dakota Hogback in the Ken Caryl vicinity. It provides multiple connections for hikers, runners, bikers, parents pushing strollers and walkers from an older demographic like me, not only with other paved trials but a wonderful loop from Jeffco's South Valley Open Space parking lot over the Lyons Hogback then north along the Cathy Johnson trail to the South Valley trail and back to the parking lot. With both the South Valley Park and the Metro Districts South Hogback available to the public, this area sees tremendous usage. An additional 800+ homes will be added to the Ken Caryl area over the next several years and the South Valley Road trail is the logical extension to users along the concrete trail extending from the east. In addition to significant recreational use, the trail serves as access to the Lockheed/Martin facility for some commuters.

I cannot stress highly enough the need for improved safety along this stretch of trail. Drainage off of the northbound South Valley Road remains an issue, particularly during the winter when melting snow creates a sheet flood onto the trail which in turn freezes overnight and creates hazardous intermittent ice patches. Cracks and disaggregating asphalt can be found along the entire stretch. I want to mention the danger currently exposed to road bikers heading southbound on South Valley Road between the Ken Caryl Avenue intersection to the Valley Parkway. Southbound on this road provides no shoulder, much less a bike lane, and halfway up the road there is a blind corner with the edge hemmed in by a guard rail and 10 foot retaining wall providing no exit for riders from vehicles driving in the right-hand lane. I believe a 10-foot wide, smooth paved concrete trail would entice cyclists to use it to ride up that stretch rather than that stretch of highway.

Thank you for your favorable consideration of this grant proposal.
