#### AUTHORIZE APPLICATION FOR CPW NON-MOTORIZED TRAILS GRANT FOR \$45,000 AND APPROVE MATCHING FUNDING








Fig. 1 – View of riparian and pasture interface providing immersible experience for trail users.
