WHO?

We are employees on the Pikes Peak Ranger District (PPRD), on the Pike-San Isabel National Forest Cimarron & Comanche National Grasslands which is managed by the USDA Forest Service. Employees on the Pikes Peak Ranger district will travel with-in Colorado to teach and certify sawyers from partners, clubs, volunteers, state, or federal to USFS standards.

WHERE?

The locations for these trainings will be determined based on need. This may be coordinated with CPW and COHVCO as to where we are requested to teach and certify up to 10-15 persons that require the standardized Forest Service saw training. The host persons or entity for this training will need to provide a classroom type setting to accommodate 10-15 students with a projector for power point presentations and internet connection for two days of classroom instruction. The requestors will also need to provide an area of trees where felling can occur for sawyers for two days of filed training and evaluation. The intent is for one class in each CPW region of the state during the year but will be based on need.

WHAT?

The US Forest Service requires Forest Service personnel, volunteers, club members, and partners operating a chainsaw to have the S-212 or Developing a Thinking Sawyer certification to operate a chainsaw on Federal Lands. There currently is a shortage on C-certified sawyers, whom are the only personnel that can teach and certify for the required classes and preform evaluations. The purpose of this grant is to train our cooperators and volunteers into becoming chainsaw certified, so they can operate on federal lands.

The course will be held with two days in a classroom setting and two days in the field. The classroom portion goes over function, maintenance and use of chainsaws, techniques for bucking and felling, safety, and open discussions. Two field days are intended for entry level sawyers learning techniques these are spent with certified sawyers and students will be evaluated on a minimum of two trees for felling, limbing and bucking practices.

In addition to a structured training course, if a need arose to assist in trail clearing or hazard tree felling on another unit, we could travel to that location to help with the projects and recertify or provide new certification at the same time as the work project.

WHEN?

We will provide 4 saw classes from the time this grant is awarded to the end of its life cycle, May 30th, 2026.

1. Need for & Benefit of the Project (25 points):

- The sawyer training will create an opportunity for individuals, clubs, partners, and volunteers to receive chainsaw training that is inline with federal policy for allowing saw operations on federal land.
- By traveling to other portions of the state, training opportunities will be more readily accessible and affordable then if interested parties had to travel to a centralized location for a course. Additionally, the lack of personnel qualified to instruct the classes is creating a gap in abilities and skill levels as less certifications are occurring. The intent is as more people are trained; more interest will develop in people wanting to become trainers themselves.
- These courses and certifications are a necessity for the ability of anyone working on federal land to clear roads and trails of trees and other hazards requiring chainsaw use.
- There is an increasing need for qualified sawyers. By presenting this venue for instruction and certification more sawyers will receive training and develop skills at a uniform standard.
- This concept crosses jurisdictional and land ownership boundaries and is a great way to get many different people together to focus on developing a common skill set and working toward a similar goal.
- At minimum, this project aims to directly train 40 sawyers and indirectly affects all users as more people will be able to perform necessary trail clearing each year.
- This program could also be used as a resource if there is a major wind or snow event impacting trail
 systems, that exceeds local capacity to mitigate in a timely manner. Qualified sawyers and trainers
 could be used to assist in clearing and hazard tree removal. This work could be combined into a formal
 training class and/or use this as an opportunity to recertify individuals and provide additional
 experience and training.

2. Partnerships, Support and Leverage (25 points):

- This project crosses all jurisdictional boundaries. The presented classes and evaluations are available to anyone, group, club, or partnership that has an interest in chainsaw operation.
- Additional ways to partner with this grant include potential support in equipment, logistics, and personnel from NOHVCC and COHVCO:
 - This grant is almost entirely salary based, most equipment, PPE, training materials, vehicle cost and fuel will be provided out of projects funds from the USFS, PPRD.
 - Total cost of the project is \$41,648.00 we are requesting OHV grant funding of \$31,648.00.

3. Resource Protection, Enhancement and Restoration relative to eligible OHV grant activities

(25 points):

- This Sawyer Training grant provides a skill that can be used not only for trail clearing and hazard removal but that can be applied to any aspect of saw use. Many times trees need to be felled to prevent and reduce erosion, or specific section of trees are cut to create structures for trail maintenance, construction, or rehabilitation.
- This skill is applicable to construction, re-routes, rehabilitation and helps to increase partners
 abilities and confidence level to work on larger scale projects and become more involved or versatile
 in trail management in the areas that they work and live.

4. Travel Management Plan Implementation, Education and Enforcement (25 points):

Travel Management.

- This training can, and does bring together multiple user groups, and allows participants to focus on a common objective. Whether users prefer single track, full sized, or 50-inch routes the principles in the sawyer class are independent of user type.
- The skills learned in the course can assist in rehabilitating off-trail, non-system OHV routes by felling trees and using a chainsaw to create barriers such as buck and rail fencing.
- This Sawyer training allows anyone operating a saw on federal land that is affiliated with a group or under a volunteer agreement to operate a chainsaw and be covered legally in the case of an injury or accident.

Education

- This grant is an educational grant. It is focused on training safe and efficient sawyers and developing skill sets that can be directly applied to projects on the ground. This is a formal and standardized training that requires a time commitment from both the instructors as well as the participants.
- The formal training conveys the ability for clubs, partners, and volunteers to take more action and ownership in trail stewardship as well as introduces or reinforces a skill set that is constantly being developed and challenged.

Enforcement and Compliance Activities:




