# 2023 OHV Program Grant Awards

The Colorado Off-Highway Vehicle Program serves to improve and enhance OHV recreation opportunities throughout Colorado, emphasizing safe responsible recreation while protecting natural resources. Registration fees for operating OHV's in Colorado are collected to:

- *Fund trail projects and improvements*
- *Prevent theft and aid law enforcement*
- *Encourage safe and responsible use*

Groups benefiting from OHV registrations include, OHV owners and operators; towns and counties that want to attract OHV recreationalists to enhance local economies; the general public; and public land managers, who are able to use these funds to better manage natural resources. Educated OHV enthusiasts are more conscientious and better stewards of the land. Many OHV trail projects address and resolve environmental issues such as stream crossing and erosion problems.

## Awarded Projects Tasks

Project tasks are performed by the US Forest Service (USFS), Bureau of Land Management (BLM), Colorado Parks & Wildlife (CPW), non-profit OHV clubs, and youth corps groups. Awarded OHV grant projects may consist of: detailed trail work, at times utilizing dozers; working on specific trail issues; and equipment purchases to support the crews performing the work. Tasks may include (but, are not limited to):

- *Trail maintenance & construction, reconstruction, area rehabilitation, improving switchbacks, re-contour and re-route trail segments, clearing corridors and drainage systems, providing resource protection, maintaining trailheads, decommission non-system routes, seeding and fencing areas.*
- *Providing signage, kiosks and maps to better help OHV users in navigating trails.*
- *Equipment purchases to support trail and work crews.*
- *Providing OHV education, making visitor contacts and enforcing compliance issues.*
- *Hosting educational workshops to provide technical information and discussions on relevant OHV topics in order to increase partnerships and resources among federal land managers, local government, and OHV enthusiasts.*
- *Providing Volunteer support.*

## #02 OHV BOX CANYON TRAIL PROJECT

### ■ USFS – Dolores Ranger District

#### *Project Area and Trail System:*

Montezuma County; San Juan National Forest; Box Canyon Trail.

**Total Project Cost:** \$99,000;

**Grant Award:** \$62,000

**Type of work to be done:** Heavy trail maintenance to improve drainages, switchbacks and steep sections of the trail.

**Partners:** Southwest Conservation Corps.

## #31 OHV TRAVEL MANAGEMENT SIGNAGE

### Stay The Trail Education & Stewardship Alliance

#### *Project Area and Trail System:* Statewide

**Total Project Cost:** \$130,000;

**Grant Award:** \$130,000

**Type of work to be done:** Distribution of signage materials for installation in the field to better help OHV users in navigating trails.

**Partners:** Colorado Parks & Wildlife.

## #24 OHV SUPPLY & EQUIPMENT GRANT

### Western Slope ATV Association (WSATVA)

*Project Area and Trail System:* Mesa County; Uncompahgre Plateau; Grand Mesa National Forest; BLM - Grand Junction Field Office.

**Total Project Cost:** \$124,000;

**Grant Award:** \$20,000

**Type of work to be done:** Project materials, supplies and equipment purchased to support trail crew activities.

**Partners:** USFS - Grand Valley Ranger District; BLM - Grand Junction Field Office; Volunteers.



## #29 METCALF FSR #779 MAINTENANCE SUPPORT

### ■ Town of Avon

*Project Area and Trail System:* Eagle County; White River National Forest; Metcalf Road (aka Forest Service Road #779).

**Total Project Cost:** \$66,462;

**Grant Award:** \$39,745

**Type of work to be done:** Heavy maintenance work on Metcalf Road #779 to maintain the status of the road as a Level II high-clearance OHV route that is open to the public. The work done will maintain the technical nature of the route and provide needed erosion control measures.

**Partners:** US Forest Service - Eagle-Holy Cross Ranger District; Wildridge Trail Coalition (WTC); Community Support.



## #12 HPBE OHV TRAIL CREW

### ■ USFS – Hahns Peak/Bears Ears (HPBE) Ranger District

*Project Area and Trail System:* Routt, Moffat Counties; Medicine Bow/Routt National Forests; limited work on Yampa and Parks Districts of the Routt National Forest, where trails cross boundaries.

**Total Project Cost:** \$138,000;

**Grant Award:** \$113,000

**Type of work to be done:** Annual trail maintenance and reconstruction tasks; signage; visitor contacts. Bridge replacement materials, and a dirt bike and accessories to support crew activities will be purchased.

**Partners:** USFS - Yampa and Parks Ranger Districts; Mountain Trail Axxess; Rocky Mountain Youth Corps; Fire crews; Volunteers.

## #20 2023 CANON CITY AREA TRAIL MAINTENANCE

### ■ Rampart Range Motorized Management Committee (RRMMC)

*Project Area and Trail System:* Fremont County; BLM - Royal Gorge Field Office, Gold Belt and Arkansas River Travel Management Plan areas; Four Mile, Texas Creek, Seep Springs, Penrose Commons motorized trail systems among others.

**Total Project Cost:** \$53,000;

**Grant Award:** \$49,000

**Type of work to be done:** Heavy trail maintenance work utilizing a trail dozer and/or excavator will be used to maintain OHV and multi-use trails on the Royal Gorge Field Office.

**Partners:** BLM; Volunteers.

## #35 DONNER PASS/LOOKOUT MOUNTAIN REHAB

### ■ Northern Colorado Trail Riders (NCTR)

*Project Area and Trail System:* Larimer County; Arapahoe/Roosevelt National Forest; Canyon Lakes Ranger District; Trails: Donner Pass Trail #926 - Trail on Elk Creek, Buckhorn Creek, Miller Fork, and Box Prairie Creek in Roosevelt National Forest. Trailhead - 105.472°W 40.52571°N; Lookout Mountain Trail #934 - Trail on Sheep Creek and Miller Fork in Roosevelt National Forest, Comanche Peak Wilderness. Trailhead -105.501°W 40.538628°N.

**Total Project Cost:** \$287,300;

**Grant Award:** \$287,300

**Type of work to be done:** Trail maintenance and reconstruction including: rerouting trail sections within the allowable corridor, removing hazard trees, installing water bars and other drainage work, replacing trail kiosks and carsonite markers, repairing fire damaged bridges.

**Partners:** Single Track Trails Inc.; Volunteers.

## #25 OHV WSATVA TRAIL DOZER GRANT

### ■ Western Slope ATV Association (WSATVA)

*Project Area and Trail System:* Mesa County; Uncompahgre Plateau; Uncompahgre & Grand Mesa National Forests; BLM - Grand Junction Field Office area.

**Total Project Cost:** \$140,000;

**Grant Award:** \$140,000

**Type of work to be done:** A Sutter 500 trail dozer with a winch will be purchased to maintain OHV trails in the area.

**Partners:** USFS - Grand Valley Ranger District; BLM - Grand Junction Field Office; Volunteers.

## #14 WHITE RIVER OHV OPEN AREAS

### ■ BLM – White River Field Office

*Project Area and Trail System:* Rio Blanco, Moffat Counties; BLM - White River Field Office; Proposed open areas: LO7 Hill OHV Riding Area, North Rangely OHV Riding Area.

**Total Project Cost:** \$88,177;

**Grant Award:** \$72,794

**Type of work to be done:** Two new OHV Open Areas will be established on the White River Field Office. Work will include installing an entrance sign, a kiosk, fencing, a cattle guard, a vault toilet, boundary markers and signs. Trail dozer work will include improving the entrance road, improving existing OHV riding routes, and providing the finishing touches on the parking area.

**Partners:** Yampa Valley Trail Riders; Youth Corps; Volunteers.

## #16 BIG BEND OHV TRACK MAINTENANCE

### ■ Central Colorado Mountain Riders (CCMR)

*Project Area and Trail System:* Chaffee County; BLM - Royal Gorge Field Office; Colorado State Parks - Arkansas Headwaters Recreation Area (AHRA).

**Total Project Cost:** \$122,360;

**Grant Award:** \$111,200

**Type of work to be done:** Year-round maintenance and updates to the track. Funds will be used to obtain a water lease, for topsoil and sand, and to procure a water trailer, a tractor and attachments, a trailer, and a rock grizzly.

**Partners:** CPW - Arkansas Headwaters Recreation Area; Bureau of Land Management (BLM); Trails Preservation Alliance (TPA); Volunteers.

## #34 DRY LAKE MOTOCROSS PARK PHASE 2

### ■ Rocky Mountain Sport Riders (RMSR)

*Project Area and Trail System:* Eagle County; Eagle County Open Space; Dry Lake Motocross Park on Trail Gulch Road.

**Total Project Cost:** \$255,000;

**Grant Award:** \$205,000

**Type of work to be done:** Completion of Phase 2 of the development of a 180 acre motorized use facility. Tasks focused on during this phase include:

- Purchasing a skid loader and a water truck.
- Installing a new well, including piping, pumping, and a control system, in the southwest corner of the facility.
- Construction of a new road to the new well site.

**Partners:** BLM – Colorado River Valley Field Office; Slauch Construction; Beaumont Excavating; Tamerell Excavation; High Country Forestry.

### ■ Rampart Range Motorized Management Committee (RRMMC)

*Project Area and Trail System:* Chaffee, Custer, Douglas, El Paso, Huerfano, Teller, Park Counties; Pike & San Isabel National Forests; Rampart Range, West Creek, Rainbow Falls, Wet Mountains, Rainbow Trail, and Four Mile trail systems.

**Total Project Cost:** \$307,859;

**Grant Award:** \$274,935

**Type of work to be done:** Heavy trail maintenance dozer work.

**Partners:** USFS; Volunteers.

## #03 OHV SAN CARLOS TRAIL PROJECTS 2023

### ■ USFS – San Carlos Ranger District

*Project Area and Trail System:* Pueblo, Custer, Huerfano Counties; Pike & San Isabel National Forests; Trails: Squirrel Creek Trail #1384, Indian Trail #1300.

**Total Project Cost:** \$206,583;

**Grant Award:** \$192,048

**Type of work to be done:** Trail maintenance and reconstruction work including drainage structures and trail tread restoration. Two ATVs with winches will be purchased.

**Partners:** Arrowhead Trails LLC; Mile High Youth Corps; Royal Gorge ATV Club; Volunteers.

## #01 OHV DOZER 23 PROJECT

### ■ USFS Dolores Ranger District

*Project Area and Trail System:* Montezuma, Dolores, La Plata, Archuleta, Mineral Counties; San Juan National Forest; Trails include: Dolores District-Aspen Loop, Aspen Spur, Golconda, Morrison and Mancos area trail network; Rico West Dolores OHV trails including Willow Divide, Ground Hog and Black Mesa zones and Lone Cone area; Pagosa District - District Wide Network including routes in the Blue Creek, Mosca,

Monument, Porcupine, and Mill Creek Road landscapes.

**Total Project Cost:** \$67,234;

**Grant Award:** \$42,234

**Type of work to be done:** Heavy trail maintenance dozer work will be done on both the Dolores and Pagosa Ranger Districts' popular OHV trails.

**Partners:** USFS - Pagosa Ranger District; San Juan Trail Riders; Pagosa Trail Riders.

## #37 ITALIAN CREEK FS 759 REHABILITATION

### ■ Colorado Offroad Trail Defenders (COTD)

*Project Area and Trail System:* Gunnison County; Gunnison National Forest; Italian Creek Road (FSR 759).

**Total Project Cost:** \$123,324;

**Grant Award:** \$70,309

**Type of work to be done:** Forest Service Road 759 will be restored and rehabilitated in two phases, crushing road base followed by dozer/hauling/skid steer road work. Dozer work will improve water bars, apply road base material back onto the road where possible, remove boulders, and build better rolling water bars and to cap the rock where required. Two kiosks and signage will be installed.

**Partners:** US Forest Service; Gunnison County Roads Division; Gunnison County Sustainable Tourism and Outdoor Recreation Committee; Club Members; Volunteers.



## #22 CCMR TRAIL MAINTENANCE

### ■ Central Colorado Mountain Riders (CCMR)

*Project Area and Trail System:* Chaffee, Fremont, Saguache Counties; USFS - Salida Ranger District (SRD); Bureau of Land Management - Royal Gorge Field Office (RGFO); Monarch Ridge Trail, Rainbow Trail from Silver Creek to Mears Junction, Rainbow Trail from Hayden Creek to Oak Creek, Poplar Gulch, Greens Creek, DudBob Trail, Sundgren Sunset Loop and the Colorado Trail Section 16.2. CCMR adopted trail segments in all three counties.

**Total Project Cost:** \$95,618;

**Grant Award:** \$84,458

**Type of work to be done:** Heavy trail maintenance dozer work.

**Partners:** USFS; BLM; Volunteers.

## #05 OHV GRAND VALLEY HEAVY EQUIPMENT CREW

### ■ USFS – Grand Valley Ranger District

*Project Area and Trail System:* Mesa and Delta Counties; Grand Mesa & Uncompahgre National Forest; Trails include: Port Mountain #534, Powerline #520, High Trail #515, Little Johnson #617, Young's Creek Connector #508, Crum Reservoir #511, & Bull Basin #507.

**Total Project Cost:** \$263,600;

**Grant Award:** \$223,500

**Type of work to be done:** Two trail dozer crews will conduct heavy trail maintenance dozer work, one doing basic maintenance on both the Uncompahgre and Grand Mesa National Forests, and the other crew will focus on a few routes that require more intensive maintenance and/or reconstructive work.

**Partners:** USFS - Paonia, Delta, and Ouray Ranger Districts; Western Slope ATV Association (WSATVA); Thunder Mountain Wheelers (TMW).

## #07 OHV RAMPART TRAIL CREW & PATROL V

### ■ USFS – South Platte Ranger District

*Project Area and Trail System:* Douglas County; Pike National Forest; Rampart Range Motorized Recreation Area; trail 770 near Bergen Rock, the Bergen Rock trailhead to the Dakan trailhead and the Bail Out trail, connecting trail 770 (Turtle Mtn.) to trail 650. Trails include: 770 A-J, 693, 683.

**Total Project Cost:** \$68,784;

**Grant Award:** \$63,084

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; visitor contacts. A specialized crew will focus on maintaining single track trails in the area and will patrol the Rampart Range Motorized Recreation area.

**Partners:** Rampart Range Motorcycle Management Committee (RRMMC); Volunteers.

## #11 COHVCO ECONOMIC & USE STUDY 2023

### ■ COHVCO Trails Partnership (CTP)

*Project Area and Trail System:* Statewide

**Total Project Cost:** \$73,500;

**Grant Award:** \$64,000

**Type of work to be done:** An updated study will be conducted to evaluate the economic contribution of off-highway vehicle (OHV) recreation in Colorado. The study will be used for assessing the needs of the recreational OHV public based upon use. It will also seek to understand the impacts of the 2020 recreational season on the economic contributions from the sport and will be a tool for determining the direction of OHV funds for statutory purposes.

**Partners:** ABT Associates.



## #06 OHV STAR TRAIL HEAVY MAINTENANCE

### ■ USFS – Gunnison Ranger District

*Project Area and Trail System:* Gunnison County; Grand Mesa, Uncompahgre & Gunnison National Forest; Star Trail #411 - Trail sections to be worked on are to the north and south of Mysterious Lake which is adjacent to the route the trail travels.

**Total Project Cost:** \$75,000;

**Grant Award:** \$56,500

**Type of work to be done:** Heavy reconstruction and maintenance work, repair of existing turnpikes and rocky sections of trail, and work on drainage structures will be done.

**Partners:** Volunteers.

## #13 OHV GRAND JUNCTION MOTOCROSS TRACK PHASE 4

### ■ Motorcycle Trail Riders Association (MTRA)

*Project Area and Trail System:* Mesa County; Motocross Track in the BLM Grand Valley OHV Special Recreation Management Area.

**Total Project Cost:** \$63,660;

**Grant Award:** \$53,660

**Type of work to be done:** Continued track improvement by performing regular maintenance; the main emphasis will be on soil improvement and watering, due to the desert conditions and increased usage.

**Partners:** BLM - Grand Junction Field Office; Volunteers.

## #10 OHV GJFO EQUIPMENT OPS

### ■ BLM – Grand Junction Field Office (GJFO)

*Project Area and Trail System:* Mesa, Montrose, Garfield, Delta Counties; Grand Junction Field Office and McInnis Canyon & Dominguez-Escalante National Conservation Areas; Trails include: Grand Valley Open Area, North Desert, Bookcliffs, parts of Bangs Canyon, Gateway, Barrel Springs, Rabbit Valley, Horse Mountain, Cactus Park, Hunting Grounds, Sawmill Mesa-Wagon Park.

**Total Project Cost:** \$103,700;

**Grant Award:** \$83,500

**Type of work to be done:** Heavy trail maintenance dozer work will be utilized to maintain existing routes and build new trails in accordance with the area's travel management plan. A trailer will be purchased for hauling the equipment and to assist with trail maintenance tasks.

**Partners:** USFS; CPW; Western Slope ATV Association (WSATVA); Motorcycle Trail Riders Association (MTRA); Timberline Trail Riders; Western Colorado Conservation Corp (WCCC).

## #30 OHV STT EDUCATION & STEWARDSHIP ALLIANCE

### ■ Stay The Trail (STT) Education & Stewardship Alliance

*Project Area and Trail System:* Statewide

**Total Project Cost:** \$253,427;

**Grant Award:** \$207,860

**Type of work to be done:** Promotion of responsible OHV recreation and land stewardship, utilizing educational trailers and other outreach tools, such as maps, brochures and videos, at events around the state and through media techniques such as the Stay The Trail website, social media sites, multi-media marketing and advertising.

**Partners:** USFS; BLM; CPW; Yamaha Grant; local stewardship sponsors; Club, Organizations, Event & Private Donations; Volunteers.

## #38 NORTH ZONE OHV CREW

### ■ USFS – North Zone (Canyon Lakes Ranger District & Pawnee National Grasslands)

**Project Area and Trail System:** Larimer, Weld Counties; Arapaho & Roosevelt National Forests and Pawnee National Grassland (PNG); Trails include: Post-Cameron fire routes – Crown Point Road 139, Cheyenne Ridge 139 and Black Hollow 142 systems; Green Ridge South Trail 177; Bald Mountain 517 from Manhattan County Road 69 to Roaring Creek 173. Additional project areas: North Fork Grace Creek 965-1; Old Roach routes 207 & 143; the Main Draw OHV Area located on the PNG. Other “emphasis” motorized routes include: Storm Mountain 153, Old Flowers 152, Swamp Creek 171s, and Sand Creek system (336, 523, and 212).

**Total Project Cost:** \$300,069;

**Grant Award:** \$150,040

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; visitor contacts. A UTV and utility dump trailer will be purchased.

**Partners:** Larimer County Four Wheel Drive Club; Big Thompson 4 -Wheeler; Northern Colorado Trail Riders (NCTR); Colorado 4x4 Rescue and Recovery.

## #19 LITTLE SNAKE OHV TRAIL CREW

### ■ BLM – Little Snake Field Office (LSFO)

**Project Area and Trail System:** Routt, Moffat, Rio Blanco Counties; Bureau of Land Management – Little Snake Field Office; BLM-LSFO’s Travel Management Area 2; South Sand Wash Special Recreation Management Area.

**Total Project Cost:** \$170,531;

**Grant Award:** \$150,000

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; implementation of the Recreation Area Management Plan; visitor contacts.

A trailer and UTV will be purchased.

**Partners:** OHV communities in Moffat, Routt, and Rio Blanco counties; Sand Wash Enduro; Craig Chamber of Commerce; Moffat County Board of Tourism.

## #04 OHV TRAIL DOZER MAINTENANCE PROGRAM

### ■ USFS – Ouray Ranger District

**Project Area and Trail System:** Montrose, Ouray, Delta, Gunnison, Hinsdale Counties; Grand Mesa, Uncompahgre, & Gunnison (GMUG) National Forests; Uncompahgre Plateau, Grand Mesa, Mountain Division and a small section in Gunnison. Specific trails determined in annual dozer meeting.

**Total Project Cost:** \$309,992;

**Grant Award:** \$180,164

**Type of work to be done:** Heavy trail maintenance, reconstruction, and major dozer work projects. Two storage containers will be purchased for the dozers and supplies.

**Partners:** BLM; USFS – Grand Valley, Paonia, Gunnison, and Norwood Ranger Districts; Thunder Mountain Wheelers; Uncompahgre Valley Trail Riders; Volunteers Thunder Mountain Wheelers (TMW); Uncompahgre Valley Trail Riders; Volunteers.





## #27 BLM STATEWIDE OHV LAW ENFORCEMENT

**Project Area and Trail System:** Statewide;

Areas of focus for BLM law enforcement details and patrols include, but are not limited to: Kremmling Field Office (Grand, Jackson Counties) - North Sand Hills Special Recreation Management Area (SRMA); Gunnison Field Office (San Juan, Hinsdale Counties) - Alpine Triangle Recreation Area ("Alpine Loop"); Colorado River Valley Field Office (Garfield, Eagle Counties) - Hubbard Mesa, Roan Plateau, Bocco Mountain, Hardscrabble; Grand Junction Field Office (Mesa County) - West Desert, Bangs Canyon, Cactus Park; Uncompahgre Field Office (Delta, Montrose, Ouray Counties) - Peach Valley OHV area; San Luis Valley Field Office (Saguache County) - Poncha Pass, Elephant Rocks; Other areas of high OHV use will be covered as they are identified and time and resources allow.

**Total Project Cost:** \$137,177;

**Grant Award:** \$25,891

**Type of work to be done:** Law enforcement patrol activities including visitor contacts, public education, monitoring, public safety, and enforcement of OHV regulations and registration requirements.

## #33 BOULDER RANGER DISTRICT OHV CREW

**Project Area and Trail System:** Boulder, Gilpin Counties; Arapaho & Roosevelt National Forests and Pawnee National Grassland; Motorized routes include: Miller Rock, Middle St. Vrain/Coney Flats, Park Creek, Kingston Peak, Rollins Pass.

**Total Project Cost:** \$167,721;

**Grant Award:** \$72,320

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; visitor contacts.

**Partners:** Volunteers; OHV 4x4 Clubs.

**Project Area and Trail System:** Eagle, Pitkin, Garfield Counties, White River National Forest; Eagle/Holy Cross and Aspen/Sopris Ranger Districts; Basalt to Gypsum System, Triangle Peak Trail System/Woody Creek areas.

**Total Project Cost:** \$23,000;

**Grant Award:** \$23,000

**Type of work to be done:** Two new dirt bikes and accessories will be purchased to support the Eagle Zone OHV Crew while performing trail maintenance activities through-out the District.

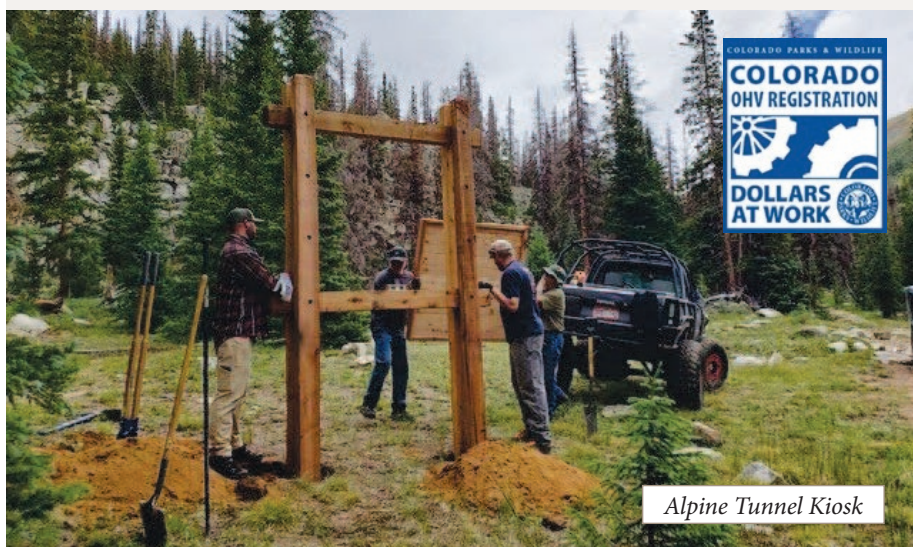

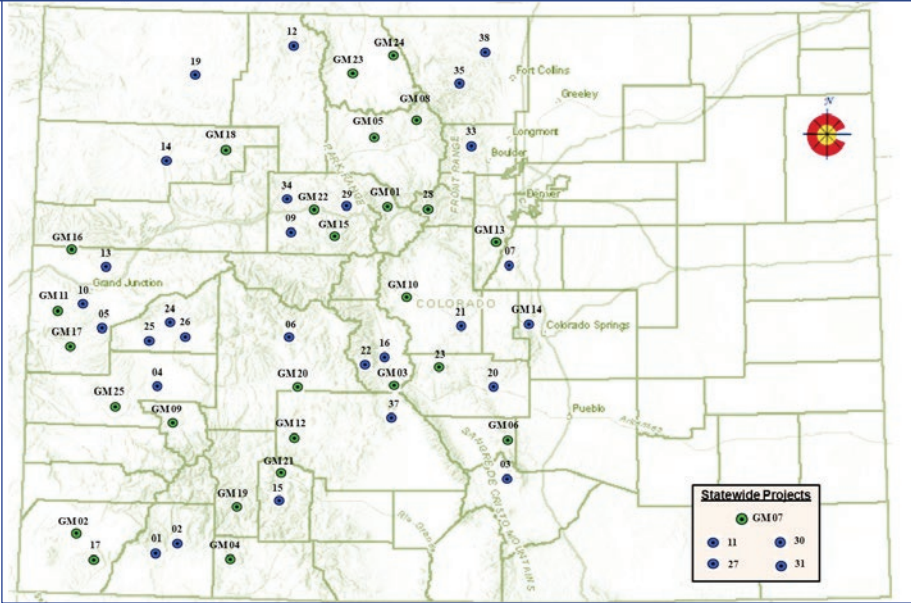

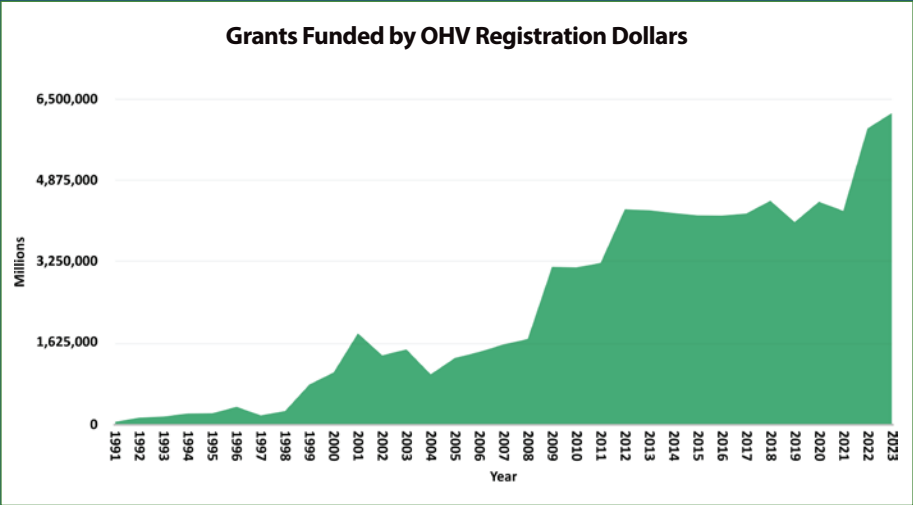
