Tom Waters, AHRA Park Manager

- Salida East:
 - Salida East is currently under construction. The campground is closed, but the boat ramp and river access remain open.
 Construction is set to be complete by Memorial Day. An additional closure will occur in the first two weeks of March, closing the site for 6-7 days while a cement apron is poured at the highway entrance to the site.

Kiosk/KCW:

- Self-serve fee tubes have been removed at all sites with credit card kiosks. Fee tubes have been closed over, and the passes have been removed at less-used sites due to theft and the cost of maintenance during these slower months.
- The new Keep Colorado Wild (KCW) Pass sales will go live on January 3, 2023, and will be available to Colorado residents upon registration of their vehicle. Park passes will remain available for sale as they were prior to the introduction of KCW. FAO

Black Hills

• Cañon City passed Issue 2C. Working out details for the City to acquire and improve the area for a river takeout/put-in.

Big Bend

 AHRA is in the draft phase of a traffic plan for Big Bend, hoping to reduce congestion at the site. AHRA met with the Regional engineer to create a draft plan for access. An outfitter requested boat-in-only camping for multi-day trips with access prohibited from the road. If you have comments, please let Tom (tom.waters@state.co.us) know.

Rincon

 This capital project request is complete. It has been challenging to get permits with CDOT. Maybe unnoticed changes but they are critical. Thanks to the staff.

■ Low-Head Dam (Plans/CPW funding)

• Still an active project in CPW. Received initial funding from the Natural Resources Damages Committee. Now seeking funding to complete \$831 (was 50%), but now costs have increased to an estimated \$1.6-\$2.2M. Fish and Wildlife awarded a grant to complete drawings. Also working with them to fill the gap, CPW will put \$650 in.

■ Fred Rasmussen Nominations

 Two nominations were received. Discussion regarding the two nominees at the next meeting.

Hayden Ranch Agreement

• CPW is working with Aurora to renew the agreement to manage the property. Should be re-signed by the end of the year.

■ Parkdale Fall 2023

AHRA was awarded the large-cap project to redo the boat ramp.
 The in-channel permit is complete. While AHRA has been awarded the money, the bid process now starts. AHRA is working with the Army Corps of Engineers and Fremont County. Improvements to start the week after Labor Day 2023. Not sure about access, the plan is to first get cement (concrete apron) poured. We will keep you posted.

Ruby Access Grant

• The plan at this point is for work to begin in the Fall of 2023, after Labor Day, to widen the road. There will be hard closures on the road, with scheduled pass-throughs. More to come.

- Milk Run Access Near Johnson Village.
 - If you have ideas for put-ins or how to address this issue, contact Tom. Right now Wilderness Aware or BV are the only put-ins.
- AHRA Budget Requests:
 - If you have ideas for budget requests, let Tom know. We can work toward a single important project to move forward with (as opposed to many projects).
- Tubing
 - Current regulation states that tubers must wear a lifejacket.
 - Possible education at 166 to help
 - People are renting tubes but are uninformed, this leaves potential for issues at the dam.
 - Will more Ranger presence help?

- > The Colorado River Water Users Association is meeting in Vegas to determine how to divide up the Colorado River.
- > Colorado Airborne Technology Group (lidar technology)
 - Water entities are looking at how to support this technology to determine the amount of water content in snowpack.
 - New, enhanced Snotel being installed.
 - Studies start in January and technology should be up and going by 2023.
