Reservation Information

Reservations are required for each site. You can reserve a site 24 hours a day, 365 days a year. Reservations can be made from the time you arrive at the park (if sites are available) up to six months in advance of your arrival date.

Limited sites and amenities are available during the *low season.

Full-Hookup Campgrounds - \$41/per night

Full-hookup campsites are located in Raptor Glen, Gobbler Grove, Swift Puma Heights, and the Meadow Campground. These sites include water, sewer, and 50/30/20 amp electrical hookups. They also include a 12'X12' tent pad, picnic table, water hydrant, and fire ring.

Walk-In Tent Sites - \$28/per night

Walk-in tent sites are located in Swift Puma Heights (sites 29-34) and the Meadow Campground (sites 45-48). These sites include a 12'X12' tent pad, picnic table, and fire ring. There are shared water hydrants in the area. Each walk-in tent site has one designated parking spot. Limited additional parking is available.

Aspen Leaf Annual Pass holders receive a \$3 discount Sunday-Thursday (holidays excluded)

Amenities

Restrooms are located in Swift Puma, Raptor Glen, and the Meadow campgrounds. They offer flush toilets, sinks, and a bear proof dumpster. An outdoor playground, dog-friendly trail access, overflow parking, and additional trash and recycling dumpsters can be found at the centrally located Camper Services building.

The *Camper Services building offers additional restrooms, coin operated shower and laundry facilities, a change machine, and an activity room with educational displays. *Camper Services amenities, as well as some campground loops may be closed from mid-Oct to mid-April.

For camper needs, such as park passes, park information, and a gift shop complete with firewood, snacks, and souvenirs, please stop at the Visitor Center.

All vehicles in the park must display a valid park pass. This is in addition to camping fees.

CAMPGROUND RULES

- Camping is allowed in designated areas by reservation only
- Smoking is strictly prohibited on the trails and in the backcountry
- Possession and/or consumption of marijuana/THC products is prohibited
- Please be considerate! Quiet hours are strictly enforced from 10PM through 6AM
- When not in use food, cookware, and coolers must be kept sealed and stored in a hard-sided vehicle or in a bear proof container. Store your garbage in a secure location with your food or use the bear proof garbage cans provided
- Dump all waste water (including dishwater and grey water) down the sewer drains
- Vehicles, trailers, and personal property cannot be left unattended in the park for more than twenty-four (24) hours

CAMPSITES:

- In order to occupy a site, a reservation must be made through the reservation system.
- Check-in is 1PM date of arrival; check-out is 12PM date of departure
- The maximum stay is fourteen (14) days within a forty-five (45) day period
- A maximum of six people and only one camping unit is allowed per site. A camping unit is defined as one motor home, one trailer, or one tent.
- Every site has a 12'x12' tent pad. One additional tent is allowed if it fits on the developed portion of the camp site. It is not permissible to set up tents on any park vegetation
- One additional passenger vehicle is allowed per full hook-up site *if* it fits on the driveway. Each walk-in tent site has one designated parking spot. Additional parking is available. All vehicles must remain on the pavement at all times
- Pay close attention to the recommendations about maximum camping unit length when you make your reservation. Make sure there will be room for your camping unit and vehicle as needed

FIRES AND GRILLING:

- All open fires must be contained in the fire rings and grills provided. Please be aware of any fire bans/restrictions.
- Never leave a fire unattended. Extinguish all fires completely
- No wood cutting or gathering is permitted in the park. Firewood is for sale at the Visitor Center and seasonally from the camp host sites.
- The use of fireworks of any kind is strictly prohibited

VEHICLES:

- Help us protect our natural resources by keeping all vehicles and trailers on the pavement at all times
- Use of off-highway vehicles and motorized scooters is prohibited in the park
- Washing vehicles/RVs at campsites is prohibited

PETS:

- All pets must be leashed (maximum of 6 feet in length) when outside your vehicle or RV
- Leashed pets are allowed in campgrounds, picnic areas, and on *designated* trails. Please ask for details
- Cleaning up after your pet is required
- Do not leave unattended, barking dogs at your campsite

**** Failure to follow rules and regulations by everyone in your party can result in a citation or eviction****

BE BEAR AWARE!

You are camping in bear country! Prevent problems by following the rules of safe camping and being “bear aware” at all times!

- Never keep food in or cook near your tent
- Store food and toiletries in bear proof containers or in an airtight container inside of your vehicle
- Clean up, store food, and remove garbage immediately after meals
- Do not leave food on the picnic tables
- Use the bear proof garbage cans provided or store your garbage in a secure location with your food
- Don't bury or burn excess food; bears will still be attracted to the residual smell
- Never approach a bear or pick up a bear cub

We care about our bears...keep them safe by not attracting them to the campgrounds
