



# Centennial Group Picnic Area Reservation Application



The Centennial Group Picnic Area is available, by reservation, through the Jackson Lake Visitors Center. (Additionally, there are 60 picnic sites, scattered throughout the park, which are available on a first-come, first-serve basis.)

**The CENTENNIAL GROUP PICNIC AREA offers the following amenities:**

- Pavilion picnic shelter.
- Two large grills.
- Horseshoe pits. (Bring your own horseshoes.)
- Volleyball pit. (Bring your own volleyball.)
- Large restroom facility on site.
- Electrical outlets available.
- South shore swim beach area.
- The Dunes Group Campground is adjacent to the picnic area and may also be reserved through the Visitor Center.

**Please be aware of the following regulations:**

- Centennial Group Picnic Area is open year round. Hours are from 9 AM to 9 PM.
- **Beginning January 1st** of each year, reservations for the Centennial Group Picnic Area may be made for the calendar year. Additionally, no year-in-advance reservations will be accepted.
- The fee is **\$100.00** per day to reserve the **Centennial Group Picnic Area**. Reservations will not be confirmed until payment is received. Additional information will be sent when reservation is confirmed.
- Any violations of regulations, damages, or littering can result in a citation and may affect future use of the area.
- **A valid parks pass is required on all vehicles.** Pre-arranged group purchases of park passes may be taken care of prior to your visit or passes are available at the entrance gate upon arrival. The fee is \$8.00/vehicle/day. We also offer an \$80 annual pass which entitles purchaser unlimited access to all of the Colorado State Parks for 12 months from date of purchase.
- Maximum of 36 vehicles and 100 people allowed.
- Pets must be kept on a maximum 6' leash and cleaned up after.
- No person shall use any facility of any group picnic area unless such use is by authority of a valid permit issued by Colorado Parks & Wildlife.
