
Purpose

Initial external scoping was done to inform the management plan regarding public opinion on potential management actions at Lathrop State Park. In addition, the comment form was used to gather demographic information and activity preferences of respondents.

Methodology

A comment form was written by CPW staff in the Southeast Region and Policy and Planning. Park staff conducted intercept surveys in the summer of 2019 to get initial feedback from visitors which was used to develop the questions. The online form was open for comments August 12 – Sept 15, 2019. Anyone with the link could participate. As this was not a random sample survey, results apply to the respondents and are not representative of all park visitors.

The opportunity to provide input was advertised in many ways including: CPW website, a press release, Facebook posts (Lathrop State Park and Cuchara Foundation pages), flyers posted and handed out at the park (e.g., arriving campers) as well as sent to partners (World Journal, La Veta Library, Spanish Peaks Library, Francisco Fort Museum, Spanish Peaks Center for Youth, and Charlies in La Veta), and emails to local partners and summer program presenters.

WALSENBURG, Colo. – The public is invited to help shape the future of Lathrop State Park as a new management plan for the park is drafted by Colorado Parks and Wildlife (CPW).

The planning process will help CPW determine what may be needed to preserve high quality visitor experiences into the future while conserving the natural setting and wildlife habitat at Colorado's first state park.

The 1,594-acre park is west of Walsenburg and sits on a high plains grassland with plenty of pinion and juniper. It features two lakes – one for motorboats and the other reserved for "quiet water" for wildlife watching and angling opportunities. It was opened in 1962 and named for Harold Lathrop, the first director of Colorado State Parks.

The park is a popular spot in CPW's Southeast Region for fishing, boating, swimming and camping. There are also trails and an adjacent city golf course. It is flanked by scenic views of nearby Spanish Peaks.

In addition to gathering public comments, CPW is conducting a comprehensive review of environmental, recreational and cultural resources. CPW will prepare a draft management plan that it will release for review by the public in early 2020.



Results

Ninety-seven people answered questions via the comment form.

Q1. Frequency of visits


Nearly half of the respondents visit the park at least once a month.



Responses for "Other" included: periodically, first time, 3-5 times a week, less than once per year, etc. In addition, comments about what affected visitation included: too expensive to go regularly, used to visit more but "Just cannot stand all the habitat destruction ongoing all the time", and used to visit a few times a month in summer but "never used to visit in colder months, but now have a park pass that I hope to utilize more frequently."


Q2. Distance travelled

Nearly half of the respondents live within 15 miles of the park and over 75% are within 60 miles.




Q3. Length of visit

Q4. Activities – respondents could select all that applied.




"Other" activities included: training dogs/hunt tests (4), paddle board/kayak (3), great meeting room, RV dump site and nature appreciation.





Access/infrastructure:


- A canopy picnic table or tables are needed at horseshoe, please!

- Consider cleaning up more shoreline at Horseshoe for easier fishing access

Target species:

- Pike: 6 respondents indicated they would like to see an end to killing pike; some mentioned catch and release as a preference or limited harvesting; several noted that the fishery for this species has declined
- Other: 1 person said "awesome job on the wiper" and would like to see more muskies in Horseshoe; 1 asked for more brown trout (please!)


Q.12 Priorities for the future

The number of respondents for each topic is notes in parentheses.



Over half of respondents ranked each item to have some level of priority. The top 3 "high priority" topics are: removal of invasives (35% of respondents ranked this as a high priority), more hiking on the hogback (32%) and increased education around cultural resources (30%).

Q.13 Concerns



There was generally low reported concerns over crowding at the locations we asked about. Resource damage and dogs off leash were of higher concern. In addition, 13 of the 14 individuals that did not have concerns over resource damage also selected no concern for all other items and 18 of the individuals with some level of concern for resource damage selected no concern for 3 or more other items.

Camping	Please do something about the bathrooms in campground. They have been redone and are awful. The fact that there is ONE shower stall per campground is awful. You have to stand and wait along time with all the Frogs and the shower house is full of frogs. I understand they were redone to to be more handicap accessible, but now they are useless. In ADDITION, the ladies toilet side only has one toilet and women tend to lock the door, so there again you are just standing out there waiting in line. We were forced to camp there after our home burnt in the Spring Fire and I was SO disappointed with all of this. I have spent countless summers camping and recreating at Lathrop as a child and loved that place. You have ruined the facilities. We actually camped elsewhere in the Fall because of this when dealing with our burnt home. Please please consider fixing this.

Dishwashing stations would be a fantastic addition! We are tent campers and when we've visited other parks that have them it has made our camping experience much easier!

I HATE the reservations I have had nearly 50 friends so far unable to get a site as they are all taken until Sept!

It'd be great to have more sheltered tent camping away from the road and turn the Yucca campground into RV sites. It was already full of RVs with generators. Noisy!

Limit future development

I am a tent camper. I loved my stay at Lathrop because of the Yucca campground. It is so hard to find a primitive campground now. So many places (like Ridgeway) don't even feel like a State Park any more because of the amenities and huge RVs. If I wanted that experience I would go to a KOA. But I just want to be alone with nature and my family. That's all I want and you'd think that would be easy but it's really not. PLEASE PLEASE PLEASE PLEASE PLEASE PLEASE don't add any hookups to Yucca Campground!!! It would totally ruin it!

Leave it alone. More development means more stupid rules.

I have been going to Lathrop State Park for almost 40 years. The changes in the past decade have been heartbreaking. The changes in the past 2 years have caused me to go less and less frequently. Whereas I used to visit the park 3-5 times a week, I now find it hard to make myself go there more that once a month. This is the first year in a long, long time when I almost did not buy a season pass. To paraphrase the old song..."You paved paradise and put up a parking lot." I would truly like to see the unnamed wildlife ponds (where the duck blind is) restored. It seems the only time they are filled is for the "Sporting dog trials". This is critical habitat for migrating and nesting birds some very special ones such as Green Heron and Sora. It was some of the most diverse habitat in the park. Now, even when there is water, the first pond is always blocked off by debris from park "mitigation" and "fishing" access" programs. DO NOT expand the swim beach any further. The last "enhancement" and expansion eliminated one of two places in the park suitable for Semi-palmated Plover and many other migrating birds. I remember right after the expansion they were spraying the newly added sand with pesticide...in the middle of Spring migration! The last time I was at the park I saw someone mowing around Yuccas in one of the picnic areas...why? I took a photo because I just could not believe my eyes. It made, and makes, no sense. It breaks my heart to see what is going on. The other day as I was walking the (in comparison) rather umkempt dirt trails around Wahatoya and Daigre Lake, a fellow hiker asked me about Lathrop. When I told her about the 13 ft. concrete multi-use trail (5 ft. of concrete with 2ft. of red gravel and 2 ft. of mowed grass on either side) she was as dismayed as I was. She asked if there was anyplace to hike without pavement. I did tell her about the Hogback Trail and the small never filled wildlife ponds. I just wish there was more appreciation of the unique habitat of the park, instead of this constant trying to "tame" it, constant urbanization... I have heard there are plans for frisbee golf....seriously??? That said, the seldom used archery range is a great place to looks for all kinds of wildlife. Did not know it was even a part of the

	I would like to see the pike fishery to stay where it is at right now. It is almost perfect. Since the pike weren't introduced into the park by cpw, it seems the trout fisherman wage war on the pike and encourage killing them. Myself and many of my friends travel from around the state just to pike fish at Martin. We spend a lot of money on pike fishing gear, restaurants and hotels in walsenburge, and camping fees. i would definitely like to see some improvements done to the swim beach! maybe an expansion, it does get quite crowded. umbrella rental would be wonderful as there isn't much shade. the youth pond could also use some updating, and more youth fishing or outdoor programs. This place could be great. With proper management of the trophy pike and muskies, lathrop could be renowned.
	PLEASE clean out the plant life in the swim lanes - they aren't useable like that. It is a great place to swim, but not when it is grown up right underneath where swimmers swim. Thank you!!
