Attached to this memo you will find the end-of-year sources and uses report for Colorado Parks and Wildlife. The fiscal year ending June 30th, 2021 continued to show growth in revenues (6%) and a reduction in expenses (10%) that resulted in net income of \$92.2 million. There are several factors that contribute to this, discussed below, and I don't anticipate that we will continue to see this level of net income in future years. However, we did see increased utilization in many areas of our business. Sales of passes at state park increased by 86,717 (6.3%) and the number of camping reservations increased dramatically (32.5%) or \$4.9 million. Across the system we saw a reported 13.1% increase in visitation showing that our parks are busier than ever, with larger increases regionally. The results on the wildlife side are more mixed. We saw declining license sales across many of the big game species, decreased resident fishing, and increased non-resident fishing. The net change to license sales and the increased license fees due to CPI still resulted in increased revenue of \$4.5 million (3.5%). The 2021 big game season did see significant disruptions due to the ongoing pandemic and a damaging wildfire season

There are significant, primarily one-time, events included in this report that should be mentioned.

- Revenue from Great Outdoors Colorado declined by \$10.9 million (22.1%) due to an additional \$9.75 million being provided for the purchase of Fisher's Peak in FY 2019-20 and not in FY 2020-21
- Revenue from Lottery increased by \$8.0 million (56.5%) reflecting increased sales, but also new revenue streams for the outdoor equity grant program (\$750,000), parks (\$2.3 million), and wildlife operations (\$2.3 million). These revenues will continue, and likely increase, in future years.
- Donations decreased \$3.7 million (65%) due to the inclusion of a \$4.3 million donation to the parks system in FY20 but not in FY21. Excluding that event would show a growth in donations of \$1.3 million (47.6%)
- Revenue from the General Fund increased \$22.3 million (17,739.3%) due to a transfer of \$14 million to support parks capital projects, \$3.5 million to support park operations, \$3.5 million to support implementation of the State Wildlife Action Plan, \$1 million for the Outdoor Equity grant program, and \$300,000 related to the \$20 million appropriated for increasing access to state parks (capital construction fund).



- Revenue from Severance Tax was reduced by \$6.4 million (100%) due to lack revenue earned at the state level.
- Expense due to Payments to Other Agencies decreased by \$5.0 million (23.4%) due to the transfer of \$5 million dollars from the Off-highway vehicle fund to the General Fund that occurred in FY20 but not in FY21. There will be an offsetting transfer from the General Fund to the OHV fund in FY22.
- Capital Improvements expense decreased by \$4.2 million (16.9%). Aside from normal variations in the capital program, FY20 also included most of the expense for the Sylvan Dam rehabilitation project. No similarly sized dam projects were completed in FY21.
- Capital Acquisitions expense decreased 14.0 million (84.8%) due to the acquisition of Fisher's Peak in FY 2019-20 and not in FY 2020-21 and smaller \ fewer projects being closed.

Lastly, appended at the end of the document is the wildlife reserve calculation. Updating the policy has been a topic of discussion at the financial subcommittee. This document is intended to facilitate that discussion and to demonstrate the effect on reserve of looking at varying time periods. Any updates from the subcommittee will be provided at the Commission meeting.
