(Dealers, renters and manufacturers should contact the Registration Unit regarding decal placement)

- 1.) Remove all decals from previous years.
- 2.) Avoid application at freezing temperature.
- 3.) Thoroughly clean the area where decals are to be applied (remove wax, tar or any other foreign matter). Allow area to dry completely before applying decals.
- 4.) Remove decals (one at a time) from the backing on the front of this form. Place on vessel/vehicle in the appropriate locations (see below).
- 5.) Rub decals with thumb until all air bubbles and wrinkles are removed.

VESSELS / WATERCRAFT

Place each decal two inches to the left of the "C" in the registration number (CL#) on each side of the bow of your vessel.

If this is an original registration, or your vessel does not display a previously issued Colorado registration number, you must display this number in the following manner:

THE REGISTRATION NUMBER SHALL:

- 1.) Be painted or attached to each side of the bow on the forward half of the vessel (if there are no such sides, a corresponding location on both sides of the foredeck is acceptable).
- 2.) Read from left to right in block characters of good proportion.
- 3.) Be a minimum of 3" in height (excluding border or trim).
- 4.) Be of a color that contrasts with the color of the background.
- 5.) ALL letters and numbers are to be maintained in a manner so to be clearly visible and legible at all times.
- 6.) No other number shall be carried on the bow of the vessel. If another state's registration number is displayed, you must remove it and display the Colorado registration number.

THE OWNER and/or OPERATOR IS REQUIRED TO:

- 1) Carry this certificate when operating the vessel/vehicle.
- 2) Produce the registration certificate upon demand of any peace officer.

This registration is NULL AND VOID when the vessel/vehicle is sold. The new owner should apply to Colorado State Parks for a transfer of ownership and new registration immediately. The registration number issued by Colorado State Parks will remain with the vessel/vehicle.

If this vessel/vehicle is lost, destroyed, or abandoned, the owner must notify Colorado State Parks within 15 days of such event.

OFF-HIGHWAY VEHICLES

- 1) For displaying decals on motorcycles and three-wheelers, position one decal on each of the outside faces of the upper end of the forks.
- 2) For display on four-wheelers, place decals in an observable location on each side of the front fender, not to cover any ATV safety warning stickers.
- 3) On all other vehicles, position one decal on the front and one on the rear in close proximity to the highway plate mounting bracket, if equipped, or on the roll bars so that one decal will be easily seen from the front and one from the rear.



SNOWMOBILES

The current year validation decals must be permanently affixed to each side of the upper half of the cowling of the machine.
