Decisions: Herd Management Planning subcommittee meetings, for 1 hour each, in conjunction with the upcoming July and September Commission meetings would benefit the new members of the Commission.

Future meetings would primarily focus on the process, not the plans themselves. However, for high profile HMPs the subcommittee may want to talk about the issues in the plans themselves. If video HMPs are pre-recorded, the HMP subcommittee could review those presentations prior to the subcommittee meeting.

Discussion:

1. Commissioners provided positive feedback on the new format of providing previously recorded video presentations by plan authors. These videos were provided because the June PWC meeting was a virtual meeting. Commissioners liked the new format. Commissioner Adams requested that videos be available and are inclusive to everyone. She added it's not just content of HMPs that's important but how we tell the story of what's in these plans.

2. HMP Content:

Commissioners requested photos of representative geographical features and habitat in plans and presentations.

Commissioners felt historical perspectives and additional details are very helpful. However, an executive summary or shorter version may be adequate for PWC meetings.

Commissioner Adams suggested we make sure plans are understandable to other interested members of the public, such as recreationists so they know they can have an effect on big game.

Commissioner Adams recommended that changes to HMPs or the process could be test piloted, rather than a decision to change all plans.

3. Regarding frequency of updates:

HMPs can be updated at any time during the 10-year lifespan of the plans if conditions change. HMP objective ranges allow for annual management flexibility based on current and changing conditions.

Commissioner Bray felt that periodic HMP updates, such as every few years would be valuable.

Commissioner Haskett felt a 10-year period for plans was appropriate.

Commissioner Adams appreciated the compromise needed to balance HMP length and update timelines with the time it takes to keep HMPs up-to-date and still have staff complete field work.
