# Colorado Wildlife Habitat Stamp

Colorado Revised Statutes Title 33.  
Parks and Wildlife § 33-1-105.5.  
Acquisition of property—procedure



- (1) Except as provided in subsection (7) of this section, **before the commission purchases any fee title interest in real property or any interest in water** pursuant to section 33-1-105(1)(a), **it shall solicit bid proposals from all interested parties through the issuance of a request for proposals.** Notice of such request for proposals shall be published in a newspaper of general circulation in the area where the commission plans to purchase the real property or interest in water.
- (5) The commission shall evaluate the proposals based on the following criteria:
- (a) Whether the ability of the commission to attain the goals established in the long-range plan of the division is enhanced by the acquisition of the property or interest in water;
  - (b) Whether the acquisition results in the establishment of additional wildlife habitat or in the potential for additional habitat through the use of habitat improvement methods;
  - (c) Whether the acquisition will improve access to other public lands;
  - (d) Whether additional wildlife-oriented recreational opportunities will result from the acquisition;
  - (e) The size and location of the property or interest in water, including the proximity of the property or interest in water to other property controlled by the division; and
  - (f) Such other criteria as the commission may establish.



# Colorado Wildlife Habitat Stamp

Colorado Revised Statutes Title 33  
Parks and Wildlife § 33-4-102.7



- (1) The general assembly hereby finds, determines, and declares that:
  - (a) Protecting wildlife habitat and obtaining public access are important elements to preserving wildlife and wildlife-related recreational opportunities in Colorado;
  - (b) The general assembly specifically recognizes that hunting of big game species is an activity that hundreds of thousands of residents and visitors to Colorado enjoy, which contributes significantly to state and local economies; and
  - (c) Priorities for the expenditure of funds generated from the sale of habitat stamps shall include protecting big game winter range and migration corridors, acquiring public access to wildlife-related recreation, including fishing, hunting, and wildlife viewing, protecting habitat for species of concern, and preserving the diversity of wildlife enjoyed by Coloradans.

## 2020 Recommended Funding Priorities

- \*Public access for hunting, fishing, wildlife viewing
- \*Big game winter range and migration corridors
- \*Protecting habitat for species of concern (specifically Species of Greatest Conservation Need, as identified in the SWAP)
- \*Riparian areas and wetlands
- \*Landscape-scale parcels
- \*Parcels that provide connectivity

## 2020 Recommended Funding Preferences:

- \*3<sup>rd</sup> Party Conservation Easements
- \*Increased public access
- \*Greater donated values
- \*Conservation Easements that support wildlife crossings
- \*Working farms and ranches
- \*Easements are preferable to fee title acquisition



# Colorado Wildlife Habitat Stamp



Colorado Revised Statutes Title 33  
Parks and Wildlife § 33-4-102.7

(3)(c) Real property interest acquisitions made by the commission pursuant to this section shall emphasize the acquisition of easements and ensure that all other avenues are pursued prior to fee simple acquisition. Conservation easements, as described in section 38-30.5-104(2), C.R.S., and fee simple title purchases are allowed. All fee simple title purchases made with revenues collected pursuant to this section, not including purchases of water for maintenance or enhancement of aquatic habitats, such as minimum storage pools or direct flow rights purchased specifically to protect habitat, shall be primarily for the purpose of providing access to the public for wildlife-related recreation, and shall be made available to the public for hunting or fishing, subject to commission rules. The commission shall not use the power of eminent domain to obtain fee simple title or a conservation easement on real property. The commission shall comply with a seller's agreement or sections 33-1-105 and 33-1-105.5 prior to purchasing real property.

(5) The Colorado wildlife habitat stamp committee is hereby created. The committee shall be composed of four sports persons; two representatives of national or regionally recognized conservation organizations whose missions are focused on nongame wildlife and whose membership is composed primarily of nongame wildlife users; two landowners actively engaged in agriculture; one citizen at large; and two division of parks and wildlife representatives as ex officio members, at least one of whom shall be a wildlife biologist. The sports persons shall be representative of the four quadrants of the state. Members shall be appointed by the governor and confirmed by the senate. Staggered appointments shall be made so that not more than two members' terms expire in any one year, and thereafter appointments shall be for terms of four years each. Members shall be limited to two consecutive four-year terms.

- Habitat Improvement
- Term-limited Public Access
- Operations and Maintenance on CPW fee title properties purchased with Habitat Stamp dollars
- Partnership Opportunities such as RESTORE

# Colorado Wildlife Habitat Program



## Funding for the CWHP/RFP:

### \*CPW

- Revenue generated from sale of Habitat Stamps
- Revenue generated by sale of hunting & fishing licenses "wildlife cash"

### \*GOCO (through Cooperative Agreement)

- Wildlife Quadrant Dollars
- NOT from GOCO's other funding programs (Resilient Communities, RESTORE, or previous Open Space, Protect Initiative, etc.)

### \*Federal funding Sources (rarely)





# Colorado Wildlife Habitat Program

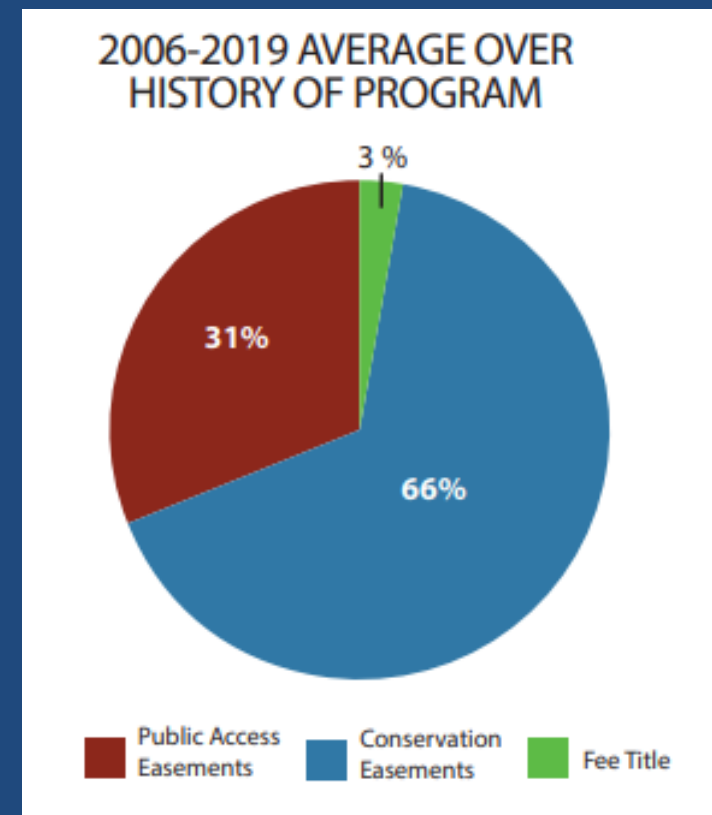


“The RFP” provides private landowners funding opportunities to protect their important wildlife habitat, provide wildlife-related recreational access to their private land, and in limited circumstances, sell their property to CPW. The RFP funds:

- \*Conservation Easements
- \*Public Access Easements
- \*Fee Title Purchases (rare)

Since 2006, CPW has invested ~\$152,000,000 across Colorado to secure:

- \*Conservation Easements on 250,000 acres
- \*Public Access on 117,000 acres
- \*River Bank access along 319 miles of river bank
- \*Fee Title on 11,000 acres



# Colorado Wildlife Habitat Program



## The RFP achieves goals of CPW's Strategic Plan and State Wildlife Action Plan (SWAP):

- Conserve wildlife and habitat to ensure healthy, sustainable populations and ecosystems
- Connect people to Colorado's outdoors
- Increase awareness and trust for CPW
- Build Collaborative conservation partnerships that enhance the capacity to deliver CPW's mission

### CPW's Mission:

*To perpetuate the wildlife resources of the state, provide a quality state parks system, and provide enjoyable and sustainable outdoor recreation opportunities that educate and inspire current and future generations to serve as active stewards of Colorado's natural resources.*

\*4 proposals to be removed

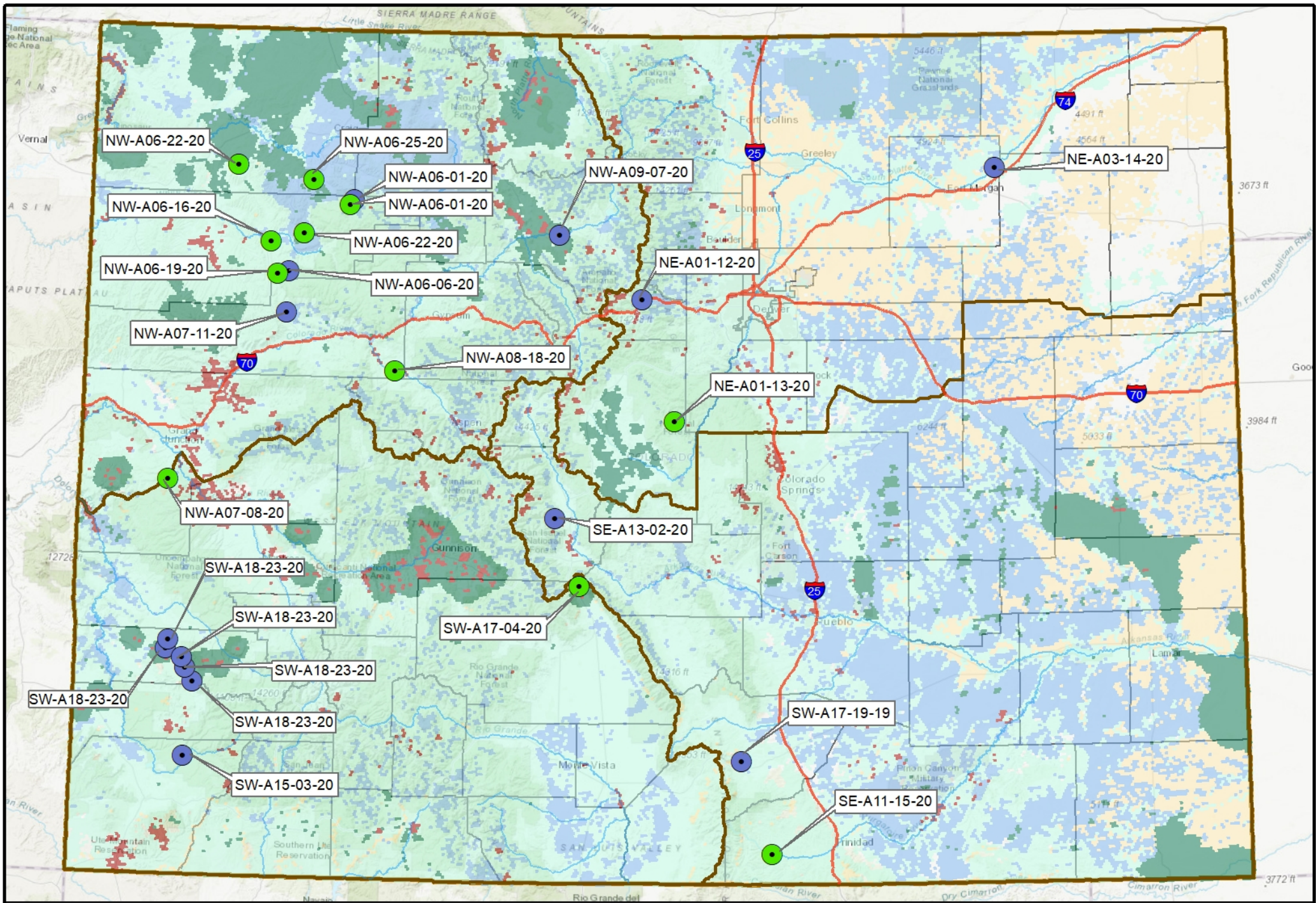
August 14: Director/Leadership Team Recommends:

9 Tier 1 projects - \$20,119,721

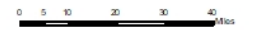
