Subject: Herd Management Plans for the September 2-3 Meeting

At the September 2-3, 2020 Parks and Wildlife Commission meeting, staff will be presenting six draft Herd Management Plans (HMPs). Copies of the draft HMPs are included in the mailing. Similar to the June and July meetings, HMP presentations have been pre-recorded for viewing by both Commissioners and the public ahead of the Commission meeting. The presentations are approximately 5-9 minutes in length and can be accessed by clicking on the titles below. For HMPs D-8, D-9, D-16, D-34 and PH-37, presentations will not be shown during the meeting, but there will be 15 minutes scheduled for each draft HMP to address questions or comments that Commissioners or the public may have.
