ISSUE: Should the regulation that prohibits fishing on the South Prong of Hayden Creek be removed?

DISCUSSION (FACTS AND FIGURES, EXPLANATION OF ISSUE):

A no-fishing regulation was put in place on the South Prong of Hayden Creek to protect a unique strain of Colorado River Cutthroat Trout. In July of 2016, a wildfire on Hayden Pass burned the entire reach of the South Prong of Hayden Creek. Before all of the fish were lost CPW and Forest Service biologists performed an emergency rescue of the Hayden Creek Cutthroats and transported them to be raised at several CPW hatcheries and the Leadville National Fish Hatchery. Due to post-fire ash and debris flows, the stream no longer contains these unique trout. CPW has no plans to reintroduce them to that location. CPW aquatic biologists anticipate trout will naturally repopulate this creek from the mainstem of the Arkansas River. The current regulation is no longer necessary to protect these fish.
