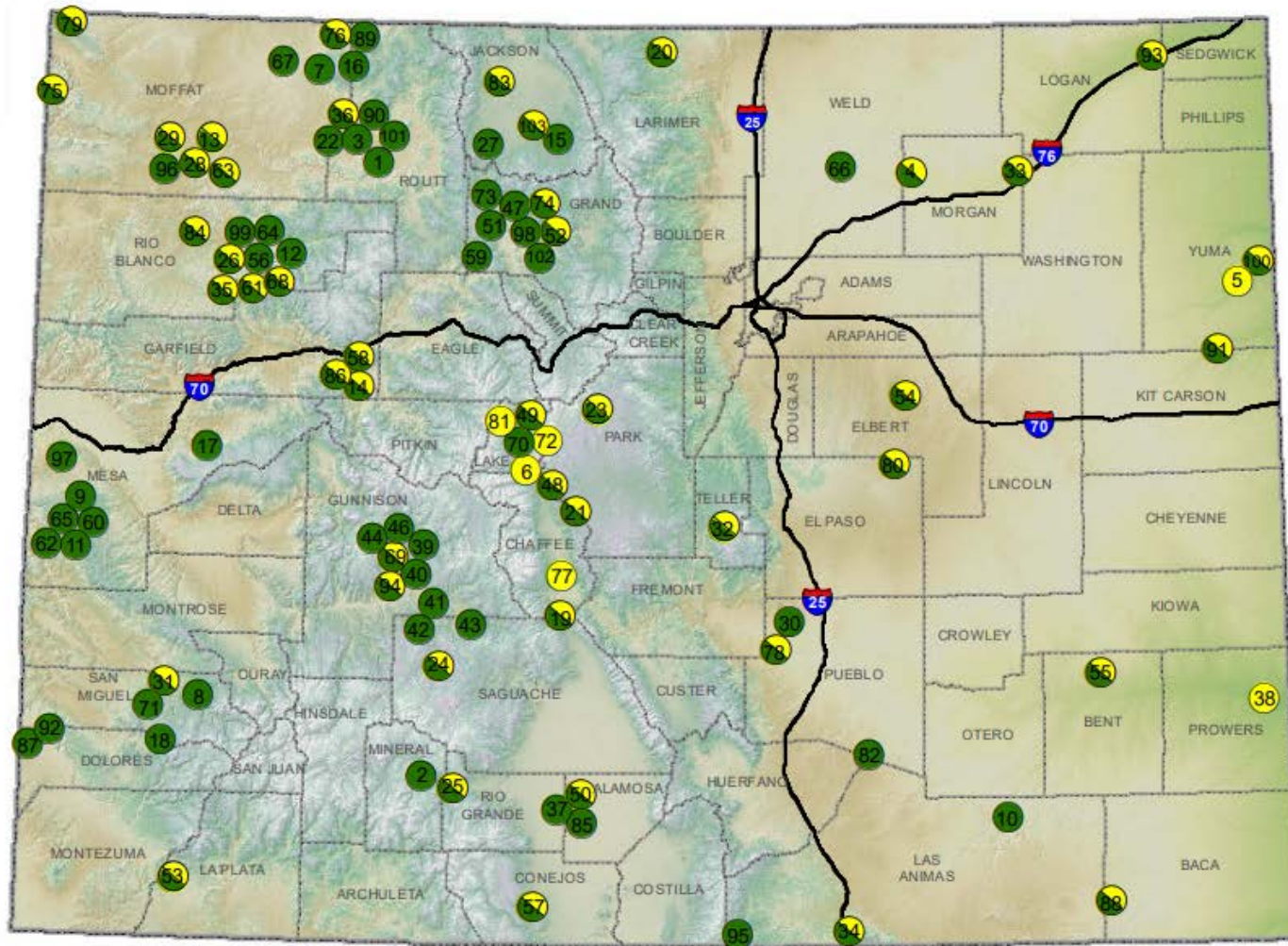

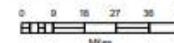

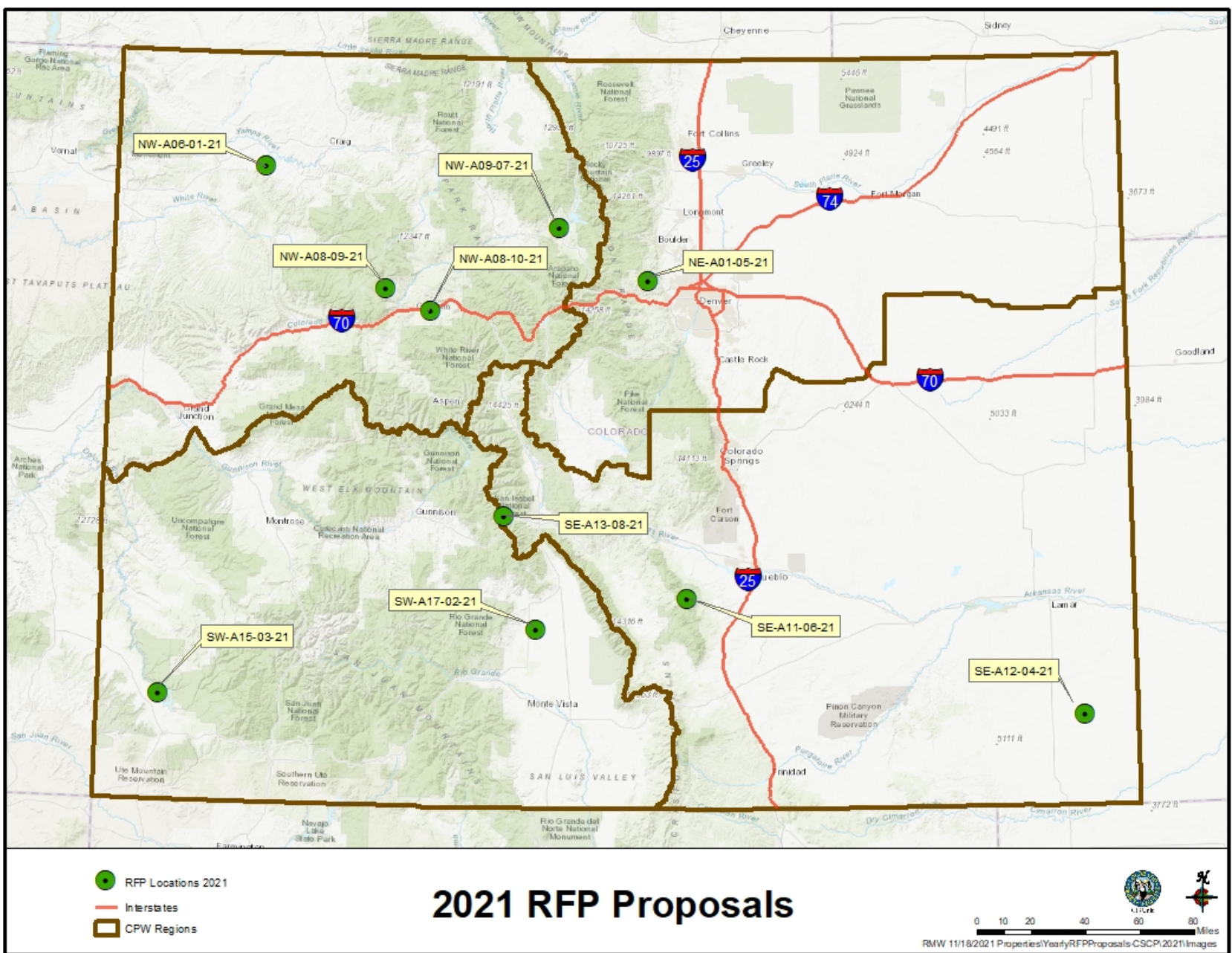


## Colorado Wildlife Habitat Program Closed Projects 2006 - 2020

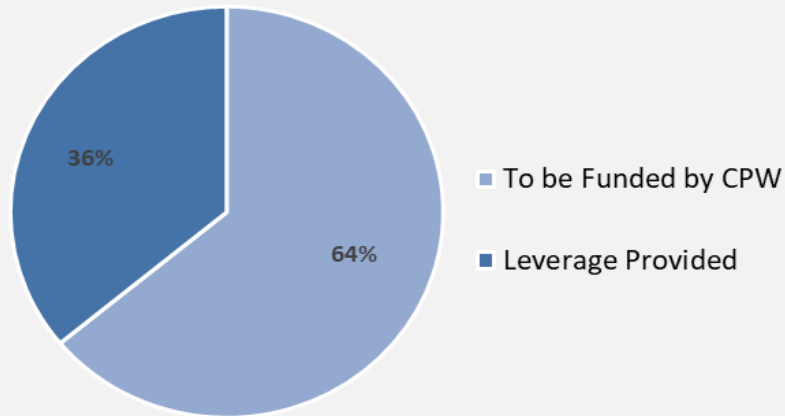

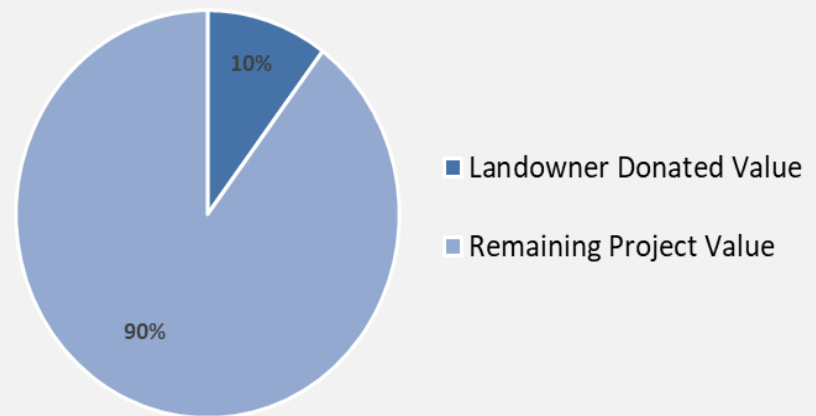

# CWHP Scoring Process

October 28, 2021: RFP Deadline

December 2021 & January 2022:

**CPW Staff**

**Habitat Stamp Committee**

Reviews proposals and provides funding recommendations.

February:

**Leadership Team and Director**

Reviews recommendations and selects projects for further evaluation.

March:

**CPW Staff and AG's office**

Provides transactional review for Leadership Team and Director. Parks and Wildlife Commission updated on preliminary funding recommendations.

April:

**Leadership Team and Director**

Creates final funding recommendations.

May:

**Colorado Parks and Wildlife Commission**

Receives update on Director's final funding recommendations.
