* Purpose of the additional meetings focused on wolf plan:
The purpose of the additional PWC meetings in 2023 is to provide an opportunity for the public to interact with the PWC and provide comments on the draft wolf reintroduction and management plan. All aspects of the plan will be presented at the December 2022 meeting. Subsequent meetings of the PWC in January and February will contain an executive level summary of the plan. The majority of the meetings will be for PWC members to ask questions of CPW staff and to listen to public testimony on the plan. The meetings are scheduled to be held in locations around the state to provide the public opportunities to interact with the PWC at a local level.
