The Outdoor Equity Grant Program (OEGP) invests in organizations that are working to increase access to the outdoors for youth and families from communities that are traditionally underrepresented in outdoor recreation and conservation. Successful applicants propose projects that break down barriers to the outdoors and increase access to outdoor recreation, environmental and conservation-based education, and/or outdoor-related career development for youth and families who: face racial and environmental inequities, are low-income, are from the LGBTQ+community, are disabled, and/or are members of a Federally-recognized Tribe.

The Outdoor Equity Grant Board welcomes applications from eligible organizations (non-profits, for-profits, school districts, local governments or federally-recognized tribes). Organizations may request up to \$100,000 during this round.

Ineligible project components include land acquisitions, trail building or maintenance, trail equipment, building construction, renovations, and indoor structures.

Organizations who have already received funding from the OEGP are eligible to receive another Outdoor Equity Grant if they have spent at least 50% of their previously-awarded Outdoor Equity grant by September 25, 2024. Expense reports demonstrating expenditures must be sent to Andrea Kurth, Outdoor Equity Grant Program Manager, by September 25, 2024.

In July of 2023, the OEGP Board adopted the following values:

- We value opportunities that respect the community's ability to define their own priorities so they can obtain the resources to achieve their goals.
- We value opportunities that instill a sense of wonder, excitement, and responsibility for the environment in Colorado youth and families.

Proposals that bring to life these values will be prioritized for Outdoor Equity Grant investments.

This year, the Outdoor Equity Grant Board is requesting that organizations fill out this preliminary "Letter of Interest" form to indicate interest in applying to the Outdoor Equity Grant. This new process aims to minimize the investment of applicant time and resources while moving forward the proposals deemed most competitive and the best fit for Outdoor Equity Grant Program funds. The board will review Letters of Interest and use a consensus-based process to move the best applicants

to the full application stage. Applicants that make it to the second phase of review will answer additional questions about their proposals and organizations, and submit a budget for their proposal. You can expect to hear back from us about whether you've moved onto the full application stage in August 2024.
