LIVE LIFE OUTSIDE

Products that are a part of the Centennial Program are offered at a discounted cost to qualified Colorado residents who meet certain income eligibility guidelines. To qualify, a resident must show a Colorado photo identification card, provide income verification as listed below, and be 64 years of age or older for senior products. If using the federal *taxable income* for eligibility, it must be at or below the threshold amount based on number of household members shown in the chart below.

These products are also **available at all CPW Offices & State Parks**. Please check the products you would like to purchase:

- ☐ **Centennial Parks Pass - \$14.00**
This pass is valid from the date of purchase and through the last day of the same month in the following year. With this pass, the Centennial Park Pass holder and vehicle occupants will be allowed entrance to Colorado's State Parks in any vehicle they choose. *The pass holder must be present in the vehicle for the pass to be valid.*
- ☐ **Cherry Creek State Park** requires an additional \$3 water basin fee. If you want to visit this park please include this fee in your payment total.
- ☐ **Centennial Senior Lifetime Fishing License - \$11.21** This product is only offered to resident seniors **64 years of age or older**. This is a lifetime license and does not need to be renewed or reapplied for each year. Lifetime fishing licenses also grant access to State Wildlife Areas.
- ☐ **Extra Rod Stamp** requires an additional \$12.68. To fish with two poles, please include this amount in your payment total. Renewable each year.
- ☐ **Centennial State Wildlife Area Pass - \$11.47**
This pass is valid from March 1st to March 31st of the following year. With this pass, individuals will be allowed access to **Colorado's State Wildlife Areas**. This pass does **NOT** provide access to State Parks. *You do not need an SWA pass if you hold any valid hunting or fishing license, including the above Sr. Lifetime Fishing License.*
