Project Description:

WHO? The Central Colorado Mountain Riders (CCMR) is a 501c3 non-profit motorcycle club of approximately 300 members located in and around Salida, CO. CCMR will be responsible for managing the proposed new trail reroute construction in partnership with the US Forest Service (USFS) and will hire a subcontractor for the mechanical effort. CCMR will also provide volunteer effort.

WHERE? The proposed trail reroutes are in Chaffee County on USFS Salida Ranger District (SRD) managed property. There are two reroutes of the Monarch Crest Trail (#531). Access is from US Highway 50 and Marshall Pass Road (CR200).

WHAT? The USFS SRD has designed two reroutes to the Monarch Crest Trail (#531) and created a Monarch Crest Duo NEPA. This NEPA is in final review now. One reroute creates a trail around a snow cornice. The second reroute moves the trail from a 4WD road to a newly created singletrack.

CCMR shall complete the upper cornice 0.5 mile reroute with CCMR in-kind labor. Access to the upper reroute is via singletrack only and prevents the use of mechanical excavators.

CCMR is requesting funding to reroute 1.75 miles with a new singletrack trail reroute.

CCMR will work with our USFS SRD partner and finalize trail flagging. CCMR will let and manage a subcontractor for the mechanical trail building effort. Trail building will include preparing the trail corridor, benching the trail, back-slope smoothing, root cutting, large rock moving, and final grooming effort. CCMR will obtain the required insurance and provide administration of the grant.

WHEN? Once the grant is approved, CCMR will begin our volunteer effort to prepare the trail corridor. As funding is released during the 2025 season, the mechanized trail builder will begin work, and CCMR volunteer effort would then complete the trail cleanup effort. The trail will be completed within one year of the date funds are released. All the onsite work is above 10,000 feet and will need to be done in the summer months.

The project detailed in this application consists of two reroutes to the Monarch Crest Trail (#531).

The Monarch Crest Trail is a singletrack trail that runs from Monarch Pass to Marshall Pass. It is a multiuse trail that is popular with motorcyclists, mountain bikers, hikers, and equestrians. The trail is also part of the Colorado and Continental Divide Scenic Trail systems.

The first Monarch Crest Trail reroute is a 0.5 mile reroute needed to avoid a large snow cornice that does not melt until mid-July on most years. Generally, the rest of this high altitude trail melts earlier, so hikers, mountain bikers, and motos go around the cornice on the tundra causing damage. For the past several years, CCMR has been shoveling/clearing the cornice with a workday after it melts down to a reasonable depth. This year the workday was on July 9th and the snow was still eight feet deep and over 200 feet long. See pictures E.1 and E.2. Unfortunately, users had been going around and damaging the tundra. This reroute will prevent this trail damage. Access to the upper reroute is via singletrack only and prevents the use of mechanical excavators. CCMR will complete this reroute with "in-kind" labor.

The second reroute is to be funded by this grant proposal. CCMR is requesting funding to reroute 1.75 miles with a new singletrack trail reroute adjacent to the 4WD road. For ATVs and 4WD vehicles, this segment is an out and back trail. Being out and back doubles the possibility mountain bikers and motorcycles colliding with ATV and 4WD vehicles. Moving the singletrack users to a singletrack trail eliminates this. Monarch Crest users are already aware the trail is open to mountain bikes and motorcycles as the rest of the trail is singletrack and there are CCMR provided kiosks at both ends showing all users.

This project is a priority because it prevents further trail damage to the tundra on the upper reroute and it increases user safety. It is a benefit to literally thousands of trail users. This is one of the most popular trails in the area.

CMMR's two major partners on this grant are the USFS SRD and the Colorado Trail Foundation (CTF). Both organizations have provided letters of support in Section G. CCMR has formal trail adoption contracts with the SRD for approximately 72 miles of singletrack trails managed by the SRD. Last year, CCMR formally adopted the entire 57 mile SRD portion of the Rainbow Trail. Previously we only had segments of this trail. Since our inception in 2016, CCMR has provided over 10,000 volunteer hours to our USFS and BLM partners. Additionally, the SRD nominated and CCMR was awarded the Public Lands Alliance national Public Lands Partner Award for best practices, leading-edge achievements and excellence in public land partnerships.

CCMR has also adopted a motorized 10.4 mile segment of the Colorado Trail (Segment 16.2) with the CTF. In 2022, we partnered with CTF on a project to repair and reroute this section of the Colorado Trail that has a mud bog that never clears during the summer season. That was a weeklong project involving three USFS Ranger Districts and the CTF. CCMR volunteers camped out on site for the duration, supplying and operating two tractors, trailers and quads. CCMR also assisted the CTF this year when their work crews completed the project. We intend to continue this partnership and have CTF heavily involved in this requested grant project.

CCMR also partners with local clubs and organizations. We had booths and static bikes displayed at the Salada Recreation's Touch-A-Truck event and the Arkansas Headwater Recreation Association Start to Summer event. CCMR and Salida Mountain Trails (SMT) partnered with the SRD on two major events this year. This was our second National Trails Day joint moto/mountain bike (MTB) workday on the Rainbow Trail that was a huge success, so both groups hope to make that an annual event. We also did a joint CCMR/SMT joint Monarch Crest Snow Shovel party where we cleared the snow cornices that are the subject of this grant. CCMR members also assisted SMT on MTB only trails on their workdays.

CCMR volunteers also laid out and swept for the Grand Traverse, the Salida 76 gravel bicycle race and the Vapor Trail 125 extreme endurance mountain bike race. Our trail maintenance work is good for all our partners.

The trail reroutes will be built to NOHVCC trail construction standards and best practices for this area.

The Monarch Crest Trail is a motorized mostly singletrack trail that runs from Monarch Pass to Marshall Pass. It is a multiuse trail that is popular with motorcyclists, mountain bikers, hikers, and equestrians. This trail is also part of the Colorado Trail and Continental Divide Scenic Trail.

Two Monarch Crest Trail reroutes have been designed and are included in the USFS Monarch Crest Duo NEPA (64130). The USFS Salida Ranger District is finalizing this NEPA. This grant is contingent upon the USFS Monarch Duo NEPA being approved. CCMR has been in discussion with the USFS and CCMR expects the NEPA decision later this year (2023) but not before the December 1st grant due date. CCMR is not aware of any community comments that would prevent the approval of the NEPA. Rather than wait until 2024 to submit this grant, CCMR proposes to submit the grant this cycle. Should this NEPA not be approved, CCMR will revoke our grant application. We are submitting this grant now rather than waiting another year.

Two Monarch Crest Trail reroutes have been designed. CCMR plans to complete the upper reroute, which is around a snow cornice, with CCMR in-kind labor. Our in-kind estimate is four people two weeks ($4 \times 80 \times $31.80 = $10,176$). Access to the upper reroute is via singletrack only and prevents the use of mechanical excavators. The actual trail work is relatively easy as the trail is above the treeline.

The lower reroute will parallel the 4WD road Monarch Crest segment to a multiuse singletrack trail. This is the segment near Marshall Pass, thus the grant name Marshall Extension. CCMR is requesting funding to build 1.75 miles of new singletrack trail reroute on the Monarch Crest Trail.

The layout and mapping of the reroutes are complete. CCMR will work with our USFS SRD partner and finalize trail flagging. CCMR will let and manage a subcontractor for the mechanical trail building effort. Trail building will include preparing the trail corridor, benching the trail, back-slope smoothing, root cutting, large rock moving, and final grooming effort. CCMR will create a trail builder state of work, solicit bids, let a subcontract, manage the subcontract, monitor the effort through completion and sign-off, usually with the land manager present, and provide status and invoices to CPW.

The reroutes will be built to NOHVCC trail construction standards and best practices for this area.

CCMR will obtain the required insurance and provide administration of the grant.

There is no large equipment purchase, maintenance nor disposition on this grant.

4. Travel Management Plan Implementation, Education and Enforcement (25 points):

Active and effective OHV management is based upon the implementation of travel management plans, broad public awareness, compliance, enforcement and providing adequate recreation opportunities.





Figure 4-1. Sample Kiosk Multi-User Sign.

Travel Management: A core part of CCMR's mission is to promote responsible travel management. For this project, CCMR has already installed a three panel kiosk at the Monarch Pass trailhead. These panels were designed in cooperation with the FS, BLM, and mountain bike, equestrian, and hiking communities (see example sign in Figure 4-1 below). These signs promote good trail etiquette and proper trail use as well as, notifying users to expect various other users to be on the trail.

This project will decommission the upper reroute old trail with rock barriers at each end. The second reroute will not decommission the 4WD drive road but will include USFS approved signage diverting the singletrack users. This proposed project will benefit primarily motorcycle and MTB riders; however, this trail is open to other types of recreational activities. These include hikers, hunters, mountain bikers, and horseback riders. Therefore, numerous recreational activities will benefit.

Education: CCMR has installed 10 kiosks with the sign panels shown below at trail heads throughout the area. These provide training and promote adherence to OHV regulations. This sign has become a statewide standard and other clubs are now using it in their area. It is a valuable on-the-ground educational tool as it describes the various trail users and their responsibilities. The emphasis is on responsible trail use.

CCMR has created a trifold CCMR brochure that emphasizes trail use compliance and trail etiquette that promotes "Stay the Trail". Additionally, we created the "Be Nice, Say Hi!" motto and have bumper stickers with it printed on it. As we mentioned in the Partners section, we participate in several events each year, and we hand out these brochures and stickers to promote these concepts. Additionally, we promote the "Stay the Trail" principles on our website, Facebook page, Instagram, and in our club-wide newsletters.

Enforcement and Compliance Activities: CCMR conducts regular trail patrols that watch for and counsel travel management violators. The project does not have a specific law enforcement component. This area has not experienced significant off-route use, except for the users going off-route around the snow cornice in early summer season. The cornice reroute should alleviate that issue.






Figure E-1 – Snow Cornice – Typical Year.




Figure E-2 – 2023 Snow Cornice Shovel Workday

Please accept this letter from the Salida Ranger District of the Pike-San Isabel National Forests and Cimarron and Comanche National Grasslands as an official letter of support for the Central Colorado Mountain Riders (CCMR) titled "CCMR Marshall Extension 2025" grant application.

The Salida Ranger District manages over 300 miles of trails on the San Isabel National Forest with roughly 100 miles of those trails providing motorized recreation opportunities. Our unit, located in the "Heart of the Rockies", is a well sought out location for our recreation opportunities including three wilderness areas, popular 14,000ft peak trails, alpine lakes, high profile trails like the Continental Divide National Scenic Trail and the Colorado Trail, and OHV recreation opportunities to name a few. Our recreation program benefits from partnerships from various local agencies, clubs and organizations by way of trail adoption, stewardship, and additional funding mechanisms. The Salida Ranger District is proud to partner with CCMR on multiple trail projects on our multi-use trails throughout the district.

CCMR is an all-volunteer, nonprofit whose mission is to preserve, maintain and create motorized multiuse trail opportunities in the Central Colorado area. CCMR partners with the US Forest Service (USFS) and the Bureau of Land Management (BLM) to preserve the sport of motorized trail riding and multiuse recreation. CCMR has officially adopted approximately 80 miles of multiuse singletrack trails on BLM and USFS managed property via formal volunteer agreements and with the Colorado Trail Foundation to help maintain another 10 miles.

The USFS Salida Ranger District is finalizing a NEPA, Monarch Crest Duo (64130). Two Monarch Crest Trail reroutes have been designed and are included in this NEPA. CCMR plans to complete the upper cornice reroute with CCMR in-kind labor. The lower reroute converts a 4WD road to a multiuse singletrack trail. CCMR is submitting this CPW OHV grant for 2025 funding to subcontract and manage a mechanical (mini excavator) trail builder. The Monarch Crest Trail segments in this NEPA are on the Colorado Trail and Continental Divide Scenic Trail.

This grant is contingent upon the USFS Monarch Duo (64130) NEPA being approved. We expect approval later this year (2023) or early next year (2024). Should this NEPA not be

approved, CCMR will revoke our grant application. We are submitting this grant now rather than wait another year.

For the above reasons, the Salida Ranger District strongly recommends the approval of CCMR's Trail Maintenance Grant application to help CCMR better fulfill its strong commitment to preserve and maintain adopted multiuse trails.

The TPA is an advocacy organization created to be a viable partner to public lands managers, working with the United States Forest Service (USFS) and the Bureau of Land Management (BLM) to preserve the sport of motorized trail riding and multiple-use recreation. The TPA acts as an advocate for the sport and takes the necessary action to ensure that the USFS and BLM allocate a fair and equitable percentage of public lands access to diverse multiple-use trail recreational opportunities.
