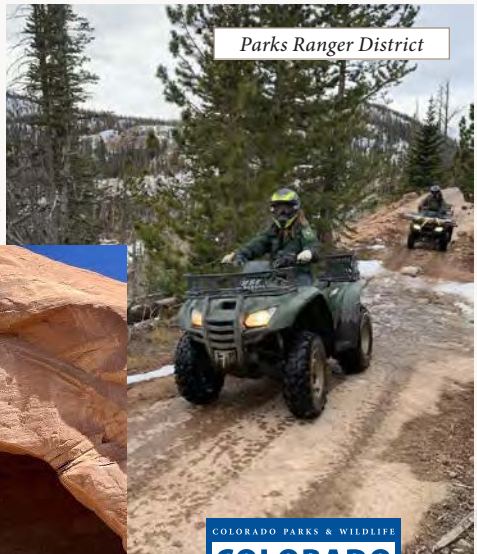
# 2024 OHV Program Grant Awards

The Colorado Off-Highway Vehicle Program serves to improve and enhance OHV recreation opportunities throughout Colorado, emphasizing safe responsible recreation while protecting natural resources. Registration fees for operating OHV's in Colorado are collected to:

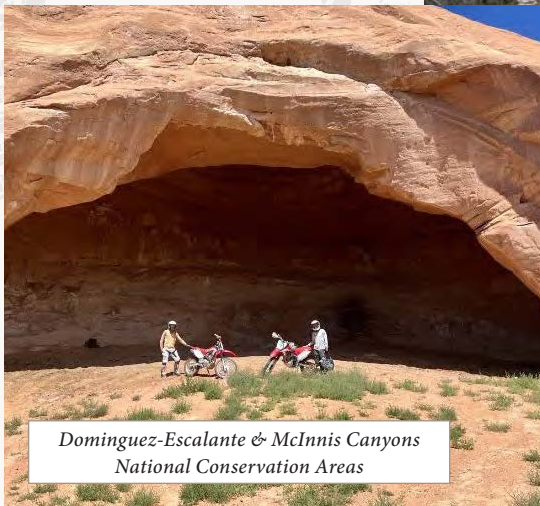
- *Fund trail projects and improvements*
- *Prevent theft and aid law enforcement*
- *Encourage safe and responsible use*

Groups benefiting from OHV registrations include, OHV owners and operators; towns and counties that want to attract OHV recreationalists to enhance local economies; the general public; and public land managers, who are able to use these funds to better manage natural resources. Educated OHV enthusiasts are more conscientious and better stewards of the land. Many OHV trail projects address and resolve environmental issues such as stream crossing and erosion problems.

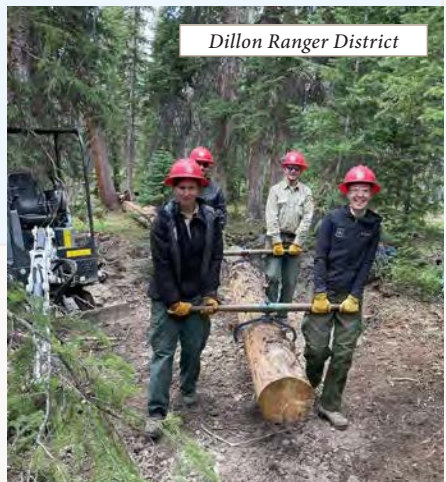

## Awarded Projects Tasks

Project tasks are performed by the US Forest Service (USFS), Bureau of Land Management (BLM), Colorado Parks & Wildlife (CPW), non-profit OHV clubs, and youth corps groups. Awarded OHV grant projects may consist of: detailed trail work, at times utilizing dozers; working on specific trail issues; and equipment purchases to support the crews performing the work. Tasks may include (but, are not limited to):

- *Trail maintenance & construction, reconstruction, area rehabilitation, improving switchbacks, re-contour and re-route trail segments, clearing corridors and drainage systems, providing resource protection, maintaining trailheads, decommission non-system routes, seeding and fencing areas.*
- *Providing signage, kiosks and maps to better help OHV users in navigating trails.*
- *Providing OHV education, making visitor contacts and enforcing compliance issues.*
- *Hosting educational workshops to provide technical information and discussions on relevant OHV topics in order to increase partnerships and resources among federal land managers, local government, and OHV enthusiasts.*
- *Providing Volunteer support.*



## #02 CALICO NORTH TRAIL PROJECT

### ■ USFS–Dolores Ranger District

#### **Project Area and Trail System:**

Dolores County; San Juan National Forest; northern section of the Calico Trail.

**Total Project Cost:** \$127,000;

**Grant Award:** \$85,000

**Type of work to be done:** Heavy trail maintenance, drainage installation, tread rehabilitation, armoring or turnpike construction and brushing to improve line of sight distance. Visitor contacts will also be done.

**Partners:** Southwest Conservation Corps.

## #19 OHV PAGOSA EXCAVATOR

### ■ Pagosa Area Trails Council

#### **Project Area and Trail System:**

Archuleta, Hinsdale, Mineral Counties; San Juan National Forest; Pagosa Ranger District.

**Total Project Cost:** \$71,000;

**Grant Award:** \$71,000

**Type of work to be done:** A mini excavator will be purchased to maintain the entire OHV trail system on the Pagosa Ranger District.

**Partners:** USFS–Pagosa Ranger District.

## #42 COLUMBINE RD OHV TRAIL CREW 2024

### ■ USFS–Columbine Ranger District

#### **Project Area and Trail System:**

Archuleta, Hinsdale, La Plata, San Juan Counties; San Juan National Forest; Trails include those in the Beaver Meadows.

**Total Project Cost:** \$97,800;

**Grant Award:** \$69,080

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; visitor contacts.

**Partners:** Southwest Conservation Corps.

## #11 OHV RAMPART TRAIL CREW & PATROL VI

### ■ USFS–South Platte Ranger District

#### **Project Area and Trail System:**

Douglas County; Pike National Forest; Rampart Range Motorized Recreation Area; Trails include: 770 A-J, 693,683.

**Total Project Cost:** \$120,990;

**Grant Award:** \$111,750

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; visitor contacts; focusing on maintaining single track trails in the area.

**Partners:** Rampart Range Motorcycle Management Committee (RRMMC); Volunteers.



## #40 OHV SUPPLY & EQUIPMENT GRANT

### ■ Western Slope ATV Association (WSATVA)

#### **Project Area and Trail System:**

Mesa County; Uncompahgre & Grand Mesa National Forests; Grand Valley Ranger District; BLM - Grand Junction Field Office area.

**Total Project Cost:** \$167,500;

**Grant Award:** \$63,500

**Type of work to be done:** Project materials, supplies and equipment will be purchased to support trail crew activities. Educational materials such as maps and signage will also be purchased.

**Partners:** USFS–Grand Valley Ranger District; BLM–Grand Junction Field Office; Volunteers.

## #08 TMW TRAIL SUPPORT

### ■ Thunder Mountain Wheelers

#### **Project Area and Trail System:**

Delta, Mesa, Montrose, Gunnison Counties; Grand Mesa, Uncompahgre, and Gunnison (GMUG) National Forests; Trails: Grand Mesa in the Grand Valley Ranger District, the Muddy Country in the Paonia Ranger District and the Uncompahgre Plateau on the Ouray Ranger District.

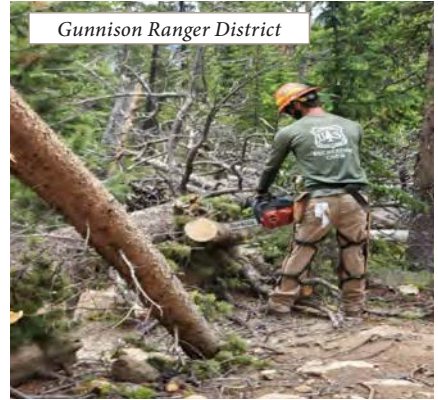
**Total Project Cost:** \$305,501;

**Grant Award:** \$205,905

**Type of work to be done:** Trail maintenance and restoration projects on 31 adopted ATV trails will be done in partnership with the Forest Service. A new trail dozer

with a winch will be purchased along with project supplies, educational guides and maps.

**Partners:** USFS–Grand Valley, Paonia Ranger, and Ouray Ranger Districts; Volunteers.



## #18 2024 RGFO OHV TRAIL MAINTENANCE

### ■ Rampart Range Motorized Management Committee (RRMMC)

#### **Project Area and Trail System:**

Fremont, Chaffee Counties; BLM–Royal Gorge Field Office, Gold Belt and Arkansas River Travel Management Plan areas; Four Mile, Texas Creek, Seep Springs, Penrose Commons motorized trail systems among others.

**Total Project Cost:** \$55,750;

**Grant Award:** \$51,750

**Type of work to be done:** Heavy trail maintenance work utilizing a trail dozer and/or excavator will be done on OHV and multi-use trails on Royal Gorge Field Office lands.

**Partners:** BLM.

## #23 OHV CAMP HALE-VAIL PASS STAKEHOLDER GRANT

### ■ Eagle River Watershed Council (ERWC)

#### **Project Area and Trail System:**

Eagle County; White River National Forest; USFS–Eagle-Holy Cross Ranger District; Camp Hale and Vail Pass area.

**Total Project Cost:** \$105,782;

**Grant Award:** \$82,782

#### **Type of work to be done:**

A facilitator experienced with travel management, motorized trail planning, motorized stakeholders, watershed health, and Forest Service policy will lead a stakeholder engagement process in order to identify a long-term, sustainable OHV connection between Camp Hale and Vail Pass. Recommendations for potential OHV connections will be developed and analyzed through the National Environmental Policy Act (NEPA) process with the ultimate goal of implementing one of the recommendations.

**Partners:** USFS - Eagle-Holy Cross Ranger District; Trail Defenders; Colorado Parks & Wildlife.

## #05 COHVCO 2024 OHV WORKSHOPS (2)

### ■ COHVCO Trails Partnership (CTP)

#### **Project Area and Trail System:**

Statewide

**Total Project Cost:** \$78,000;

**Grant Award:** \$70,000

#### **Type of work to be done:**

Educational workshops on OHV land stewardship, trail maintenance, and sustainability techniques for federal land managers, local government, and OHV enthusiasts.

**Partners:** National Off-Highway Vehicle Conservation Council (NOHVCC); CPW; USFS; BLM; Volunteers.

## #07 OHV SAN CARLOS TRAIL PROJECTS 2024

### ■ USFS–San Carlos Ranger District

#### **Project Area and Trail System:**

Fremont County; Pike & San Isabel National Forests; Tanner/Stultz trail system.

**Total Project Cost:** \$193,200;

**Grant Award:** \$172,000

**Type of work to be done:** Trail maintenance and reconstruction work including: clearing the trail of oak brush, heavy maintenance and reconstruction of the trail tread, widening the trail and fixing the trail for grade reversals, out sloping and sustainable drainage. A trail dozer and mini excavator will be used for areas of rock work that is beyond the ability of hand crews to complete.

**Partners:** Arrowhead Trails LLC; Mile High Youth Corps; Royal Gorge ATV Club; Volunteers.



## #41 LOOKOUT MOUNTAIN TRAIL REALIGNMENT

### ■ Northern Colorado Trail Riders (NCTR)

**Project Area and Trail System:** Larimer County; Arapaho and Roosevelt National Forests; Canyon Lakes Ranger District; Lookout Mountain Trail #934 - Trail on Sheep Creek and Miller Fork in Larimer County. The trail can be accessed through FSR 154, 154C, 129, and 344. Trailhead - 105.501°W 40.538628°N.

**Total Project Cost:** \$391,490;  
**Grant Award:** \$349,560

**Type of work to be done:** The trail will be realigned and rehabilitated. Dead/downed trees will be removed, check dams, water bars and slash will be used to mitigate erosion issues. Kiosks and signage will be installed.

**Partners:** Single Track Trails, Inc., Overland Mountain Bike Association (OMBA) volunteers, Larimer County Youth Conservation Corps, and Canyon Lakes Ranger District (CLRD) Staff.

## #14 BLM-SLVGO! OHV TRAIL CREW 2024

### ■ BLM-San Luis Valley Field Office (SLVFO)

**Project Area and Trail System:** Rio Grande, Saguache, Alamosa, Conejos Counties. Emphasis will be on two of the primary motorized singletrack trail systems of the field office located in Rio Grande County, the Limekiln and Greenie

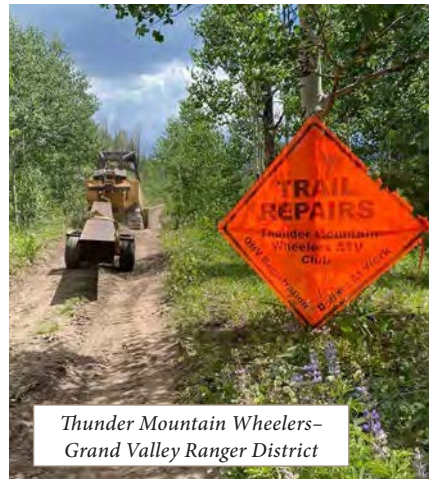
Mountain trail areas, including technical singletrack trails up to full size 4x4 primitive roads.

**Total Project Cost:** \$233,000;

**Grant Award:** \$100,000

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage; visitor contacts; focusing on maintaining single track trails in the area. The SLV GO!, a partnering non-profit organization, will utilize their professional trail crew (the Great Outdoors Action Team-GOATs), to plan, design, and complete the needed maintenance of recently storm-damaged sections of Limekiln and Greenie Mountain OHV trails.

**Partners:** San Luis Valley Great Outdoors (SLV GO!); Great Outdoors Action Team-GOATs; Southwest Conservation Corps (SCC); Volunteers for Outdoor Colorado (VOC).

## #28 COLUMBINE OHV PARKING AREA RESTROOMS 2024

### ■ USFS–Clear Creek Ranger District

**Project Area and Trail System:** Gilpin County; Arapaho & Roosevelt National Forests; Columbine OHV Parking Area trailhead for the Forest Service Road system to Yankee Hill/St. Mary's Area.

**Total Project Cost:** \$12,995;

**Grant Award:** \$9,000

**Type of work to be done:** Four portable toilets (including one Accessible toilet) will be installed along with a bear proof dumpster in the area until the district can provide a more developed permanent facility. A fence will be built around the facilities to help protect surrounding natural resources.

**Partners:** Local clubs and organizations associated with the adoption of Columbine trail systems.



## #17 OHV 2024 RRMCM TRAIL MAINTENANCE

### ■ Rampart Range Motorized Management Committee (RRMMC)

**Project Area and Trail System:** Chaffee, Custer, Douglas, El Paso, Huerfano, Teller, Park Counties; Pike & San Isabel National Forests; Rampart Range, West Creek, Rainbow Falls, Wet Mountains, Rainbow Trail, and Four Mile trail systems.

**Total Project Cost:** \$312,169;

**Grant Award:** \$263,319

**Type of work to be done:** Heavy trail maintenance dozer work.

**Partners:** USFS; Volunteers.

## #36 WHITE RIVER OHV TRAIL CREW 2024

### ■ BLM–White River Field Office (WRFO)

**Project Area and Trail System:** Rio Blanco, Moffat, Garfield Counties; the BLM-WRFO Travel and Transportation Management Resource Management Plan Amendment (TM RMPA) TMA1 areas, the Rangely Rock Crawling Park, North Dinosaur, and the 2 motorized Open Areas, LO7 and North Rangely; Wagon Wheel West (WW) OHV Trail System.

**Total Project Cost:** \$405,055;

**Grant Award:** \$163,625

**Type of work to be done:** Trail maintenance and reconstruction tasks; signage and kiosk installation; visitor contacts. Project materials, a UTV, trailer, TRAFx



counters and hand held radios will be purchased.

**Partners:** Volunteers.

## #27 BIG BEND OHV BEGINNER TRACK 2024

### ■ Central Colorado Mountain Riders (CCMR)

#### **Project Area and Trail System:**

Chaffee County; BLM–Royal Gorge Field Office; CPW–Arkansas Headwaters Recreation Area (AHRA).

**Total Project Cost:** \$80,320;

**Grant Award:** \$74,320

**Type of work to be done:** Improve and maintain the track and improve facilities around the kid/beginner track. Tasks will include: installing a covered picnic pavilion, picnic tables, bench, grills, and handicap accessible parking. An enclosed trailer for equipment storage will be purchased.

**Partners:** CPW–Arkansas Headwaters Recreation Area (AHRA); Salida Parks and Recreation; Volunteers.

## #01 OHV DOZER 24 PROJECT

### ■ USFS–Dolores Ranger District

#### **Project Area and Trail System:**

Montezuma, Dolores, La Plata, Archuleta, Mineral Counties; San Juan National Forest; Dolores and Pagosa Ranger Districts; Trails include: Dolores District - Morrison, BC Rim, Chicken Creek, Aspen Loop and Mancos area trail network; Rico West Dolores OHV trails - routes authorized in the Willow Divide, Ground Hog and

Black Mesa zones of the district and the Rico area of the district including 62” OHV trails; Pagosa District–District Wide Network–routes in the Blue Creek, Mosca, Monument, Porcupine, and Mill Creek Road areas.

**Total Project Cost:** \$73,157;

**Grant Award:** \$48,157

**Type of work to be done:** Heavy trail maintenance dozer work will be done on both the Dolores and Pagosa Ranger Districts’ popular OHV trails. The dozer program will also be available to the Columbine Ranger District.

**Partners:** USFS–Pagosa Ranger District; San Juan Trail Riders; Pagosa Trail Riders.

## #16 OHV DIVIDE HEAVY MAINTENANCE CREW

### ■ USFS–Divide Ranger District

#### **Project Area and Trail System:**

Rio Grande County; Rio Grande National Forest. Work will take place on OHV system trails located on the southern end of the district. Trails include: Dry Creek, Cross Creek, Bennett, and Burro.

**Total Project Cost:** \$100,850;

**Grant Award:** \$67,060

**Type of work to be done:** Heavy trail maintenance dozer work using a mini excavator. The crew will construct a 1.4 mile reroute on the Dry Creek Trail #700, a .3 mile reroute on the Bennett Trail #872, and will maintain the Burro Trail #873 and Cross Creek Trail #812.

**Partners:** Volunteers.

## #39 OHV SUBCONTRACTOR TRAIL MAINTENANCE

### ■ Western Slope ATV Association (WSATVA)

#### Project Area and Trail

**System:** Mesa, Delta, Montrose, Gunnison Counties; Grand Mesa, Uncompahgre & Gunnison National Forests; Trails may include Monument Trail (#518), and High Trail (#515).

**Total Project Cost:** \$295,000;

**Grant Award:** \$295,000

**Type of work to be done:** Heavy trail maintenance dozer work.

**Partners:** BLM; Volunteers.

## #04 OHV TRAIL DOZER MAINTENANCE PROGRAM

### ■ USFS–Ouray Ranger District

#### Project Area and Trail System:

Montrose, Ouray, Delta, Gunnison, Hinsdale, Counties; the Grand Valley area; Uncompahgre Plateau and the Grand Mesa, Uncompahgre, and Gunnison (GMUG) National Forests; BLM Uncompahgre Field Office lands. Specific trails determined in annual dozer meeting.

**Total Project Cost:** \$309,187;

**Grant Award:** \$196,996

**Type of work to be done:** Heavy trail maintenance, reconstruction, and major dozer work projects.

A replacement UTV will be purchased.

**Partners:** BLM–Uncompahgre Field Office OHV Trail Crew; USFS–Grand Valley, Paonia, and Norwood Ranger Districts;

Thunder Mountain Wheelers; Uncompahgre Valley Trail Riders; WESTCORE; Volunteers.



## #32 CCMR TRAIL MAINTENANCE 2024

### ■ Central Colorado Mountain Riders (CCMR)

#### Project Area and Trail System:

Chaffee, Fremont, Gunnison, Saguache Counties; USFS - Salida Ranger District (SRD) and the BLM - Royal Gorge Field Office (RGFO); Adopted trails: Monarch Ridge Trail, portions of the Rainbow Trail, Poplar Gulch/Green Timber Trail and Bridge, Greens Creek, DudBob Trail, Sundgren Sunset Loop and the Colorado Trail Section 16.2.

**Total Project Cost:** \$319,131;

**Grant Award:** \$307,971

**Type of work to be done:** Ongoing trail clearing and maintenance on adopted singletrack trails, and other motorized multiuse singletrack trails in the area. Work will be done by hand and utilizing heavy equipment. Tools and equipment will be purchased, including a Canycom powered walk-behind

carrier, DeWalt rock drill, bits and chipping hammers, and a generator.

**Partners:** USFS; BLM; Volunteers.

### #31 OHV STT EDUCATION & STEWARDSHIP ALLIANCE

#### ■ Stay The Trail (STT) Education & Stewardship Alliance

**Project Area and Trail System:**

Statewide

**Total Project Cost:** \$285,142;

**Grant Award:** \$227,774

**Type of work to be done:**

Promotion of responsible OHV recreation and land stewardship, utilizing educational trailers and other outreach tools, such as maps, brochures and videos, at events around the state and through media techniques such as the Stay The Trail website, social media sites, multimedia marketing and advertising.

**Partners:** USFS; BLM; CPW; Yamaha Grant; local stewardship sponsors; Clubs, Organizations, Event & Private Donations; Volunteers.

### #24 OHV GVRD HEAVY EQUIPMENT CREW

#### ■ USFS–Grand Valley Ranger District (GVRD)

**Project Area and Trail System:**

Mesa and Delta Counties; Grand Mesa & Uncompahgre National Forests; Trails include: Silver Spruce #517, High Trail #515, Little Johnson #617, Cedar Mesa #718, and Triangle Stomp #736.

**Total Project Cost:** \$294,300;

**Grant Award:** \$265,000

**Type of work to be done:** Two trail dozer crews will conduct heavy trail maintenance dozer work, one doing basic maintenance on both the Uncompahgre and Grand Mesa National Forests, and the other crew will focus on routes requiring more intensive maintenance and/or reconstructive work.

**Partners:** USFS–Paonia, Delta, and Ouray Ranger Districts; Western Slope ATV Association (WSATVA); Thunder Mountain Wheelers (TMW); BLM–Grand Junction Field Office.

### #29 HILL CLIMB REHAB & OHV TRAIL IMPROVEMENT

#### ■ USFS–Pikes Peak Ranger District (PPRD)

**Project Area and Trail System:**

Teller, Douglas, El Paso, Park Counties; Pike National Forest; Trails and areas include: single track trail 667 located in the Captain Jacks area; OHV routes 717, 717A, 717F located outside of Woodland Park and Divide; hill climb routes 351, 350A, and 356D in Douglas and Teller counties; Rainbow Falls Trailhead.

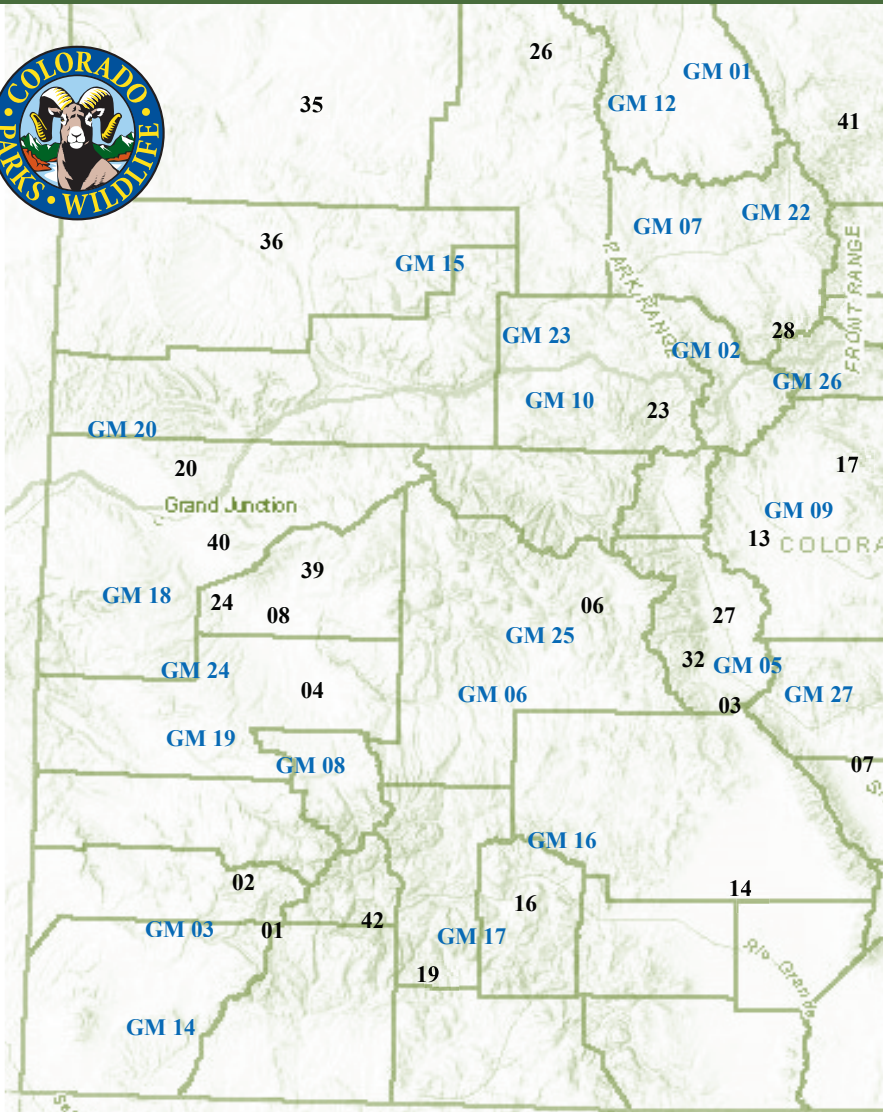

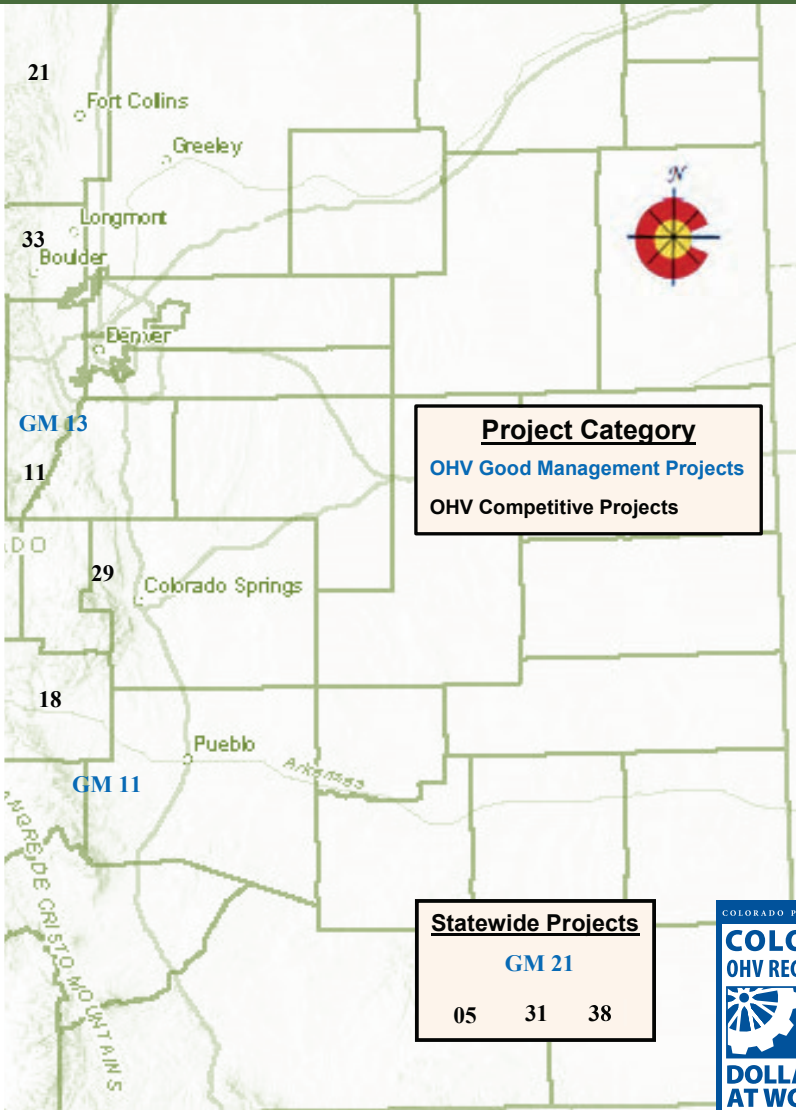

## #20 OHV GJFO EQUIPMENT OPERATOR

### ■ BLM–Grand Junction Field Office (GJFO)

#### **Project Area and Trail System:**

Mesa, Montrose, Garfield, Delta Counties; Grand Junction Field Office and McInnis Canyon & Dominguez-Escalante National Conservation Areas; Trails include: Grand Valley Open Area, North Desert, parts of Bangs Canyon, Gateway, Barrel Springs, Horse Mountain, Rabbit Valley, Cactus Park, Hunting Grounds, and Sawmill Mesa-Wagon Park.

**Total Project Cost:** \$70,000;

**Grant Award:** \$45,000

#### **Type of work to be done:**

Heavy trail maintenance dozer work will be done on existing routes and new trails will be built in accordance with the area's travel management plan.

**Partners:** USFS; Western Slope ATV Association (WSATVA); Motorcycle Trail Riders Association (MTRA); Timberline Trail Riders.

## #03 OHV UAMTC EQUIPMENT

### ■ CPW–Arkansas Headwaters Recreation Area (AHRA)

#### **Project Area and Trail System:**

Chaffee, Fremont, Lake, Park, Saguache Counties; Pike & San Isabel National Forests; system routes throughout the district.

**Total Project Cost:** \$33,000;

**Grant Award:** \$26,000

**Type of work to be done:** To support trail crew activities, a motorcycle and a UTV with a dump/utility bed will be purchased to help transport the crew and materials to the work site on 50” and larger OHV trails. Equipment outfitting accessories and guards will also be purchased.

**Partners:** USFS–Salida Ranger District; BLM–Royal Gorge Field Office; neighboring USFS districts include Gunnison, Saguache, Leadville, and San Carlos.

## #26 HPBE OHV TRAIL CREW

### ■ USFS–Hahns Peak/Bears Ears (HPBE) Ranger District

#### **Project Area and Trail System:**

Routt, Moffat Counties; Medicine Bow/Routt National Forests, including areas of the Yampa and Parks Districts of the Routt National Forest. Areas of focus include: North Routt, from Seedhouse Road (FS400) to the

Wyoming state line and from the Continental to California Park County Road 80. Other areas include: the Bears Ears, Buffalo Pass, and Rabbit Ears. Trails include: Ellis Trail, Farwell Connector, FS 305 Gate, West Nipple Peak Trail, Continental Divide Trail (CDT)/WY from Diamond to Hare, Whiskey West, Independence, and Ellis Jeep Trail. The crew will also work on the Morrison Divide Trail on the Yampa Ranger District.

**Total Project Cost:** \$122,000;

**Grant Award:** \$105,000

**Type of work to be done:**

Annual trail maintenance and reconstruction tasks; signage; visitor contacts. Work will include improving and replacing aging trail infrastructure (bridges, turnpikes, width restrictors).

**Partners:** USFS–Yampa & Parks Ranger Districts; Timberline Trail Riders/Mountain Trails Axxess (MTA); Yampa Valley Trail Riders; Volunteers.

## #38 BLM STATEWIDE OHV LAW ENFORCEMENT

### ■ BLM–Colorado State Office

**Project Area and Trail System:**

Statewide; Areas of focus for BLM law enforcement details and patrols include, but are not limited to, the following: Kremmling Field Office (Grand, Jackson Counties–North Sand Hills Special Recreation Management Area (SRMA) (Memorial Day), North Sand Hills (Independence Day, Labor Day); Gunnison Field Office (San Juan, Hinsdale Counties)–Alpine Triangle Recreation Area (“Alpine Loop”) (July–September); Colorado River Valley Field Office (Garfield, Eagle Counties)–Hubbard Mesa, Roan Plateau, Hardscrabble, Bocco Mountain (TBD); Grand Junction Field Office (Mesa County)–West Desert, Bangs Canyon, Cactus Park (TBD); Uncompahgre Field Office (Delta, Montrose, Ouray Counties)–Peach Valley OHV area; San Luis Valley Field Office (Saguache County)–Poncha Pass, Elephant Rocks (TBD); Additional areas of high OHV use will be covered as they are identified and time and resources allow.

**Total Project Cost:** \$162,296;

**Grant Award:** \$65,170

**Type of work to be done:**

Law enforcement patrol activities including visitor contacts, public education, monitoring, public safety, and enforcement of OHV regulations and registration requirements.

## #06 CANYON CREEK TRAIL RECONSTRUCTION

### ■ USFS–Gunnison Ranger District

#### **Project Area and Trail System:**

Gunnison County; Grand Mesa, Uncompahgre & Gunnison National Forests; Canyon Creek Trail #481. 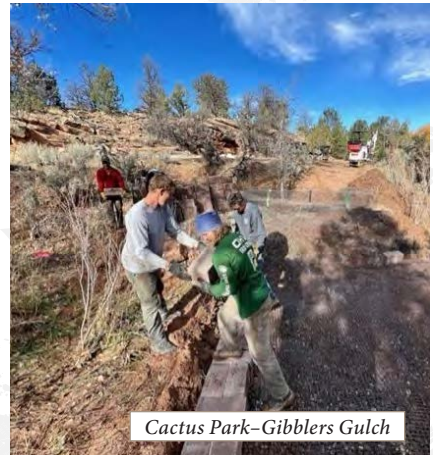

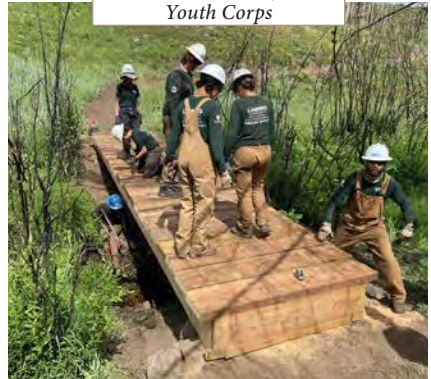

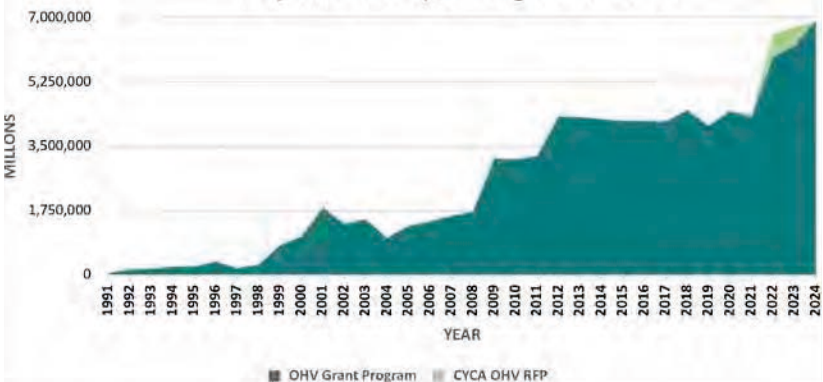
