EXHIBIT E ARKANSAS HEADWATERS RECREATION AREA SPECIAL ACTIVITY PERMIT WALK & WADE FISHING

PURPOSE OF EXHIBIT: To authorize **Company Legal** operating as **Company dba** to conduct the following activities for **2024** within the AHRA:

• Commercially guided walk and wade fishing trips, WITHOUT THE USE OF WATERCRAFT

as detailed in the AHRA Operating and Safety Plan, within the Permit term, launch windows where applicable, capacities on the Arkansas River and pursuant to the provisions of the Arkansas Headwaters Recreation Area Management Plan (AHRA-MP) and the following Conditions:

CONDITIONS:

1. AHRA Special Activity Permit Application

Any person or business entity conducting any of the activities authorized above shall meet the following requirement(s):

- a. Submit a copy of a current Colorado Outfitters Registration issued by the Office of Outfitter Registration. Required for any Permittee involved in the taking of fish on public lands or waters within the State of Colorado. Violation of the terms of the Colorado Outfitters Registration may be cause for Permit probation, suspension or revocation.
 - 1) All guides must have current first aid and CPR certification cards with a hands-on practical.
- b. Submit a copy of a current Colorado Parks and Wildlife (CPW) Temporary Wildlife Special Use Permit issued by the appropriate Area Wildlife Manager. This is required for any Permittee utilizing State Wildlife Areas within the AHRA for commercial operations. Violation of the terms of the CPW Temporary Wildlife Special Use Permit may be cause for Permit probation, suspension or revocation.
- c. Permittees may conduct commercial walk wade activities on property owned or managed by CPW and, pursuant to a separate agreement with a private landowner, conduct such activities on private property. If a Permittee conducts such activities exclusively on private property, the Permittee need not report any associated revenue to CPW. However, where a Permittee guides the same client on property owned or managed by CPW and private lands on the same day, the Permittee must report total gross receipts to CPW with a half-day proration only. The Permittee cannot allocate revenue earned on CPW land less than 50% per day and submit such amount from total gross receipts reported to CPW. The 5% use fee provided for in this Special Activity Permit is payable to CPW if the Permittee guides such a client on property owned or managed by CPW.
- 2. Guide ID Cards
 - a. The State will issue AHRA Guide ID Cards to each Permittee based on the number of guides listed in the application package. Each Guide ID Card will have the company name, ID Card number and expiration date displayed.
 - b. AHRA Guide ID Cards may only be used by the Permittee or any agent or employee of the Permittee while conducting commercial operations within the AHRA. It is the responsibility of the Permittee to ensure that all AHRA Guide ID Cards are used only for authorized activities.

- c. AHRA Guide Cards must be carried at all times by the Permittee, any agent, or employee of the Permittee while conducting commercial operations within the AHRA. It is the responsibility of the Permittee, if the employee should for whatever reason leave the employment prior to the expiration date on the card, to retake possession of the card. The Permittee must then provide the State with an updated Guided List by uploading this information to the ahraoutfitters.org site.
- 3. No Use / Declaration of Non-Use
 - a. No Use shall be defined as a Permittee with a Walk and Wade Fishing Permit who guides zero (0) commercial paying clients during the term of the Permit.
 - b. Declaration of Non-Use
 - A Declaration of Non-Use must be submitted in writing and received by March 1st. A Permittee may petition the AHRA Park Manager for discretionary approval for a Declaration of Non-Use in the event of an unforeseen emergency after the March 1st deadline.
 - All Walk and Wade Fishing Permittees requesting a declaration of non-use must pay the \$250.00 Application Fee by April 1st.
 - 3) The AHRA Park Manager will decide within 10 business days whether to grant or deny the Declaration of Non-Use and will notify the Permittee of his decision by March 15th.
 - 4) A Permittee's Permit will be revoked if that Permittee operates commercially within the AHRA after declaring a season of non-use.
 - c. A Permittee may have either one (1) No Use Season or a Declaration of Non-Use Season once every five (5) years.
 - d. Any combination of No Use or a Declaration of Non-Use twice in a five-year period will result in Permit revocation.
 - e. A Permittee who has previously had either a No Use season or a Declaration of Non-Use in a fiveyear period may petition the AHRA Park Manager for discretionary approval for a second Declaration of Non-Use in the event of an unforeseen emergency.
